THE CAREER LADDER PROGRAM ANNUAL REPORT 2006-2007 SCHOOL YEAR

The Missouri Career Development and Teacher Excellence Plan was established by the Excellence in Education Act of 1985. In 1986-87, 63 districts representing 2,400 teachers participated in the program. During the 2006-2007 school year, 338 districts representing 17,710 teachers participated in the program. The cost to the state was \$36,881,883. It is anticipated 342 districts will participate in the program for the 2007-2008 school year. Nine districts have chosen to participate on a limited basis to reward National Board Certified teachers. A statistical history of the Career Ladder Program can be found in Attachment A. A map showing statewide distribution of participating districts is found in Attachment B.

Information for this report was provided to the Department on the Assessment of Career Ladder Plan and Activities form (Attachment C). This form is used to assess district activities and monitor progress toward Career Ladder goals. Appendix A contains the specific data supplied by each district.

Educators participating on Stage I of the Career Ladder are required to spend a minimum of 60 hours outside of contracted time in appropriate activities; Stage II participants must spend 90 hours; and Stage III participants must spend 120 hours. The average number of hours spent by Stage I participants was 79, Stage II - 109, Stage III - 144. The educators exceeded the requirements of time by 379,042 hours (an average of 22 hours per participant). Career Ladder teachers spent 1,303,394 hours in instructional improvement activities including student tutoring and student/parent contact activities.

Career Ladder teachers provide students opportunities for enhanced learning experiences, remedial assistance and various extended day/year activities. These teachers also participated in professional growth activities including college classes, workshops, professional organizations and mentoring. Curricula were updated in many districts. Career Ladder educators performed in excess of 2 million hours of responsibilities in addition to their teaching responsibilities.
