Please accept this letter and the supporting documents attached as my application for appointment as Trustee for Area 6. As a life-long resident of the Elk Grove Unified School District, graduate of EGUSD schools, an educator and former teacher for the district, EGUSD coach, and parent of EGUSD students, I am excited for the opportunity to serve my community in this important role.

After graduating from Elk Grove High School, I earned a Bachelor of Arts in History and Political Science from Cedarville College (Cedarville, Ohio). I earned a certificate in American Studies from the American Studies Program in Washington, D.C. In 2001, I earned a Juris Doctor from the Martin Luther King, Jr. School of Law at the University of California, Davis, graduating with honors (Order of Barristers) and recognition (*Pro Bono* Legal Services Certificate). I have been a member of the California State Bar since 2001. I currently hold a valid California substitute teaching credential.

My wife, Sonia, is credentialed in Spanish and music and currently teaches at the School of Engineering in Sciences in the Sacramento City Unified School District, where she also serves as Teacher Lead/Acting Vice Principal. We have three sons: Joshua, age 9, Alexander, age 5, and Matthew, age 2. Joshua currently attends Ellen Feickert and previously attended Arlene Hein. He and Alex will attend Franklin Elementary School in the fall.

An Understanding of the Elk Grove Unified School District

I have a long history with the Elk Grove Unified School District. I graduated from Joseph Kerr in 1991 and Elk Grove High School in 1995. My mother worked for the district for many years, at the district office in Human Resources and Staff Development and at Florin High School. I have lived within the boundaries of the district since I was four years old, with brief exceptions when my father worked in Butte County and when I attended college.

I attended Elk Grove schools during a difficult period of growth and campus overcrowding. I attended Joseph Kerr with approximately 2,000 students. One-third of my classmates would attend Florin High School after graduation. In 8th grade, our campus was home to portables housing Samuel Jackman students. Mine was the first class to attend Kerr on a year-round schedule. At Elk Grove High School I experienced similar crowding.

I watched the district grow to meet the challenge. Florin High School was brand new when I began seventh grade; my senior year we cheered our JV teams against the new Laguna Creek and bid farewell to Principal Paula Duncan as she left to oversee development of Sheldon High School. I remember taking my first AP test in the new district office built behind Kerr on my old baseball practice field. I appreciated the support of community during those times.

As a student, I was very involved in school. I served on the student council and worked in the student store in middle school, earning the campus pride award at graduation.

I played football for four seasons. I learned the value of community in football; thousands came to our road games and people were always willing to buy a raffle ticket, a hat, or a program ad to support the team. Coach Lombardi required that we volunteer at Home Field Advantage events; I remember the pride we felt the night Home Field Advantage turned on our new stadium lights. We had great men serving as great coaches, and even better mentors: Ed Lombardi, Herbie Berry, Chris Nixon, and John Zehnder to name a few.

I competed in speech and debate, becoming the first EGHS student to advance through each stage of the California Speech and Debate Championships and receive a finalist medal. I served in student government, was the voice of the daily "Herd Word", and announced every home game for the 1995 Sac-Joaquin Section Champion basketball team. I lost my voice every December calling all 12 games of the Cartwright Classic Basketball Tournament. I was privileged to witness a number of historic events in school history. In 1992 we celebrated our school's 100th anniversary. I attended the ceremony naming the gymnasium after Bill Cartwright. I remember the construction of a new gymnasium and temporary classrooms (many of which are still in use 20 years later).

Two experiences stand-out as life changing in high school. The first occurred early in my junior year. The year before some of my classmates won a lawsuit mandating that the school allow them to paint a mural of a burning flag on school property. EGUSD responded to the court's direction by proposing a ban on all student murals. I mostly stayed quiet as students held walk-outs and protest rallies in response to the proposed ban. I was troubled by comments I read from a World War II veteran about the mural, how much it saddened him and how much the flag meant to him. I was the lone vote on the student council in support of the district policy. I was terrified as I turned in my speaker card at the packed school board meeting on the issue. I was so impressed by the meeting and by the thoughtful comments from the board. It was my first time speaking to a government body and it confirmed my interest in a career in public service.

The second event followed shortly after my comments that night. David Hill was the advisor to the student group responsible for the mural and my AP U.S. History teacher. He was impressed by my performance at the meeting and even more impressed by my guts opposing the majority of the student body. He asked me to tryout for the mock trial team he coached. I earned a starting role-and All-State Attorney honors my senior season. More importantly, I developed a passion for the law that launched my career.

I began serving as a team coach my first year of college, something that continues today. Over the past seventeen years our program has grown from a good regional team to an internationally recognized program. I am very proud of our successes, but more proud of our students and their growth through the program. We estimate that nearly half of our student attorneys have gone on to practice law, graduating from America's elite law schools. All of our graduates have gone on to great accomplishments, with tremendous confidence in their ability to speak and write and effectively advocate their views in any forum.

In addition to coaching, I have remained involved in Elk Grove schools in other ways. I have coached other sports and activities at Elk Grove High School, served as a guest speaker on a multitude of subjects, and volunteered for the district's First Amendment writing competition. I have worked with new coaches to help grow mock trial programs throughout the district and county.

A Diverse Background in Education

I have a very diverse educational history that gives me a unique perspective on education. Growing up, I was homeschooled and later attended private and public schools. I also attended public and private universities. I have an understanding of, and an appreciation, for the strengths, weaknesses, and differences in these varied approaches to education. I watched my parents weigh the difficult decision of how best to educate my sister and me. I appreciate the struggle that many parents face to determine what is best for their children.

I am a teacher. In addition to teaching legal principles and trial advocacy in mock trial, I have also worked in EGUSD classrooms as a substitute teacher. I am an adjunct law professor at U.C. Davis, where I teach trial advocacy. I was a member of the criminal justice faculty at the University of Phoenix, where I taught a range of courses for working professionals and traditional college students. During my time in Afghanistan, I supervised a training program for justice sector officials. My work included curriculum development, classroom instruction, and student assessment. I placed special emphasis on staff development, improving the teaching skills of my employees and trainers within the various Afghan ministries we supported. I value well-prepared teachers, quality curriculum, and effective staff development as a means to helping students succeed.

My wife is teacher. She has been laid off in the past, and expects to be laid off this year. I see the challenges that she faces each day as she works to help her students succeed. I know how important her job is to our family. Many of our closest friends, and many of my childhood mentors, are teachers for EGUSD. I value the dedication, sacrifice, and commitment of our teachers and support staff.

Legal Experience in Educational Matters

During my career as a prosecutor and administrative law judge, I have developed expertise and experience in matters related to education. Early in my career, I managed a major civil suit against a local school district over unsafe busing practices. I negotiated directly with the Board of Education, Superintendent, and school counsel to develop a plan to bring school district into compliance with the Vehicle and Education Codes. I worked with local probation and school attendance review boards (SARB) to hold parents accountable for the education of their children. I oversaw a special investigation and prosecution program targeting adults who preyed upon school-age children for sex. I prosecuted school employees for abusing children in their care. I regularly preside over employment law cases involving teachers and school employers and have developed expertise in the area of school employee unemployment benefits. The Board will benefit from legal experience and training.

I am a proud alumnus of the Elk Grove Unified School District (EGUSD), grades K to 12, and now an associate of the English law firm Allen & Overy, LLP. Jake was the coach that brought that that Saturday-feeling to the team six days a week. Jake was the coach who came in after work, often five days a week, two to four hours a day. He brought and enthusiasm and a passion to the team that truly inspired students to strive for more.

Jake would always ask, "Right, this is good. How can we make it better?" It's not always the question you want to hear, but it's often the question you need to hear. Thanks to Jake's leadership and vision, he helped organise trips to the court house to practice, to watch other trials, meet judges and even took us on a tour of the courthouse he worked. Jake also knows the Elk Grove community inside and out. He is an alumnus of Kerr and EGHS, has coached and volunteered with the school every year since his graduation and has worked as a substitute teacher within the school. I am a partner in the Sacramento law firm of Downey Brand LLP, father of Elk Grove High School alumnus Bradley Carroll and current EGHS junior Leah Carroll, and an EGHS mock trial program volunteer attorney coach. I write this letter to recommend, without hesitation or hint of reservation, the appointment of Jake Rambo to the EGUSD Board of Trustees.

I first met Jake in fall 2003, when Bradley had the good fortune of being selected to compete with EGHS' storied mock trial team. Seeing the opportunity to help in an area where I had some experience, I volunteered to help coach the team on Saturday mornings. Thus began one of the most rewarding volunteer experiences I have ever had, one that has lasted for nine years and has been significantly enhanced by Jake's participation in the program.

Jake is a product of the Elk Grove school system, having graduated from Joseph Kerr Middle School and Elk Grove High School. While at EGHS Jake played football and also competed with the mock trial team for two years, earning All State Outstanding Attorney in 1995. He began helping coach the team even before attending law school at U.C. Davis and in the 17 years he has volunteered to coach the team, the team has been Sacramento County Champion six times. At the State Competition during those 17 years, the team has finished with one honorable mention, taken fifth place once, second place twice, and won the state championship once, in 2007. In 2007, the team finished eleventh in its first national competition. It has also competed on the national level in 2009, 2010, and 2011 at the Empire World Championship and the American Mock Trial Invitational, placing fifth in 2010 at Empire and sixth in 2009 at American.

Jake would be the first to tell you that mock trial is a team competition and to give credit to the students and his fellow coaches. However, the team's achievements during Jake's time as a coach are in many ways attributable to his talents and skills. Specifically:
