

Responsible for instigating AB 1626 to enact the statewide-California SAVE Program designed to address school safety in the areas of zero tolerance, violence, and weapons on school campuses. Provided support to countywide school administrators and peace officers on the alternatives of juvenile adjudication. Appointed to organize and establish a Countywide Hmong Refugee Education Collaborative. Staffed self-sustaining fundraising efforts for various youth development programs, i.e. Annual Golf Tournament and Fund Development. (1997- 2005)
