EXPLANATION

- 1) Barack Obama's mother, Ann Soetoro, declares in this form that she is leaving the U.S. indefinitely, since she is married to an Indonesian National.
- 2) Her one child is listed on page 2 of the form Barack Hussein Obama (Soebarkah)
- 3) As shown on the annotations to the form and *in accordance with the form instructions*, Barack Obama's mother was required to strike out Obama's name *as a foreign national*. Barack Obama's name is dutifully struck out.

Therefore, this form is **an official declaration** to the State Department by Barack Hussein Obama's mother that **Barack Hussein Obama is not a U.S. citizen.**

FUTHER NOTE

The instructions to this form further require a supplementary explanatory affidavit (sworn statement) to be attached regarding the non-citizenship status of persons mentioned. This is to be made part of the application. However, this page of the document is evidently being withheld by the State Department, in violation of a court order demanding its release. (see Strunk v Department of State case.)
