# Idempotent Generated Endomorphisms of an Independence Algebra

#### Abstract

The aim of this note is to give a direct proof for the following result proved by Fountain and Lewin: Let $\mathcal{A}$ be an independence algebra of finite rank and let $a$ be a singular endomorphism of $\mathcal{A}$. Then $a=e_{1} \ldots e_{n}$ where $e_{i}^{2}=e_{i}$ and $\operatorname{rank}(a)=$ $\operatorname{rank}\left(e_{i}\right)$.

We assume the reader to have a basic knowledge of independence algebras. As reference we suggest [3]. Throughout this note $\mathcal{A}$ will be an independence algebra of finite $\operatorname{rank}(\operatorname{rank}(\mathcal{A}) \geq 2)$ and with universe $A$. By $\operatorname{End}(\mathcal{A})$ and $\operatorname{PEnd}(\mathcal{A})$ we will denote, respectively, the monoid of endomorphisms and of partial endomorphisms of $\mathcal{A}$, and $\operatorname{Aut}(\mathcal{A})$ will be the automorphism group of $\mathcal{A}$. Moreover, $\operatorname{End}(\mathcal{A}) \backslash \operatorname{Aut}(\mathcal{A})$ is the monoid of singular endomorphisms and will be denoted by $\operatorname{Sing}(\mathcal{A})$. For $a \in \operatorname{PEnd}(\mathcal{A})$ and $X \subseteq A$, denote by $\Delta(a), \nabla(a)$, respectively, the domain and the image of $a$, and denote by $a \mid X$ the restriction of $a$ to $X$. The following proof is inspired by [1] and goes as follows:
(1) for every $a \in \operatorname{Sing}(\mathcal{A})$ there exists an idempotent $e \in \operatorname{End}(\mathcal{A})$ and a partial monomorphism $a^{\prime}$ such that $a=e a^{\prime}$ (with $\nabla(e)=\langle E\rangle=\Delta a^{\prime}$ and $\nabla\left(a^{\prime}\right)=\langle E a\rangle$, for some independent set $E$ );
(2) there exist idempotents $e_{1}, \ldots, e_{n} \in \operatorname{PEnd}(\mathcal{A})$ such that $\operatorname{rank}\left(e_{i}\right)=\operatorname{rank}(a)$ and $(E) e_{1} \ldots e_{n}=E a ;$
(3) for every $f \in \operatorname{Sym}(E a)$ (the symmetric group on $E a$ ), there exist idempotents $f_{1}, \ldots, f_{m} \in \operatorname{PEnd}(\mathcal{A})$ such that $\operatorname{rank}\left(f_{i}\right)=\operatorname{rank}(a)$ and $f=\left(f_{1} \ldots f_{m}\right) \mid \operatorname{Ea}$;
(4) finally, using (2), $a^{\prime} \mid E: E \rightarrow E a$ can be factorized as $a^{\prime}\left|E=\left(e_{1} \ldots e_{n} f\right)\right| E$, with $f \in \operatorname{Sym}(E a)$, and hence, by (3), we have $a^{\prime}\left|E=\left(e_{1} \ldots e_{n} f_{1} \ldots f_{m}\right)\right| E$, so that $a=e a=e a^{\prime}=e e_{1} \ldots e_{n} f_{1} \ldots f_{m}$.

We start by proving (1). Let $a \in \operatorname{Sing}(\mathcal{A})$. Since $\operatorname{End}(\mathcal{A})$ is regular there exists an idempotent $e \in \operatorname{End}(\mathcal{A})$ such that $e a=a$ (and $\operatorname{rank}(e)=\operatorname{rank}(a)$ ). Moreover, if $E$ is a basis for $\nabla(e)$, we have

$$
|E a| \leq|E|=\operatorname{rank}(e)=\operatorname{rank}(a)=\operatorname{rank}(e a)=\operatorname{rank}(\langle E\rangle a)=\operatorname{rank}(\langle E a\rangle) \leq|E a| .
$$

Therefore $\operatorname{rank}(\langle E a\rangle)=|E a|$ and hence $E a$ is independent. Since $|E|=|E a|$ and $E a$ is independent, then $a \mid E$ is $1-1$ and $a \mid\langle E\rangle$ is a monomorphism. It is proved that $a=e(a \mid\langle E\rangle)$ and (1) of the scheme above follows.

For the remains of this note $a, e, E$ and $E a$ are the objects introduced above and are fixed. We now prove (2). Let $l=\operatorname{rank}(a)$ and let $K_{l}=\{B \subseteq A| | B \mid=l$ and $B$ is independent $\}$. Consider in $K_{l}$ the following relation: $\left(B_{1}, B_{2}\right) \in \rho$ if and only if $\left|B_{1} \backslash B_{2}\right| \leq 1$.

Lemma 1 For some natural number $n \geq 0$ we have $(E, E a) \in \rho^{n}$.
Proof: Let $\uparrow E=\left\{C \in K_{l} \mid(E, C) \in \rho^{m}\right.$, for some natural $\left.m\right\}$. Now let $C \in \uparrow E$ such that for all $D \in \uparrow E$ we have $|C \cap E a| \geq|D \cap E a|$. We claim that $C=E a$. In fact, if by contradiction $C \neq E a$, then there exists $d \in C \backslash E a($ as $|C|=|E a|)$. Therefore, for some $c \in E a$, we have $c \notin\langle C \backslash\{d\}\rangle$ (since we cannot have $E a \subseteq\langle C \backslash\{d\}\rangle$ as $\operatorname{rank}(\langle C \backslash\{d\}\rangle)<\operatorname{rank}(\langle E a\rangle)$ ). Thus $C_{0}=(C \backslash\{d\}) \cup\{c\} \in K_{l}$ and $\left(C, C_{0}\right) \in \rho$. Since $(E, C) \in \rho^{k}$ and $\left(C, C_{0}\right) \in \rho$ it follows that $\left(E, C_{0}\right) \in \rho^{k+1}$ so that $C_{0} \in \uparrow E$ and $\left|C_{0} \cap E a\right|>|C \cap E a|$, a contradiction. It is proved that $C=E a$ and hence $E a \in \uparrow E$.

We observe that the key fact used in the proof of this lemma is a well known property of matroids (see [4], Exercise 1., p.15).

Now let $E=E_{1} \rho E_{2} \rho \ldots \rho E_{n-1} \rho E_{n}=E a$. We claim that, for every $i=1, \ldots, n-1$, there exist two idempotents $e_{i, 1}, e_{i, 2} \in \operatorname{PEnd}(\mathcal{A})$ such that $\left(E_{i}\right) e_{i, 1} e_{i, 2}=E_{i+1}$. In fact let $D=E_{i} \cap E_{i+1}$ so that $E_{i}=D \cup\{x\}$ and $E_{i+1}=D \cup\{y\}$. Then either $y \notin\langle D \cup\{x\}\rangle$ or $y \in\langle D \cup\{x\}\rangle$.

In the first case, $D^{\prime}=D \cup\{x, y\}$ is independent. Thus we can define a mapping $f: D^{\prime} \rightarrow D \cup\{y\}$ by $x f=y f=y$ and $d f=d$, for all $d \in D$. This mapping $f$ induces a partial idempotent endomorphism $e_{i, 1}:\left\langle D^{\prime}\right\rangle \rightarrow\langle D \cup\{y\}\rangle$ such that $\left(E_{i}\right) e_{i, 1}=$ $(D \cup\{x\}) e_{i, 1}=D \cup\{y\}=E_{i+1}$. (Let $\left.e_{i, 2}=e_{i, 1}\right)$.

In the second case, $\operatorname{rank}(\langle D \cup\{x, y\}\rangle)=\operatorname{rank}(\langle D \cup\{x\}\rangle)<\operatorname{rank}(\mathcal{A})$ and hence there exists $z \notin\langle D \cup\{x, y\}\rangle$. Therefore $D \cup\{x, z\}$ and $D \cup\{y, z\}$ are independent sets and hence there exist two idempotents $e_{i, 1}, e_{i, 2} \in \operatorname{PEnd}(\mathcal{A})$ such that $e_{i, 1}\left|D=i d_{D}=e_{i, 2}\right| D, x e_{i, 1}=$ $z e_{i, 1}=z$ and $z e_{i, 2}=y e_{i, 2}=y$. It is obvious that $(D \cup\{x\}) e_{i, 1} e_{i, 2}=D \cup\{y\}$ and hence $\left(E_{i}\right) e_{i, 1} e_{i, 2}=E_{i+1}$. We have constructed idempotents $e_{1,1}, e_{1,2}, \ldots, e_{n, 1}, e_{n, 2} \in \operatorname{PEnd}(\mathcal{A})$ such that $(E) e_{1,1} e_{1,2} \ldots e_{n-1,1} e_{n-1,2}=E a$ and hence (2) is proved.
Observation 2 Observe that in both cases considered above, and for all $i=1, \ldots, n-1$, we have $\nabla\left(e_{i, 1}\right) \leq \Delta\left(e_{i, 2}\right)$ and $\nabla\left(e_{i, 1} e_{i, 2}\right) \leq \Delta\left(e_{i+1,1}\right)$.

Lemma 3 Let $\operatorname{Sym}(E a)$ be the symmetric group on Ea and let $(x y) \in S y m(E a)$ be a transposition. Then there exist idempotents $f_{1}, f_{2}, f_{3} \in P \operatorname{End}(\mathcal{A})$ such that $f=\left(f_{1} f_{2} f_{3}\right) \mid E a$ and $\operatorname{rank}\left(f_{i}\right)=\operatorname{rank}(a)$.

Proof: Since $|E a|<\operatorname{rank}(\mathcal{A})$ there exists $z \notin\langle E a\rangle$ and hence $E a \cup\{z\}$ is independent. Let $f_{1}, f_{2}, f_{3}$ be idempotents of domain $\langle E a \cup\{z\}\rangle$ defined as follows: $x f_{1}=z=z f_{1}$ and $u f_{1}=u$, for the remaining elements of $E a ; x f_{2}=x=y f_{2}$ and $u f_{2}=u$, for the remaining elements of $E a ; z f_{3}=y=y f_{3}$ and $u f_{1}=u$, for the remaining elements of $E a$. Hence $(x) f_{1} f_{2} f_{3}=(z) f_{2} f_{3}=(z) f_{3}=y$ and $(y) f_{1} f_{2} f_{3}=(y) f_{2} f_{3}=(x) f_{3}=x$. Moreover, for all $b \in E a \backslash\{x, y\},(b) f_{1} f_{2} f_{3}=b$. It is proved that $\left(f_{1} f_{2} f_{3}\right) \mid E a=(x y)$ and it is clear that $\operatorname{rank}\left(f_{i}\right)=\operatorname{rank}(a)$.

Lemma 4 Let $f \in \operatorname{Sym}(E a)$. Then there exist idempotents $f_{1}, \ldots, f_{m} \in \operatorname{PEnd}(\mathcal{A})$ such that $f=\left(f_{1} \ldots f_{m}\right) \mid E a$ and $\operatorname{rank}\left(f_{i}\right)=\operatorname{rank}(a)$.

Proof: Clearly $(E a) f=(E a)\left(x_{1} y_{1}\right) \ldots\left(x_{m} y_{m}\right)$, since every permutation of a finite set can be decomposed in to a product of transpositions. Now the result follows by repeated application of the previous lemma.

Observation 5 Observe that, for all the partial idempotents $f_{i}$ considered in the proof of the two previous lemmas, we have $\Delta\left(f_{i}\right)=\langle E a \cup\{z\}\rangle$ and $\nabla\left(f_{i}\right)=\langle E a\rangle$. Thus $\nabla\left(f_{i}\right)<\nabla\left(f_{i+1}\right)$.

Lemma 6 Let $i_{0}, i_{1} \in \operatorname{PEnd}(\mathcal{A})$ and suppose that $\nabla\left(i_{0}\right) \leq \Delta\left(i_{1}\right)$. Then there exist $\beta_{0}, \beta_{1} \in \operatorname{End}(\mathcal{A})$ such that $\left(\beta_{0} \beta_{1}\right) \mid \Delta\left(i_{0}\right)=i_{0} i_{1}, \operatorname{rank}\left(\beta_{j}\right)=\operatorname{rank}\left(e_{j}\right)$ and if $i_{j}$ is idempotent, then $\beta_{j}$ is idempotent $(j \in\{0,1\})$.

Proof: Let $i_{0}:\left\langle B_{0}\right\rangle \rightarrow\left\langle C_{0}\right\rangle$ be a partial endomorphism ( $B_{0}, C_{0}$ are independent sets). Then we can extend $B_{0}, C_{0}$, respectively, to $B, C$, bases of $\mathcal{A}$ and define $\beta_{0}: \mathcal{A} \rightarrow \mathcal{A}$ such that $\beta_{0} \mid B_{0}=i_{0}$ and $\left(B \backslash B_{0}\right) \beta_{0}=\{c\} \subseteq C_{0}$. In the same way we extend $i_{1}$ to $\beta_{1} \in \operatorname{End}(\mathcal{A})$. Therefore $\beta_{0} \mid \Delta\left(i_{0}\right)=i_{0}$ and $\nabla\left(\beta_{0}\right)=\nabla\left(i_{0}\right)$. Thus $\left(\beta_{0} i_{1}\right) \mid \Delta\left(i_{0}\right)=i_{0} i_{1}$ and $\left(\beta_{0} \beta_{1}\right) \mid \Delta\left(i_{0}\right)=i_{0} i_{1}$.

Theorem 7 (Fountain and Lewin [2]) Every $a \in \operatorname{Sing}(\mathcal{A})$ is the product of idempotents $e_{1}, \ldots, e_{n} \in \operatorname{End}(\mathcal{A})$ such that $\operatorname{rank}(a)=\operatorname{rank}\left(e_{i}\right)$.

Proof: Let $a \in \operatorname{Sing}(\mathcal{A})$. Then there exists an idempotent $e$ (with $\nabla(e)=\langle E\rangle$ ) and a partial monomorphism $a^{\prime}=a \mid\langle E\rangle$ such that $a=e a^{\prime}$. Moreover $a^{\prime}$ maps the basis $E$ of $\nabla(e)$ into a basis $E a$ of $\nabla(a)$. We proved that for some idempotents $e_{1}, \ldots, e_{k} \in$ $\operatorname{PEnd}(\mathcal{A})$ we have $(E) e_{1} \ldots e_{k}=E a$. Let $h=e_{1} \ldots e_{k}$ and consider $f \in \operatorname{Sym}(E a)$ defined by $(x h) f=x a$, for all $x \in E$. It is obvious that $\left(e_{1} \ldots e_{k} f\right)|E=a| E$ and hence $\left(e_{1} \ldots e_{k} \phi\right)|\langle E\rangle=a|\langle E\rangle=a^{\prime}$, where $\phi \in \operatorname{Aut}(\langle E a\rangle)$ is (the automorphism) induced by $f$. Therefore $e e_{1} \ldots e_{k} \phi=e a^{\prime}=a$. It is also proved that for some idempotents $f_{1}, \ldots, f_{n} \in \operatorname{PEnd}(\mathcal{A})$ we have $f=\left(f_{1} \ldots f_{n}\right) \mid E a$. Thus $\phi=\left(f_{1} \ldots f_{n}\right) \mid\langle E a\rangle$ and hence

$$
a=e a^{\prime}=e e_{1} \ldots e_{k} \phi=e e_{1} \ldots e_{k}\left(f_{1} \ldots f_{n}\right) \mid\langle E a\rangle=e e_{1} \ldots e_{k} f_{1} \ldots f_{n}
$$

(since $\left.\nabla\left(e e_{1} \ldots e_{k}\right)=\langle E a\rangle\right)$. To finish the proof we only need to show that the idempotent partial endomorphisms used above can be replaced by idempotent total endomorphisms. This follows from Observations 2 and 5 and the previous lemma.
