Continuation of 3. NOTE: The amendment to the claims cancels one of the members of a Markush group of activities. This changes the scope of the claims and thus requires further search and consideration.

Continuation of 11. does NOT place the application in condition for allowance because: The proposed amendment cancels the limitation of nitric oxide production. The amendment changes the scope of the claim and has not been entered. With respect to the rejection of claims 27, 48, 50 and 51 as unpatentable over Ivanov et al., in view of Werner et al. and Cillari et al., in view of Lam et al. in view of Houghten et al. and in view of Lin et al. under 35USC 103(a), Applicant argues that Ivanov et al., in view of Werner et al. and Cillari et al., in view of Lam et al. in view of Houghten et al. and in view of Lin et al. does not show the amended claims. The argument is not persuasive because the amendment to the claims has not been entered. However, even if the amendment had been entered, Cillari et al shows nitric oxide and nitrate are correlated, reading on nitrate production (p. 2651, col. 2).
