

Whereas it appears that, in the above entitled proceeding, on May 13, 1935, the above entitled Court made and rendered an order confirming an order of S. W. McNabb, Referee in Bankruptcy, allowing the general claim in the sum of \$260,200.00 filed in said proceeding by Friend W. Richardson, as Superintendent of Banks of the State of California and in charge of the liquidation of the Bank of San Pedro, an insolvent California state banking corporation, and thereupon and on said 13th day of May, 1935, there was entered by the Clerk of the Court in Book No. 94 of the Minutes of the Court at page 422 the following Minute Order:

McNabb, made and entered on the 9th day of May, 1935, overruling the Trustee's Objections to and allowing the claim of Friend W. Richardson, as Superintendent of Banks; Reuben G. Hunt, Esq., appearing for the Trustee.

"R. G. Hunt, Esq., makes a statement of agreement reached by counsel regarding order which may be entered; and it is ordered that in the light of explanation by counsel, the ruling of the Referee is confirmed and an exception may be noted."

and that thereupon and on said 13th day of May, 1935, there was presented to the Court a formal written order to the same effect as said Minute Order, and that said formal written order was signed by Honorable HARRY A. HOLLZER, a Judge of the above entitled Court, but said written order as so signed was inadvertently dated May 15, 1935, instead of being dated May 13, 1935, the latter date being the date upon which such order was

actually made and rendered, and that such inadvertence in dates should be corrected so that said formal written order may speak the truth,

IT IS HEREBY ORDERED That said formal written order be and the same is hereby corrected and amended so that the date thereof shall read May 13th, 1935, instead of May 15th, 1935, and that this order of correction shall take effect nunc pro tunc as of said 13th day of May, 1935.
