PETITION FOR WRIT.

To the Honorable the Judges of the United States District Court in and for the Northern District of California:

Your petitioner, George R. Andersen, for and on behalf of CAMPBELL WILLIAM SKEOCH BRANCH, an alien, respectfully shows and presents to this honorable court the following facts:

#### I.

That the said alien is at the date hereof unlawfully detained and confined and deprived of his liberty at Angel Island, California, by one Edward Cahill, United States Immigration Commissioner at the port of San Francisco, for the Northern District of California, and by his officers and agents.

#### II.

That your petitioner alleges that said alien is not imprisoned and deprived of his liberty under any process, judgment, or decree of any competent court or tribunal of civil or criminal jurisdiction. [1\*]

## III.

That the true cause or pretense of the restraint and imprisonment of said alien is a certain alleged warrant of deportation in the possession of said Edward Cahill.

## IV.

That said warrant depends upon certain proofs submitted to the Department of Labor of the United States and more particularly the Assistant Secretary of Labor who signed and issued said warrant, which said proofs are in the possession of the said Edward Cahill.

## V.

That said proofs do not state facts sufficient to constitute a crime against any law or laws of the

United States and do not state facts sufficient to confer upon the said Department of Labor jurisdiction to issue said warrant or to deport said alien.

#### VI.

That your petitioner further alleges that for the reasons hereinbefore set forth said detention and imprisonment of the said alien is illegal and without authority or justification in law, and is in violation of the Constitution of the United States of America and the amendments thereto, and contrary to the acts of Congress in such case made and provided, and the said warrant of deportation was wrongfully and unlawfully issued against said alien.

#### VII.

That no prior application for a writ of habeas corpus has been made to this honorable court in and about the matters herein set forth on behalf of said alien.

#### VIII.

That the said warrant of deportation charges that the said alien "is a member of or affiliated with an organization, asso- [2] ciation, society, or group that writes, circulates, distributes, prints, publishes, or displays, or causes to be written, circulated, distributed, printed, published or displayed, or that has in its possession for the purpose of circulation, distribution, publication, issue, or display, written or printed matter advising, advocating, or teaching the overthrow by force or violence of the government of the United States, or of all forms of law.

## IX.

That in the record of the proceedings before the said Immigration Department, and reviewed by the said Assistant Secretary of Labor there is no evidence upon which to sustain the charges contained in the said warrant of deportation; and a copy of the said proceedings before the said Immigration Department are filed herewith, and made a part hereof.

## Х.

That in the said copy of proceedings before the Immigration Department reference is therein made to many exhibits introduced in evidence by the government and by the alien; that your petitioner is unable to file copies of said exhibits herewith for the reason that the said exhibits are not available to your petitioner, and are in the possession of the said Edward Cahill.

#### XI.

WHEREFORE, your petitioner prays that a writ of Habeas Corpus issue out of this Honorable Court directed to the said Edward Cahill, on behalf of said alien, and that the said Edward Cahill be ordered and directed to be and appear before this Court to show cause, if any he may have, why the said petition should not be granted; and further, that pending the hearing the alien be admitted to bail.

ORDER TO SHOW CAUSE

Upon reading and filing the verified petition of George R. Andersen, for and on behalf of CAMP-BELL WILLIAM SKEOCH BRANCH, for a writ of Habeas Corpus, whereby it appears that the said CAMPBELL WILLIAM SKEOCH BRANCH is unlawfully imprisoned and restrained of his liberty by Edward Cahill, Commissioner of Immigration for the Northern District of California, at Angel Island, California, from which it appears that a Writ of Habeas Corpus ought to issue:

That on the 4th day of February, 1936, the above entitled court made and entered its order denying the petition for a writ of habeas corpus as prayed for in the petition on file herein, in which said order in the above entitled cause certain errors were made to the prejudice of the appellant herein, all of which will more fully appear from the assignment of errors filed herewith.

ASSIGNMENT OF ERRORS.

Comes now the petitioner and appellant herein and sets forth the errors he claims the above entitled court committed in denying his petition for a writ of habeas corpus, as follows:

## I.

That the court erred in not granting the writ of Habeas Corpus and discharging the said alien from the custody and control of Edward Cahill, Commissioner of Immigration at the port of San Francisco.

## II.

That the court erred in not holding that it had jurisdiction to issue the writ of habeas corpus as prayed for in the petition on file herein.

## III.

That the court erred in not holding that the allegations set forth in the petition for a writ of habeas corpus were sufficient in law to justify the granting and issuing of the writ of habeas corpus.

#### IV.

That the court erred in holding that the evidence adduced before the immigration authorities was sufficient in kind and character to warrant a finding by the Court that the said alien was not entitled to a writ of habeas corpus and that said [12] alien was entitled to a complete discharge from the cus-

tody and control of said Edward Cahill, Commissioner of Immigration at the Port of San Francisco.

V.

That the court erred in holding that the record contained sufficient evidence to show the charges placed against the alien were proven.

#### VI.

That the court erred in not holding that the proceedings against said alien were unfair and prejudicial to the alien and that the warrant of deportation was arbitrarily issued, by virtue of the fact that the record of the hearing does not contain sufficient or any evidence to justify the issuance of said warrant of deportation.

WHEREFORE, appellant prays that the said order and judgment of the United States District Court for the Northern District of California, made and entered herein on February 4th, 1936, denying the petition for a writ of habeas corpus, be reversed and that he be restored to his liberty and go hence without delay.
