## MINUTES.

1st. The Introductory Sermon was preached by Eld. S. F. Phillips, of the Upatoie Association of Georgia, from 2nd Timothy, iv. 2: "Preach the word," etc.

2nd. The Hymn: "How Sweet the name of Jesus sounds," was sang by the brethren and congregation, and prayer was offered by Eld. S. W. Pruet, of the Hillabee Association, of Alabama.

3rd. Letters from the churches composing the Olive Association were called for and read and messengers names enrolled, and the status of the churches noted.

4th. On motion of Eld. B. H. Pierson the present incumbents were elected by acclamation to serve as Moderator and Clerk, viz: Eld. J. S. Baxley, Moderator, and Eld. H. J. Redd, Clerk.

5th. Invited visiting ministers and brethren from sister Associations to seats.

6th. Agreed to adopt the same order of business as of last year.7th. Appointed the following Committees :

To Arrange Preaching—B. H. Pierson, J. W. Foster and R. A. Thompson, together with the messengers of Concord Church, viz: J. W. Galloway, J. T. Penington and A. S. Henderson.

11th. Preaching Committee announced Eld. R. B. Smith to preach this afternoon, followed by Eld. E. S. Sellers from the Beulah Association; Eld. S. W. Pruet, of the Hilabee Association, to preach at 10 A. M. to-morrow, followed by Eld. H. J. Redd, of this body.

12th. The Association then adjourned to meet for business again at 8:30 to-morrow morning.

#### SATURDAY MORNING.

October 20th.

1st. The Association met pursuant to adjournment, and after singing the Hymn:

"Father, whate'er of earthly bliss Thy Sovereign will denies,"

Prayer was offered by Eld. E. C. Thrash, of the Primitive Western Association.

2nd. Called the roll and marked absentees.

3rd. Renewed the invitation to correspondents from sister Associations and received :

To the Upatoie-B. H. Piérson, J. S. Baxley and H. J. Redd. Convenes with Bethel Church, near Butler, Ga., on Tuesday after the first Sunday in September, 1895.

To the Conecul River—B. H. Pierson, C. P. D. Taylor, H. J. Redd and J. S. Baxley. Convenes with Pisgah Church, Montgomery county, Ala., on Friday before the last Sunday in August, 1895.

6th. Called for the reading of the Corresponding Letter, which was read, received and ordered to be spread upon these minutes.

7th. Received contributions from the churches amounting to \$14.80; also an additional sum of \$1.35 from brethren present. Distributed corresponding minutes, and agreed to have 600 copies of these minutes printed and distributed in the usual way; the Clerk to superintend the same and to have remaining funds, if any, for his services.

8th. Agreed that the next session of this body convene with Mt. Gillead Church, 4 miles south of Motts' Mill, on the Columbus and Western Railroad, between Columbus, Ga., and Opelika, Ala., on Friday before the third Sunday in October, 1895.

9th. Instructed the Clerk to tender a note of thanks to the brethren and friends of this neighborhood for their unstinted hospitality extended to us while in their midst.

10th. On motion heard the reading of the minutes, which were adopted, and then adjourned for final adjournment at the stand on Sunday. J. S. BAXLEY, Moderator.
