1. Copy of UPI Chicago Press Release regarding comments by DICK GREGORY, alleging that he had evidence placing some of the same familiar persons in the Watergate scandal in Dallas at the time of President KENNEDY's assassination.

2. Flimsy Press Release Sheet showing DICK GREGORY with known photographs of E. HOWARD HUNT and FRANK STURGIS, and pictures of two individuals photographed at Dallas on 11/22/63.

3. Photograph taken at Dallas, 11/22/63, showing three unknown individuals and a Dallas Police Officer.

4. Photograph taken at Dallas, 11/22/63, showing three unknown individuals (one almost completely obscured) and three Dallas Police Officers, one of whom had back to camera.

6. Photograph taken at Dallas, 11/22/63, showing same three unknown individuals and two Dallas Police Officers from different angle.

Each of the above enclosures have been identified by number as indicated above.

It is noted that the photographs made available by Mr. JOHNSON are copies of portions of the same photographs showing the three unknown individuals in custody of Dallas Police Officers mentioned in referenced Bureau airtel dated 9/18/74.

Copies of the six above described items furnished by Mr. JOHNSON are being retained in Dallas Files.

The foregoing described items are furnished the Bureau for information. It appears that investigation has been conducted to substantiate that E. HOWARD HUNT and FRANK STURGIS were in Dallas on 11/22/63.
