PROCEEDINGS.

CICERO, INDIANA, OCTOBER 16TH, 1866.

The Ministers and Lay Delegates comprising the Twelfth Annual Convention of the Evangelical Lutheran Synod of Northern Indiana, assembled in the Lutheran Church at Cicero, Indiana, in the charge of Rev. D. Smith, on Tuesday Evening, October 16th, 1866.

The President, Rev. W. P. Ruthrauff, delivered the Synodical Sermon from John, 21: 15. "Feed my Lambs."

FIRST SESSION.

WEDNESDAY MORNING, 9 O'CLOCK, OCTOBER 17TH, 1866.

After an hour's meeting for prayer, Synod was called to order. The brethren united in singing a hymn, after which the President led in prayer.

The ministerial roll was then called and the absentees noted. The delegates from the various charges were next received, on presenting certificates, and their names recorded.

On motion, the regular order of business was suspended, in order to the admission of several ministers from other Synods.

Rev. J. W. Henderson was received on certificate from Miami Synod, Ohio. Also, Rev. P. Bergstresser, from Illinois Synod.

Rev. S. McReynolds, of the East Ohio Synod, having transmitted his certificate to the President, it was

(I.) Resolved, That we now sanction the action of the President of Synod in the reception of Rev. S. McReynolds from the Evangelical Lutheran Synod of East Ohio.

PRESIDENT'S REPORT.

The President read his report, as follows:

Fathers and Brethren:

In the merciful providence of our God, we are again permitted to meet in Synodical Convention. Again permitted, after the cares and the tears, the joys and anxieties of another year, to greet each other in the flesh; again permitted to meet to devise good for Zion.

Whilst some things have occurred to mar the peace of our churches and disturb the friendly intercourse of some of our brethren, some things over which we have had cause to mourn, there are other things over which, as a Synod, we have just cause to rejoice.

During the year that has just ended, many souls have been gathered into the folds of the Redeemer; and saints have been built up in the faith and hope of the gospel. God's Word has not returned unto him void. Many of our ministerial bretbren who have gone forth weeping, bearing the seed of the word, have returned rejoicing, bearing precious sheaves.

From every part of the Synod, tidings have come up, that God has owned and blessed the preaching of His Word, to the salvation of precious souls. For these manifest tokens of our Master's gracious presence and blessing, we devoutly thank and praise His glorious name.

In presenting a summary of my official acts during the interval of Synod, I deem it unnecessary to burden your minutes with a specific account of all the numerous letters and inquiries I have had to answer during the year. It will be sufficient for me to say that I did all that it was in my power to answer to the best of my knowledge.

CALLS ACCEPTED.

1. The week after the adjournment of Synod, I visited the "Lost-Creek Charge," in company with Father Hunt, who, after having preached in the different congregations, received and accepted a call, and immediately entered upon his duties.

2. About the 10th of October, I received a letter from Rev. C. Sink, stating that in accordance with the recommendation of Synod, he had visited the "Spencerville Charge," received and accepted a call, and would shortly enter upon his duties.

April 23d, 1866, I received a letter from Rev. S. McReynolds, containing a certificate of dismission, from the President of the East Ohio Synod to this body. This certificate is now before you, and his reception cheerfully recommended.

DISMISSION.

Sept. 28th, 1866, I received a letter from Rev. J. M. Lang. stating that he had taken charge of congregations in the bounds of the English Ohio Synod, and requesting a letter of dismission to that body, which was granted.

MISCELLANEOUS BUSINESS.

Some weeks after the adjournment of Synod, I received an application, signed by the members of the Northern Conference, urging me to grant ad-interim license to Bro. J. W. Miller; but in view of the fact that my worthy predecessor had given Bro. Miller ad-interim license and that Synod after examining this brother, had so unanimously decided to take his license from him, or rather decided not to renew it, and in view of the fact that Synod, as I thought, had very wisely requested Bro. Miller to place himself under the instruction of Bro. Waltman, with the view of preparing himself for an examination at this Synod, I did not feel—much as I sympathized with Bro. Miller—that it would be right for me to do what would be in direct contradiction to the almost unanimously expressed will of this Synod.

On the 26th of March, I received a letter from the Rev. B. F. Hills, containing several grave charges against Rev. J. G. Biddle, which he declared himself prepared to prove, and asking that the matter be investigated. After some correspondence with regard to the matter, I wrote to Bro. Biddle, transmitting him a copy of the charges and stating that my duty would require me to order an investigation. The matter was finally, at Bro. Biddle's own suggestion, referred to the Northern Conference. For the result of that investigation, I would refer Synod to the minutes of that Conference.

On the 15th of March, I received a letter from Rev. C. Sink, stating that Father Hunt had said that he—*i. e.*, Rev. Sink—had gone beyond the limits of his power, in organizing a congregation at Maysville, within the bounds of Father Hunt's charge, and asking whether in my opinion, he had done so or not. To this letter I replied, that in my opinion, he had transcended his powers as a licentiate, in thus organizing a congregation within the bounds of Father Hunt's charge, without at least consulting him. To this letter I received an answer on the 23d of April, asking whether he should disband his organization, to which I replied that they had better continue it and make application to Synod, where the whole matter could be adjusted.

Oct. 2d, I received a letter from Rev. G. E. Moore, giving an account of the condition of his charge and stating that he had, for various reasons, dropped one of his congregations-Bruce Lake. To which letter I replied, that in thus dropping that congregation, he had violated an express law of the Synod, and that the best I could do was to commend him to the favor of Synod. All of which is respectfully submitted for your approval.

Nor can I close this report, without asking the prayers of this Synod for our dear Father Hunt, who for eight weeks has been suffering at the point of death; all that time not being able to lie down day nor night, and of whose recovery there is no hope.

With the earnest prayer that we may have a pleasant and profitable session of Synod, I cheerfully recommit into your hands the office with which you have so kindly intrusted me. W. P. RUTHRAUFF.

WEDNESDAY, 2 O'CLOCK, P. M.

The Report was received and adopted seriatim.

Item 1. Reverends Waltman, Wells and Cromer, were appointed to confer with Rev. C. Caskey.

Item 2. The brethren complied with the Resolutions, without, as yet, accomplishing anything definite.

Item 3. The Committee was continued, and after a colloquial discussion, the evident desire of the Synod was, that said Committee "look well to our wants."

Item 4. Awaiting Report of the Delegates, the matter was deferred. Item 5,

REPORT OF DIRECTORS TO WITTENBERG COLLEGE.

The undersigned, members of the Board of Directors to Wittenberg College, elected by this Synod, report, that they attended the meetings of the Board in March and June. Much business was transacted not necessary to report upon. We, however, will state that the Institution is in a greatly prosperous condition, there having been connected with the College the last year, 195 students. The senior class was the largest ever graduated there. For further particulars we refer you to the Catalogue herewith presented.

At the March meeting, the President, Dr. Sprecher, was voted a salary of \$1,500 annually; the other professors \$1,300. The Prudential Committee were empowered to arrange and embellish the grounds, grade and gravel the drive, and complete and repair the building. Rev. J. Crouse was continued Agent, and he was allowed an addition of \$200 to his salary. He reported \$89,862.81 as secured on the endowment, from which deducting \$4,085.77 expenses, leaves the fund \$85,777.04. He expresses confidence in the complete and speedy endowment.

We asked that, as there were five Synods in connection with the College, and five professors, that our Synod should have one of the faculty; the result of which petition is, that Prof. I. Sprecher was requested to unite with us. Your Committe claim as due them for traveling expenses, \$52,80.

THIRD SESSION.

THURSDAY, 9 O'CLOCK, A. M.

After an hour spent in devotional exercises, Synod opened with prayer by Rev. P. Bergstresser.

Minutes read and approved.

Rev. R. F. Delo presenting himself, was excused for late arrival.

We report the papers placed in our hands to be, (1.) The Minutes of the Fifth Annual Convention of the Evangelical Lutheran Synod of New Jersey. (2.) REPORT OF COMMITTEE NO. I,

(On President's Report.)

Your Committee, to whom was referred the President's Report for examination, beg leave respectfully to recommend,

1. The approval of all the official acts of the President referred to in his Report, and that we sincerely rejoice with him in the continual prosperity of our Zion.

2. In reference to that part of the President's Report which relates to the organization of the congregation at Maysville, and the transcending of the powers of a licentiate by Rev. C. Sink, &c., your committee are of the opinion that the President is correct in his opinion and advice, so far as he had information; but on further and more fully examining into the nature of the case, your Committee has satisfied itself that Rev. Sink is fully exonerated from any blame whatever, on the charge of intentionally interfering in Rev. Hunt's charge, or of violating his powers as a licentiate.

3. In reference to Bro. Moore's case, relinquishing the "Bruce Lake" Church, without the advice and consent of the President, your Committee are of the opinion that he did transcend his powers as a licentiate, but, at the same time, knowing the difficulties connected with the case, are satisfied that he did not intentionally violate said powers, but simply acted prematurely in a case wherein the President would have fully justified him, if properly and timely presented.

Your Committee would recommend, therefore, that Rev. Moore be excused from any intentional violation of the rules, &c., of the Synod as a licentiate, and that hereafter licentiates be more careful in observing the rules, &c., of Synod. All of which is respectfully submitted.

The papers placed in the hands of this Committee are the Constitutions of the Monroeville Evangelical Lutheran Church and Saint John's Evangelical Lutheran Church, Cass County. Indiana. Also, a certificate from the Park-Grove, Mottville, Constantine and White Pigeon Evangelical Lutheran Churches, asking the privilege of changing their Synodical relations from the English Synod of Ohio, to connect with the Synod of Northern Indi-ana, in whose bounds they are situated. Having examined the Constitutions, we find them to be in accordance with the requirements of this Synod, with the suggestion that Saint John's Church strike out the words "North America," and substitute "United States," With this correction, we therefore recommend that they be received into connection with this Synod. In regard to the Park-Grove, Mottville, Constantine and White Pigeon Churches, it is the judgment of the Committee that they be advised first to receive a certificate of dismissal from the English Synod of Ohio, and be requested to send up copies of their Constitutions to the next meet-J. W. HENDERSON. ing of this Synod.

The only document placed in our hands is the Minutes of the Northern Conference of this Synod, held in LaGrange Center, Indiana, June 12 and 14, 1866.

These Minutes are quite meagre and unsatisfactory; but, inasmuch as they contain matter of grave importance, of a strictly ministerial character, we recommend that the matter be referred to the Ministerium.

Rev. J. Crouse was introduced and granted a seat as an advisory member.

On motion, adjourned to give place to the Ministerium. Prayer by Rev. J. Crouse.

SEVENTH SESSION.

SATURDAY, 9 O'CLOCK, A. M.

Rev. E. W. Erick opened the session with prayer, after the customary morning prayer meeting.

The following Resolutions were introduced:

ON THE GENERAL SYNOD.

(IV.) Resolved, That this Synod approve of the ruling of the Rev. S. Sprecher, D. D., President of the General Synod, and of the action of said Synod respecting the Delegates of the Synod of Pennsylvania.

 $(\dot{V}.)$ Resolved, That this Synod disapprove of the proceedings of the Delegates in their withdrawal from the conventions of the General Synod at York and Fort Wayne, and of their Synod in approving of their action, as such a course encourages secession, revolution and disunion in the Church.

(VI.) Resolved, That this Synod hereby re-assert its confidence in the General Synod, and its attachment to that truly venerable, wise and Evangelical body, and that we will pray and labor for its perpetuation and extension.

The above Resolutions having been adopted in the absence of a number of the brethren, and a majority of the General Synod Delegation, the vote was re-considered and the Resolutions tabled, to be acted upon when the Report of the Delegates to said body shall have been presented.

A motion to elect Directors to Wittenberg College elicited an interesting speech from the agent, Rev. Crouse.

Rev. C. Sink and G. W. Kling were appointed Tellers. The result of the ballot was, the election of Rev. H. Wells and Mr. D. S. Keil.*

EDUCATION.

The following preamble and resolution were presented:

WHEREAS, We, as a Synod, feel the necessity of increased effort in the great cause of education, and especially of the education of young men for the gospel ministry in the Lutheran Church, in the West, and

WHEREAS, We believe that Wittenberg College is worthy of our confidence and support, as an institution imparting thoroughness of instruction, and hitherto exerting a favorable moral and religious influence upon its pupils, therefore,

(VIII.) Resolved, That we hereby pledge our prayers and support in behalf of said institution; that we will encourage our young men to enter it, and hereby invite the Agent, for its endowment, to visit our charges for the purpose of collecting funds.

After listening to extended remarks by the Agent, Rev. J. Crouse, Synod adjourned until 3 o'clock, P. M.

(IX.) Resolved, That it be made the duty of each Minister in this Synod, having charge of congregations, to preach, at his earliest convenience, one or more discourses on the subject of Wittenberg College, thus preparing the way for the coming of the Endowment Agent among our people.

The following, presented by Rev. H. Wells, passed:

(X.) Resolved, That an order be drawn on the Treasurer for \$75, to be placed in the hands of the Secretary, to have published, and distributed according to the number of communicants in each charge, as many copies of the Minutes as he can for that amount.

On motion, the following sums were voted for the support of the beneficiaries named, at College:

A. Leathers, \$175, and Owen W. Bowen, \$100.

Synod also passed the two Resolutions, as follows:

(XI.) Resolved, That this Synod advise Brothers Wm. L. Robinson and Wm. Baxter, to pursue their studies at any suitable point, by the consent of their Pastor and the President of Synod, and that Synod appropriate any amount necessary for their support, at the discretion of the Executive Committee.

(XII.) Resolved, That our beneficiaries be required to give Synod their notes, with approved security, payable whether they enter the ministry or not.

The Synod went into Committee of the Whole on the proposed Institute at Elkhart, Indiana, when, after an earnest canvass of the matter, it was

(XIII.) Resolved, That Reverends Delo, Ruthrauff and Wells be a Committee, with discretionary powers, to transact business relating to the establishing of an Institution of Learning, to report at the next meeting of the Synod.

Adjourned.


