### HIGHLIGHTS: SELECTMAN RACE, NEW SCHOOL BUDGET FORMULA

In Sheffield's town elections, to be held on Mon., May 11, there is one contested race. David Smith, Jr., and Rene Wood are running for the position of selectman, a seat currently held by Jim Collingwood. Collingwood took out nomination papers for another term but did not file them. Smith or Wood will join Julie Hannum and David Macy on Sheffield's Board of Selectmen.

Uncontested positions this year are town moderator, one seat on the Library's Board of Trustees and two seats on the Planning Board.

Bruce Person is running for modera-

tor, a position he's held for 20 years.

Betty LeGeyt is running for re-election to the Library's Board of Trustees.

Peter Cherneff, currently a Planning Board alternate, and Chris Tomich, currently the chair of the Planning Board, are running to fill two seats.

Profiles and pictures of the candidates are on pages 6 and 7.

Also on the ballot are two Proposition 2½ budget overrides tied to two articles in the warrant. Question 1a would approve an override sufficient to pay for the alternate method of figuring Sheffield's share of the school budget,

per Article 6 of the warrant. Question 2a would approve an override to pay for the compromise method, per Article 5. See the school budget discussion, below.

Voting will take place from 9am to 7pm at Sheffield's Town Hall. Absentee ballots are available from the Town Clerk up to noon on Fril., May 8. Call the Town Clerk at 229-7000, ext. 151, if you have questions.

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the Town of Sheffield, qualified to vote in Town affairs, to meet in the auditorium of the Mount Everett Regional High School on Berkshire School Road in Sheffield on Monday, May 4, 2009, at 7:00 P.M. for the following purposes:

ARTICLE I: To see if the Town will vote to raise and appropriate and/or transfer from available funds, such sums of money as listed below, and as may be amended, necessary to defray the expenses of the Town for Fiscal Year 2010, or take any other action relative thereto.

Everett Regional High School. All Sheffield residents are welcome at the meeting, but only registered Sheffield voters can vote.

Here are highlights:

Town budget items. Most of the proposed items in Article 1 are at the same level as last year's budget, or even a bit less. The biggest line item is for the Highway Dept., which includes allocations for salt, sand, gravel and asphalt. The largest increases are for items connected with pensions and health insurance—and for town buildings and properties, which is up 9 percent over last year's budget.

Compensation. Under Article 2, compensation for elected officers,

which range from \$200 to \$2,200, remain the same. Article 3 keeps the same \$800 stipend for Sheffield's four members of the School Committee.

School budget. Articles 4 through 9 are about the school budget and present a substantive choice for voters at the town meeting. The nowelected School Com-

mittee for Southern Berkshire Regional School District has come up with a compromise plan to deal with how the five towns that make up the district share the school's operating costs.

Until 2007, the costs were divided according to the "alternative method," based mostly on the number of students. Following the recommendation of Sheffield's Board of Selectmen and Finance Committee, Sheffield's voters that year elected to shift to the "statutory method," a Massachusetts Dept. of Education formula that takes into account a town's relative ability to pay. Since Alford, Egremont, Monterey and New Marlborough are relatively wealthier than Sheffield, the switch saved Sheffield more than \$300,000.

The vote, however, caused a lot of ill will toward the town. New Marlborough sued Sheffield over the issue.

Article 4 presents the compromise

worked out by the School Committee and endorsed by Sheffield's Board of Selectmen. It would use both the alternative and statutory methods to figure each town's contribution, 50/50 in Fiscal Year 2010 (which starts June 1, 2009) and 25/75 in FY 2011. For this compromise to take effect, all five towns must approve it at their town meetings.

The school's operating budget for FY 2010 has been set at \$13,203,459, an increase of 2 percent. Article 5 approves the amount required to meet the compromise. Sheffield's share would be \$5.6 million and would require passage of a Proposition 21/2 override vote in the amount of \$177,000.

Article 6 and 7 are included in

case the compromise of Article 4 and its associated Proposition 2½ override don't pass. Article 6 approves the amount required under the alternative method and would require passage of a Proposition 2½ override vote in the amount of \$305,000. Article 7 approves the amount required under the statutory method and requires no Proposition 2½ override.

Article 8 approves Sheffield's share of the school's capital budget, an amount 6 percent lower than last year's. Article 9 approves \$55,000 money to pay for vocational education for Sheffield students.

New equipment. Article 17 would add \$40,000 to the \$350,000 approved last year for purchase of a new fire truck. The truck couldn't be bought in 2008, until the Fire Dept. was sure it could house it, and the price went up. Article 20 approves \$30,000 for a new brush chipper and snow plows for the Highway Dept., and Article 22 approves \$32,000 for a new police cruiser.

New commission. Article 26 would create a permanent Commission on Disabilities, with five to nine members appointed by the Board of Selectmen.

Most of the other warrant items are "housekeeping" items and identical to items on last year's warrant.

ARTICLE 2: To see if the Town will vote to fix the compensation of the following elected officers of the Town for Fiscal Year 2010, as required by Chapter 41, Section 108 of the General Laws; Moderator, \$200; Selectmen, Chairman \$2,200; Selectmen, two members at \$1,900 each, or take any other action relative thereto.

ARTICLE 3: To see if the Town will vote to raise and appropriate or transfer from available funds, \$800 to pay the stipend for Sheffield's committee members of the Southern Berkshire Regional School District for Fiscal Year 2010, or take any other action relative thereto.

ARTICLE 4: To see if the Town will vote pursuant to M.G.L. c 71, s16B, as amended, to amend Section 4 (e) the SBRSD Regional Agreement as follows:

"For Fiscal Year 2010, each member town's share of the total operating and transportation budget of the District ("Assessment") shall be the amount determined as follows: the district treasurer shall calculate each member town's share of the District's total operating and transportation budget using the alternative assessment method as set forth in the amendment to the SBRSD Regional Agreement voted in May of 200 land shall then multiply such share by fifty percent (50%) (the "Alternative Method Portion"). The district treasurer shall then calculate each member town's share of the District's total operating and transportation budget using the Statutory Method and shall then multiply such share by fifty percent (50%) (the "Statutory Method Portion"). The district treasurer shall then calculate each member town's actual Assessment for Fiscal Year 2010 by adding the Alternative Method Portion to the Statutory Method Portion.

"For Fiscal Year 2011, each member town's share of the total operating and transportation budget of the District shall be the amount determined as follows: the district treasurer shall calculate each member town's share of the District's total operating and transportation budget using the alternative assessment method as set forth in the amendment to the SBRSD Regional Agreement voted in May of 2001 and shall then multiply such share by twenty-five percent (25%) (the "2011 Alternative Method Portion"). The district treasurer shall then calculate each member town's share of the District's total operating and transportation budget using the Statutory Method and shall then multiply such share by seventy-five percent (75%) (the "2011 Statutory Method Portion"). The district treasurer shall then calculate each member town's actual Assessment for Fiscal Year 2011 by adding the 2011 Alternative Method Portion to the 2011 Statutory Method Portion."

ARTICLE 5: To see if the Town will vote to approve the Southern Berkshire Regional School District ("District") Operating Budget for Fiscal Year 2010 of \$13,203,459 and vote to raise and appropriate \$5,451,605 to pay the Town's assessed share of that budget under the alternate apportionment formula, said formula being an optional alternative to the statutory formula enumerated in Chapter 71, Section

16B of the General Laws, said appropriation to be contingent both on the passage of a Proposition 2 ½ override in the amount of \$177,000, and passage by the five member towns of the District of the amendment contained in Article 4 above, or take any other action relative thereto.

ARTICLE 6: To see if the Town will vote to approve the Southern Berkshire Regional School District ("District") Operating Budget for Fiscal Year 2010 of \$13,203,459 and vote to raise and appropriate \$5,580,157 to pay the Town's assessed share of that budget under the alternate apportionment formula, said formula being an optional alternative to the statutory formula enumerated in Chapter 71, Section 16B of the General Laws, said appropriation to be contingent both on the passage of a Proposition 2 ½ override in the amount of \$305,000, and the failure of any of the five member towns of the District to pass the amendment contained in Article 4 above, or take any other action relative thereto.

ARTICLE 7: To see if the Town will vote to approve the Southern Berkshire Regional School District Operating Budget for Fiscal Year 2010 of \$13,203,459 and vote to raise and appropriate \$5,323,053 to pay for the Town's assessed share of that budget under the statutory formula enumerated in Chapter 71, Section 16B of the General Laws, said appropriation to be contingent on the failure of Article 5 above and Article 6 above to pass, or the failure of any of the contingent Proposition 2 ½ overrides noted therein to pass, or take any other action relative thereto.

ARTICLE 8: To see if the Town will vote to approve the Southern Berkshire Regional School District Capital Budget for Fiscal Year 2010 and vote to raise and appropriate \$190,190 to pay the Town's assessed share of that budget, or take any other action relative thereto.

ARTICLE 9: To see if the Town will vote to raise and appropriate or transfer from available funds \$55,000 to pay for vocational education tuition in Fiscal Year 2010, or take any other action relative thereto.

ARTICLE 10: To see if the Town will vote to raise and appropriate and/or transfer from available funds, a sum of money for the disposal and management of solid waste, or take any other action relative thereto.

ARTICLE II: To see if the Town will vote to authorize the appointment of members of the Board of Selectmen to any office or position under their supervision at no additional compensation in accordance with the provisions of Chapter 268A, Section 21A of the General Laws, or take any other action relative thereto.

ARTICLE 12: To see if the Town will vote to authorize the Board of Health to employ any of its members, including members who also serve on the Board of Selectmen, as Title 5 Witnesses for Septic Systems Evaluation Tests and Inspections at a rate of \$35.00 per inspection, and/or Sanitation (Title 5) Inspector at an annual salary of \$500 for Fiscal Year 2010, or take any other action relative thereto.

ARTICLE 13: To see if the Town will vote to raise and appropriate, transfer from Overlay Surplus, and/or transfer from available funds, \$70,000 to provide for extraordinary or unforeseen expenditures under the provisions of Chapter 40, Section 6 of the General Laws, known as the Reserve Fund, or take any other action relative thereto.

ARTICLE 14: To see if the Town will vote to authorize the Treasurer/Collector to sell, with the approval of the Board of Selectmen, any parcel or parcels of real estate which have been or may be acquired through the foreclosure of tax title, or take any other action relative thereto.

ARTICLE 15: To see if the Town will vote to raise and appropriate or transfer from available funds \$29,053 to pay principal and interest on the bonded indebtedness authorized by Town Meeting vote of January 30, 1995, or take any other action relative thereto.

ARTICLE 16: To see if the Town will vote to raise and appropriate or transfer from available funds \$750 to the Emergency Response Fund, or take any other action relative thereto.

ARTICLE 17: To see if the Town will vote to raise and appropriate or transfer from available funds \$40,000 to be added to the \$350,000 approved under Article 16 of the 2008 Annual Town Meeting Warrant to purchase a new fire truck, or take any other action relative thereto.

ARTICLE 18: To see if the Town will vote to raise and appropriate or transfer from available funds \$18,000 to purchase new turnout gear for the Fire Department, or take any other action relative thereto.

ARTICLE 19: To see if the Town will vote to raise and appropriate or transfer from available funds \$19,600 to compensate firefighters for training, or take any other action relative thereto.

ARTICLE 20: To see if the Town will vote to raise and appropriate or transfer from available funds \$30,000 for a new brush chipper and snow plows, or take any other action relative thereto.

ARTICLE 21: To see if the Town will vote to raise and appropriate or transfer from available funds \$50,000 for a new highway garage design and feasibility study, or take any other action relative thereto.

ARTICLE 22: To see if the Town will vote to raise and appropriate or transfer from available funds \$32,000 to purchase and equip a new police cruiser for the Police Department, or take any other action relative thereto.

ARTICLE 23: To see if the Town will vote to raise and appropriate or transfer from available funds \$5,000 for commercial personal property tax appraisal consultant services for the Board of Assessors, or take any other action relative thereto.

ARTICLE 24: To see if the Town will vote to raise and appropriate or transfer from available funds \$15,000 for

town repairs and building improvements to include the Town Hall, Library, and Police Station, or take any other action relative thereto.

ARTICLE 25: To see if the Town will vote to raise and appropriate or transfer from available funds \$10,000 to purchase up to date information technology hardware, software, and services, or take any other action relative thereto.

ARTICLE 26: To see if the Town will vote to accept the provisions of Chapter 40, Section8] of the General Laws and establish a permanent Commission on Disabilities to cause the full integration and participation of people with disabilities in Sheffield. Such commission shall (1) research local problems of people with disabilities; (2) advise and assist municipal officials and employees in ensuring compliance with state and federal laws and regulations that affect people with disabilities; (3) coordinate or carry out programs designed to meet the problems of people with disabilities in coordination with programs of the Massachusetts office on disability; (4) review and make recommendations about policies, procedures, services, activities and facilities of departments, boards and agencies of said city or town as they affect people with disabilities; (5) provide information, referrals, guidance and technical assistance to individuals, public agencies, businesses and organizations in all matters pertaining to disability; (6) coordinate activities of other local groups organized for similar purposes.

Said commission shall consist of not less than five nor more than nine members to be appointed by the Board of Selectmen. A majority of said commission members shall consist of people with disabilities, one member shall be a member of the immediate family of a person with a disability and one member of said commission shall be either an elected or appointed official of the Town. The terms of the first members of said commission shall be for one, two or three years, and so arranged that the term of one-third of the members expires each year, and their successor shall be appointed for terms of three years each. Any member of said commission may, after a public hearing, if so requested, be removed for cause by the appointing authority. A vacancy occurring otherwise than by expiration of a term shall be filled for the unexpired term in the same manner as an original appointment. The chairperson and other officers shall be chosen by a majority vote of said commission members.

ARTICLE 27: To see if the Town will vote to accept Chapter 32B, Section 18A of the General Laws which will require that all persons who retire after the acceptance of this section, their spouses and dependents who are enrolled in Medicare Part A at no cost to a retiree, their spouse or dependents, or eligible for coverage thereunder at no cost to a retiree, their spouse or dependents, be required to transfer to a Medicare extension plan offered by the Town, or take any other action relative thereto.

You are also directed to notify and warn the inhabitants of the Town of Sheffield, qualified to vote in Town elections, to meet in the Town Hall on Depot Square in Sheffield on Monday, May 11, 2009 at 9:00 AM then and there to bring in their votes for the election of the following Town officers:

One Moderator for one year
One Selectmen for three years
One Library Trustee for three years
Two Planning Board members for three years

And to decide on the following questions:

David Smith, Jr. David and his wife, Jeanne, both graduated from Mt. Everett High School. They have four children, Tony, Christina, Elizabeth and Kelly. They

have been co-owners of the Great Barrington Sears store for 11 years. Prior to that time they owned "Smitty's," next door, for 17 years.

David has been an active member of the Sheffield Kiwanis Club for 17 years, serving at different times as president and currently as president-elect. He is also the Past Distinguished Lieutenant Governor of the New England District of Kiwanis. He notes with great pride that Kiwanis raises \$35,000 in scholarships annually for seniors at Mt. Everett and Monument Mountain High Schools and Berkshire School.

While living in Great Barrington, David served two terms on that town's Board of Selectmen, first winning as a write-in candidate. His platform was to bring in the town manager form of government to that town. Since moving to Sheffield he has served eight years on the Sheffield Finance Committee, two of them as vice chairman.

Rene has been an active fundraiser for the Sheffield Historical Society and Christ Episcopal /Trinity Lutheran Church and a volunteer with the Sheffield Land Trust. She's volunteered with Elder Services and was the first advertising manager for the Sheffield Times. Her baked goods, jams and chutneys are donated to many local organizations.

Rene first came to Sheffield over 25 years ago and became a full-time resident 11 years ago. She holds BA, MBA and MA degrees and has a long-standing interest in elder issues. 


