We were wondering what you would like to do with our water samples. We have water samples from every 2 hours at Rotary Park starting Friday night at 6 PM.

We are going to pull the ISCO and monitor the samples again tomorrow.

1. How much of the water do you want (every 2, 6 etc hours)?
2. How do we move forward with testing- shall we package and prepare them for shipping to the lab?
3. Please forward the methods, shipping number, etc.
4. What interval should we program the ISCO to collect going forward?

Also, you mentioned this morning a concern about the differences in the potential for the data that we are collecting to be coming back in different units than the EPA data. I want to talk this through with you- it should be the same and I want to make sure that we are collecting the data the way that you want it. We should be on the same page.

Finally, Fort Lewis College will have a new ICP machine installed in two weeks. Would there be interest? Are you interested in collaborating with them in the future?

Let us know- we would want to set up a regular schedule and pattern for sending these off so that there isn't a delay.
