Hi Jess,

Can you make a few changes before I send this over to the Mayor for approval?

- 1) Drop South El Monte. No need to compare us to them, as we know they are a higher crime rate area.
- 2) Drop Slide 4 – Duarte Part 1 Crime Rates. Not really important to us.
- 3) Drop Slide 5 crime rates per 10k. Since we are a population of 1k, I think its more understandable to reduce the other cities to our side in comparison. Plus, having a comparison of 10k then a comparison to 1k is a bit confusing.

With the stats, It looks like we have a higher Robbery rate than Duarte and Temple. It would be best for you to have an understanding of this Robbery since there is only one, as I' sure you will be asked about it during the meeting. Additionally, it might be good to have an understanding of the other cases too, now that I think about it. It's good to know if these crime rates are a result of random people doing crime in the city, or are they relatives doing it to one another. Additionally, is this all one house reporting crime, or is this going on throughout the City. This helps in understanding if this crime is really occurring to random residents (which is to be feared) or if there are just a few problem homes in the City (which is not to be feared).

When you have a moment, it would be appreciated if you could make these changes, and send the updated PPT back to me. I will then forward it to the Mayor for his review and approval.
