Today, I met with the chief to go over our stats for the period between April 2017 through May 2018. As a station, we have a lot for which to be very proud. Some outstanding work has been done, and I feel compelled to thank each of you for contributing to the success of our station. Here are a few positive highlights:

- Narcotics related arrests were the highest in 3 years
- \* Administrative investigations were down 53%
- \* Personnel Complaints were down 61%
- \* Service Complaints were down 30%
- \* Overall complaints were down 54%
- \* Commendations by the public were up 19%

I am also very proud of the great police work and arrests that have taken place. I am impressed by the reports I have read and I am energized by our motivated staff. We were recently in a lull regarding our overall arrests, but that has turned around. In fact, the overall arrest stats for last month were the highest since August 2016.

Looking forward, we will build upon the successes we have achieved. And, as we continue to work hard, do what is right, lead by example, and put our mission first, our goals for the station for this coming year are to:

- \* Continue to make quality arrests at a higher volume
- \* Ensure we stay safe by lowering our preventable traffic collisions
- \* Reduce our IODs by employing the best tactics possible

To help reduce our preventable traffic collisions, we already have a plan in place which will ensure everyone receives training. I am confident the additional training will be beneficial for everyone.

Thank you again for all the good work you do. You should be very proud of yourselves and your partners.
