For some months now, there has been talk about morphing our Emergency Response Committee into a Public Safety type committee. The idea has been gaining traction and a report on the discussion will be presented at the upcoming Council meeting on the 16th. Ultimately, I have no idea what the Council will do.

The idea though would be that this committee would may not just focus on disaster preparedness. Maybe the Committee will additionally start analyzing crime reports, work with neighborhood watch programs, and be the spring board to large law enforcement discussions (similar to how the Council discussed the CSO program and police services in the past).
