SUBJECT: ALPR CAMERA INSTALLATION AT MT. OLIVE AND GARDI

Dear Kevin:

As we have discussed on several occasions, both the Cities of Duarte and Bradbury recognize the benefits derived from the installation of ALPR cameras at Mt. Olive Drive and Gardi Street in the City of Bradbury. Each City also appreciates the importance of keeping our residents and their properties safe. The Cities of Bradbury and Duarte have partnered on joint projects in the past and would like to do so again on the installation of two ALPR cameras.

Please consider this letter as a confirmation of the agreement between our Cities that:

1. The City of Duarte will purchase and oversee the installation of two ALPR cameras at Mt. Olive Drive and Gardi Street. The City of Bradbury will contribute up to \$15,658.50 (see attached quote) towards the costs of purchasing and installing the ALPR camera.
2. The City of Bradbury will provide the Point of Connection for the street light at their existing meter pedestal and be responsible for the payment of any increased electrical costs as a result of the installation of the new ALPR cameras.
3. The City of Duarte will be responsible for the installation and cost of the concrete pads for both ALPR cameras.
4. The City of Duarte will be responsible for purchasing two "Verizon" SIM cards necessary for the ALPR system to send information to the Los Angeles County Sheriff Department and the monthly cost of the two SIM cards.

If you concur with the terms of this agreement, please sign below on both copies, keep an original for your files, and return a signed copy for my files. Again, I greatly appreciate your willingness to partner on this project as we seek to make our communities better places to live, work, and play.
