A Hearing to determine the legality of the tow must be requested within 10-days of the notification, per 22852 CVC.

Basis of Decision:

Deputy Wang responded to a call of an abandoned vehicle, Tag 219, at 1600 Mountain Avenue, Duarte. Deputy Wang checked the license plate number and discovered the registration was expired for over a year. Deputy Wang requested a vehicle tow and completed the paperwork.

R/O Mira had been shopping and came out of the store and found his vehicle missing. He called Temple Station and was advised it had been towed. R/O Mira called to Temple Station on July 16, 2018, and requested a Stypmann hearing.

I conducted a Stypmann hearing on July 16, 2018, at 1600 hours. R/O Mira presented paperwork that showed he purchased the vehicle on June 20, 2018, from Auto Desert Dealership and a DMV "Used Vehicle Dealer Notice/Temporary Identification" sticker was placed in the lower right front windshield, allowing vehicle operations until license plates/registration are received by R/O Mira or 90 days after the vehicle sale. I verified through Jan's Towing that the sticker was in place on the windshield.

Deputy Wang advised me he did not see the sticker on the windshield.

Based on my review, the tow and storage was invalid due to Deputy Wang failing to check the front windshield for the temporary sticker after noting via DMV records that the vehicle had been sold on June 20, 2018. R/O Mira was provided a release for the vehicle and Jan's Towing (Leia) was contacted on July 24, 2018, to reimburse R/O Mira.

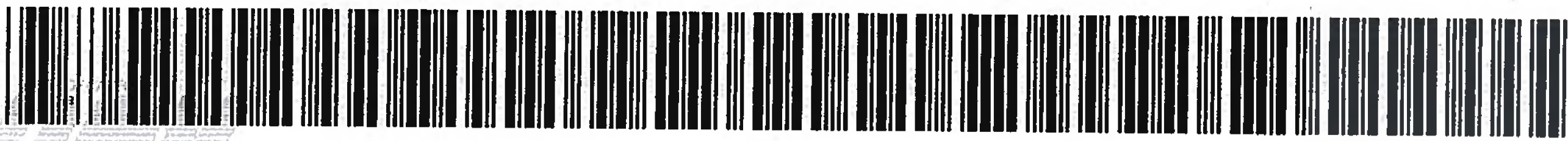

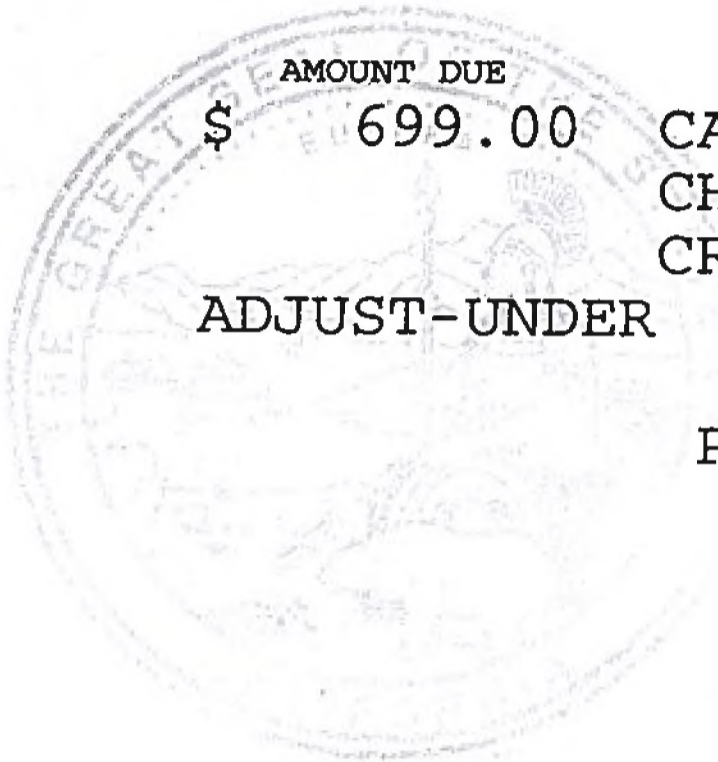
