DATA QUALITY 35. For further information on the data quality of Indigenous census data, see Populati Household Income 42. Due to operational limitations, the family/household income imputation method Distribution, Aboriginal and Torres Strait Islander Australians (Cat. No. 4705.0). This publication presents counts for Aboriginal and Torres Strait Islander Australians from thIncome (FINF) 2001 Census for Indigenous geographic areas, accompanied by information on data quality to help interpret the data. Population estimates of the Indigenous population based on the 2001 Census are also included. For comprehensive information on the quality ϕf Indigenous census data, see Population Issues, Aboriginal and Torres Strait Islander Australians (Cat. No. 4708.0).

36. Each stage of the Census is subject to stringent quality assurance measures. However, in a census there are recognised sources of error which may survive in the data produced. These include undercounting, processing and respondent error. Some of these are overcome or 'repaired' during processing. The effect of those that remain is generally slight, although they may be more important for small groups in the population such as the Indigenous population. The primary forms of error to keep in mind are:

Partial 37. In some cases where an answer was not provided to a question an answer was non-response imputed or derived (often from other information on the form). In other cases a 'not stated' code was allocated.

Processing error 38. While such errors can occur in any processing system, quality management is used to continuously improve the quality of processed data, and to identify and correct data of unacceptable quality.

Random 39. Cells containing small values are randomly adjusted to avoid releasing information Adjustment about particular individuals, families or households. The effect of random adjustment is statistically insignificant.

Respondent erroi40. Processing procedures cannot detect or repair all errors made by persons in completing the form, therefore some may remain in final data.

Undercount 41. Although the Census aims to count each person once, there are some people who are missed and others who are counted more than once. A post enumeration survey is conducted soon after the Census to measure the undercount.

(HIND) and Family may result in an undercount of the number of families/households in the \$1,500 - \$1

range and a balancing over count in the \$2,000 range. No other income ranges are affected. This may also affect the median income estimate if the median falls in eithe these ranges.

43. The calculation of median income is based on imputations made from the Survey Income and Housing Costs, and as such is subject to sampling error. This is particular evident if the median falls into the highest income range, where the guoted median i proxy only and should be regarded with caution.

44. Further information on data quality will be provided progressively in Census Upd and in the 2001 Census fact sheets and working papers.
