Hello Ron,

I am glad we were able to finally complete your request.

Traditionally we prefer to not overlay PCC streets with asphalt. However as time goes on some concrete streets deteriorate to a point where they require attention and are in fact covered with asphalt. I will have McCadden inspected and from your description most likely placed in a future resurfacing program. Eventual resurfacing will happen but will be based on utility clearances and available funding.

Well, McCadden Pl. 230' south of Santa Monica Bl. finally got resurfaced.

It looks beautiful - your department did a great job - thank you!

In fact, so great that I want to ask you about the cracked concrete portion farther south of the completed section all the way to Romaine St.

It is badly cracked and I have been noticing that when large trucks or buses come by ( I am on a bus turnaround for MTA bus 156), the building shakes as a result.

It has been getting worse and the new repaving did not have alleviate that.

So, is there any way you could schedule your crew to come back at some point and do the rest of McCadden Pl. approximately 460 ft. north of Romaine St.?

Thank you, I had a great time vacationing at Lake Tahoe.  
I have just been informed that our Coordinating Section has been able to gain DWP clearance for the portion of McCadden Place south of Santa Monica Bl. that you are requesting. I will include this street segment in our current 16-17 resurfacing program. We will schedule this project for the second quarter of this fiscal year when we are in the area to complete other already scheduled projects. I do not schedule the crew's work, but the second quarter begins October 1 so this will likely be completed before the end of the calendar year.  
Notices will mailed to affected property owners indicating the month the work will be scheduled and Notices of Street Work will be distributed door to door indicating the approximate start date, prior to work commencing.

Dave,

I have been requesting a resurfacing several times since 2/09 and DWP has delayed this several times.

The reason for the hold is so that DWP can park their equipment on McCadden while they do their repairs for the project on Santa Monica Bl. In any case, it is not McCadden that is part of their project but Santa Monica Bl.

Since the work is not scheduled for another year, I see no reason why the resurfacing could not be done before that.

I would like to speak with someone at DWP about this to see if they could release their hold temporarily while the resurfacing is done this fiscal year.

The asphalt portion of McCadden Place south of Santa Monica is only 230'. This segment was first proposed for resurfacing in the 13-14 program. A hold was placed by DWP at that time and subsequently extended for DWP project #45714, which is their Santa Monica Bl., Highland to Seward project. Their work is currently scheduled to begin July 1, 2017.

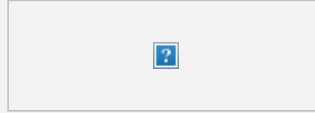

Hi Nikki,

I met you about 6 years ago when I was President of the Hollywood Media District and we had a BID matter to discuss with Tom LaBonge downtown.

I am the gentleman in the photo standing behind you, third from the left and still serve as Board member of the HMD.

Congratulations, by the way on returning as Field Deputy to our District!

I am contacting you regarding getting some information on repairing a portion of my street which neither I nor Lisa Schechter, our Executive Director, have been able to get from BSS. Last year, it was scheduled for repair but fell off the the list due to a DWP hold. If you read the chain of emails below, you will see that we have

been trying to get a contact at DWP regarding a hold on the BSS repair of the street.

It is my opinion that the hold was a result of a water main issue that has been resolved and DWP has not bothered to release it.

That way it could be put on the list for repair for the next fiscal year in July 2016 instead of July 2017 as Sherman states.

Both Lisa and I have sent emails to Sherman Torres asking for further info without reply.

Could you find out from either BSS or DWP what the problem is and when the work can be rescheduled?

The street is in terrible condition and I have been constantly reporting this as a service request to BSS for over 7 years.

Incidentally, It is only the first 250' of asphalt on McCadden south from Santa Monica Bl. to just past the first alley - the rest of the street towards Romaine is concrete and is fine.

Hi Sherman,  
I am following up on an email sent by our Executive Director for our BID, Lisa Schechter. As a property owner and Board Director of the Hollywood Media District, I am concerned about the condition of the street on McCadden Place. Not only has it not been resurfaced for many years, it gets constant traffic from MTA buses as a turnaround and other heavy vehicles.

Concerning your email response about the DWP project, I know that the hold was due to water main issues on the south side of Santa Monica. As far as I know, that work was completed last year and we have not had any issues since. For those repairs, DWP liked to park their equipment just south of Santa Monica Boulevard on McCadden Pl. - the portion of the street that needs the resurfacing. If another rupture should occur during resurfacing, an unlikely coincidence, I see no reason why DWP couldn't park their equipment north of Santa Monica Bl. on McCadden.

The business owners in this area would like this resolved at some point soon and rescheduled for resurfacing. This street has been inspected and approved for resurfacing through coordinating for more than a year. I have personally been making service requests since 2012 (ref#13035294 - 6/20/13). To hold up a street repair of 250' of asphalt for another 6 months or more because water main repairs just might be needed the same day as repaving seems unfair.

Could you please

follow up with DWP  
concerning the hold to  
see if they will release  
it so that BSS can  
schedule resurfacing or  
let us know who we  
should contact there?
