# **Highlights from 2016**

## **PropertyPanel.LA**

My office released <u>PropertyPanel.LA</u>, the most comprehensive map ever produced of properties owned by the City of Los Angeles, and issued a call for L.A. to appoint a Chief Asset Manager to oversee its extensive portfolio of real estate holdings.

Our goal in releasing the information is to enable the City to capitalize on its real estate holdings, which include police and fire stations, pools and parks—but also a wide-ranging collection of commercial, residential and industrial buildings, as well as vacant land.

### **Domestic Violence has No Place Here**

The audit conducted by my office on the City's domestic violence programs showed

that the City was not doing enough for the victims of this heinous crime—and more investment in resources was one way we could do better.

This year the City adopted many of our recommendations—and increased the number of response teams in the LAPD and significantly increased spending on programs like shelters for the victims of abuse.

#### LAX Interactive Dashboard

Our online LAX data tool "Ready for Takeoff" continues to win awards, including the Outstanding IT Project Award from GovernmentTechnology magazine. With real-time noise level tracking, airplane emissions and flight delay data, and traffic and airport spending charts, Ready for Takeoff is a valuable tool for all Angelenos.

#### Prop O: Good Projects but a Poor Financial Practice

Our <u>audit of Prop O</u>—the 2004 measure that financed stormwater system improvements—revealed that while the City has done a commendable job implementing <u>clean water projects</u>, the City also spent \$6.8 million on unnecessary interest payments over five years on its bonds. Working with the CAO, we issued a letter to change the process on how bonds are issued, saving the taxpayers money long-term.

# Looking Ahead to 2017

#### The Affordable Housing Crisis

A decade ago, the State Legislature created the density bonus program—a zoning tool that permits developers to build more housing units, taller buildings, or more floor space than normally allowed, in exchange for provision of a defined public benefit, such as a specified number or percentage of affordable units included in the development.

As many groups look at how to maximize the use of our density bonus program, my office will be providing useful data to add to this conversation.

#### **Ensuring Safe Rental Housing**

My office is undergoing an audit of the <u>Systematic Code Enforcement Program</u> (<u>SCEP</u>). The purpose of SCEP and the complaint inspection program is to verify compliance with the standards set forth in the applicable building and housing codes. The SCEP and complaint inspection programs aim to maintain the quality of life enjoyed by the residents of the City.

Our audit will assess the effectiveness of the program overall and review both financial and programmatic processes. I look forward to releasing the findings in the coming months.

#### What's at the Zoo?

My office is currently evaluating the governance structure at the L.A. Zoo and the Greater Los Angeles Zoo Association (GLAZA), the nonprofit corporation created to support and fund the Zoo's programs. My team will have recommendations on how to

improve the services and finances of this great City asset.

### **Improving Park Space**

We are continuing our survey of City parks and evaluating the conditions, amenities and overall usefulness to the community. Our goal is to make recommendations that will help guide the Dept. of Recreation and Parks in allocating resources in order to better meet the community's needs. We are in the midst of data gathering and our L.A. parks score card will be ready in early 2017.

## The Controller's Financial Planning Program

75% of adults agree that they could benefit from a financial professional's advice and answers to every day questions. With that in mind, I will continue to host community workshops across the City to empower Angelenos with financial planning tools and resources.

Save the date—the next financial planning workshop will be held on January 25, 2017 from 6-7PM at the North Hollywood Amelia Earhart Library.
