Subject: Street Vending Alert

On Wednesday, January 18, the street vending issue will come before the City Council. It is expected that the actions will be to direct the City Attorney to draft an ordinance decriminalizing street vending and to direct the City Attorney to draft an ordinance setting up the framework for vending that was presented in the letter from Councilmembers Price and Buscaino in late November. This is not a final vote on the issue.

We do not know if they will allow public comment or not, in light of the extensive hearing that was held in December, but we believe it's important that we have a number of people representing our views at that hearing.
