Thank you Darin.

I spoke with the Bureau of Street Services Investigation and Enforcement Division Chief, Gary Harris about this issue. His agency is in charge of investigating and enforcing these violations. He explained that they no longer have employees dedicated solely to illegal posting enforcement. He said that you will need to make your request on the 311 app and then they will delegate other employees to take care of it.

I know that may sound like a roundabout way of getting something done, but I recommend we go through the official channels and then if they don't take action, we have a record of the request in the system and something to follow up on. In addition, the number of requests for a given service on the 311 app is taken into consideration at budget time when they allocate resources.
