After meeting with Mo Gomez yesterday and reflecting on the status of our BLQ-Pico Renewal Petition Drive, I'm compelled to send this email to alert you to my concern that we have not mobilized the resources necessary to mount a successful Petition Drive within the required time frame. I'm sure that both of you will be surprised to hear this message. And I think both of you would be disappointed with me if I saw something and didn't say something.

I believe that Eugene Van Cise at the City Clerk's Office shares my concern.
