Hello board members,

As of an update from Don Duckworth today the "official" count puts us at 39.7%. That excludes the City parcels, which total 2.24% and the LAUSD parcels that total 1.13%. So one could argue we're at 43.07%. $39.7\% + 2.24\% + 1.13\% = 43.07\%$.

The City requires that we have at least 50% which leaves us with a margin of 6.93% to make up for the next two weeks.

So we still have some work to do.
