Lauren,

Apologies for the late response.

Here are the answers to your questions:

1. Business participation in the BID is 100%. This is a requirement set upon by the City of LA.
2. Unfortunately the BID has no control or oversight over the trash disposal services for each specific property. Where we do have authority is the trash pick and removal services in common public access are of the BID. This means the streets and alleyways. We can also serve as an advocate for property owners when it comes to interacting with the City. At this time we are trying to coordinate a meeting with Councilman Gilbert Cedillo in regards to various complaints from property owners regarding the increase trash removal fees.
3. We work with the local chapter of KYCC to address issues with graffiti on the boulevard. Moving forward if you have any issues with graffiti on any of the properties we can have them addressed at little to no cost to you. We can even coordinate between you and KYCC to ensure that they can match the paint of your buildings. The only caveat is that you have a mural on the bakery property which may require some additional coordination.

As for 4. & 5., by all means feel free to consult with your tenants.

4. With regard to the sidewalk pressure washing and other street maintenance you've enumerated, we will consult our tenants if these services have affected their businesses.

5. With regard to the restaurant promotional banners, we will also ask our tenants serving in the food industry if they have availed of this benefit.

Upon inspecting the petition it looks like there was an error in the way the system added the total amounts generated for this specific petition. It appears that the system was tabulating the amounts and percentages for the first petition you received for the properties on 1550 and 1562 W. Pico. and not 1801 and 1807 W. Pico.

The amounts and percentages have been retabulated and a corrected petition has been generated and has been attached.

As for your second question, yes that assessments you pay are bundled into your existing property payments which you make to the city. You will not receive a separate bill for these amounts.
