Thank you for following up. My understanding is that the assessments are based on the total annual budget for the BID, which is currently around \$173K. The percentage share of each property is based on the square footage of that property relative to the total square footage of all the properties in the BID. [Moises/Duck — Please correct me if I am wrong.]

But please keep in mind that this BID is not new, and the applicable assessment already is being charged on your property tax bills. We are just trying to renew the charter for the BID so that it can continue to do the work of keeping the Pico corridor clean. I know first hand that if the BID did not exist, Pico Blvd. would be a much dirtier and trash-ridden place. It is the BID that contracts for the curb cleaning and trash removal. The City does not do this and will not do it if the BID ceases to exist. It is in the vital interest of all property and business owners in the BID area to renew the charter. I sincerely hope that you please sign the form and send it in as soon as possible.
