Ricardo –

They finally changed the curb directly in front of my property to allow for parking. However, they did not do the section just to the north in front of the parking lot, and they did not place any parking restrictions. Currently, a car could park there all week, except for Friday morning street cleaning. I think this is the situation that caused the LAPD to want to restrict parking there. The area should ideally be 2-hour parking or even metered parking. The same should apply to the section in front of the parking area to the north.

I am assuming that the LAPD is no longer involved in the matter, so could you please ask DOT to make these changes as soon as possible.
