Metro informed me last week that the funds that were set aside for the last 2 islands have been de-obligated, contrary to what I was told several months ago. I am looking at alternative funding sources to complete this project and have a couple of leads, including some cost savings we incurred with the first 4 islands as we ended up with more deducts than adds. I will get back to you next week with my findings.


