Ami,

Hello. We met very briefly after you spoke at the WSSM HOA annual meeting on Wed April 10. It was great to hear you speak at our event, and I recall you mentioned in your talk that you would assist with any homeless encampments which are brought to your attention. I approached you afterward, got your card, and let you know I would reach out.

So, here goes...

If you could assist with a couple of, longer standing encampments within ZIP 90064, I would greatly appreciate it as I am sure many in the local community and I hope, the individuals in the encampments as well.

#1 on Sepulveda Blvd. underneath the 10 freeway

Close address is 2738 S Sepulveda, ZIP 90064;

This encampment has morphed over the last year or two, but currently seems anchored by two or three parked vehicles (including one larger RV), and the occupants setting up make shift camps near by. There's often possessions and/or debris on the parkway and sidewalk.

I personally have made a LAHSA request for resources to come on site a couple of times, and I have requested via MyLA311 for a clean up when it seems debris has accumulated. I have seen clean ups performed, and I have seen LAPD on site (perhaps related or not, unclear but I have seen LAPD with cuffed individuals, although not clear if they are long term residents/occupants of the encampment).

In addition the site is potentially involved in stolen bicycles processing (e.g. dismantling for parts). That is to say, I have heard grumblings on NextDoor and other crime related social sites like Ring Neighbors that reported bike thefts may end up at this encampment. And I can report I have observed bike maintenance being performed a couple of times.

Any help you can work on to engage with these individuals and get them housing or other assistance as well as clean up and permanent abandonment of this site would be great.

#2 on Pico Blvd. as it passed under the 405

Close address is 11201 Pico Blvd., ZIP 90064

Near the Smart and Final grocery store parking lot

This encampment is mainly on a patch of grass just east of the 405 overpass, but also seems to include a tent/occupant under the 405 itself. There appear to be multiple individuals here as well, but no vehicles as far as I can tell. There may also be some additional individuals along the embankment of the 405, north from Pico and behind the Smart and Final (not as sure on this...)

Again I have requested LAHSA resources to this site, but have not reported this for cleanup via MyLA311.

This encampment may be 3-6 months old as far as I remember, but again any work you can do to engage with these individuals and get them housing or other assistance as well as clean up and permanent abandonment of this site would be great.
