The same test being tried upon a metal fountain, we found it became useless in one month's time, from the action of the ink, and that the ink was not fit to use.

The first Fountain issued by Mr. Prince was manufactured of metal, and had to be abandoned. Our Fountain Pen now offered to the public is perfect, (and the only one in the world.)
