This letter is in responds to your two Freedom of Information Act (FOIA) requests of 10 November 2018, which was received by this office on 13 November 2018, for the following:

105591 – "I hereby request the document or documents - often called memorandum of understanding (MOU) or memorandum of agreement (MOA) that outline the current relationship between the National Security Agency and "Philips Crypto", and/or "Philips USFA", and/or "NV Philips Gloeilampenfabrieken", and/or Philips. Please include any processing notes made in completing this request."

105594 – "I hereby request the document or documents - often called memorandum of understanding (MOU) or memorandum of agreement (MOA) that outline the current relationship between the National Security Agency and Fox-IT and/or Fox-IT crypto and/or Fox-IT high assurance. Please include any processing notes made in completing this request."

Your requests have been assigned the Case Numbers as noted above. Please refer to these numbers when contacting us about your requests. There are no assessable fees for these requests; therefore, we did not address your fee category.

Your requests has been reviewed by this Agency as required by the FOIA, and is being fully denied in accordance with Executive Order 13526, as set forth in Subparagraphs (e) and (g) of Section 1.4. This request is denied because disclosure could reasonably be expected to cause damage (at minimum) to the national security, per Executive Order 13526, Section 1.2. Any responsive material that may exist would be deemed currently and properly protected; therefore, exempt from disclosure pursuant to the first exemption of the FOIA (5 U.S.C. Section 552(b)(1)).

In addition, this Agency is authorized by various statutes to protect certain information concerning its activities. Accordingly, your request is also denied pursuant to the third exemption of the FOIA, which provides for the withholding of information specifically protected from disclosure by statute. The specific statute applicable in this case is Section 6, Public Law 86-36 (50 U.S. Code 3605). No portion of any responsive material is reasonably segregable.

Please be advised that due to security concerns, this is our standard response to all requests where we reasonably believe acquisition records are being sought on a contract or contract related activity.

You may appeal this decision. If you decide to appeal, you should do so in the manner outlined below. NSA will endeavor to respond within 20 working days of receiving any appeal, absent any unusual circumstances.


