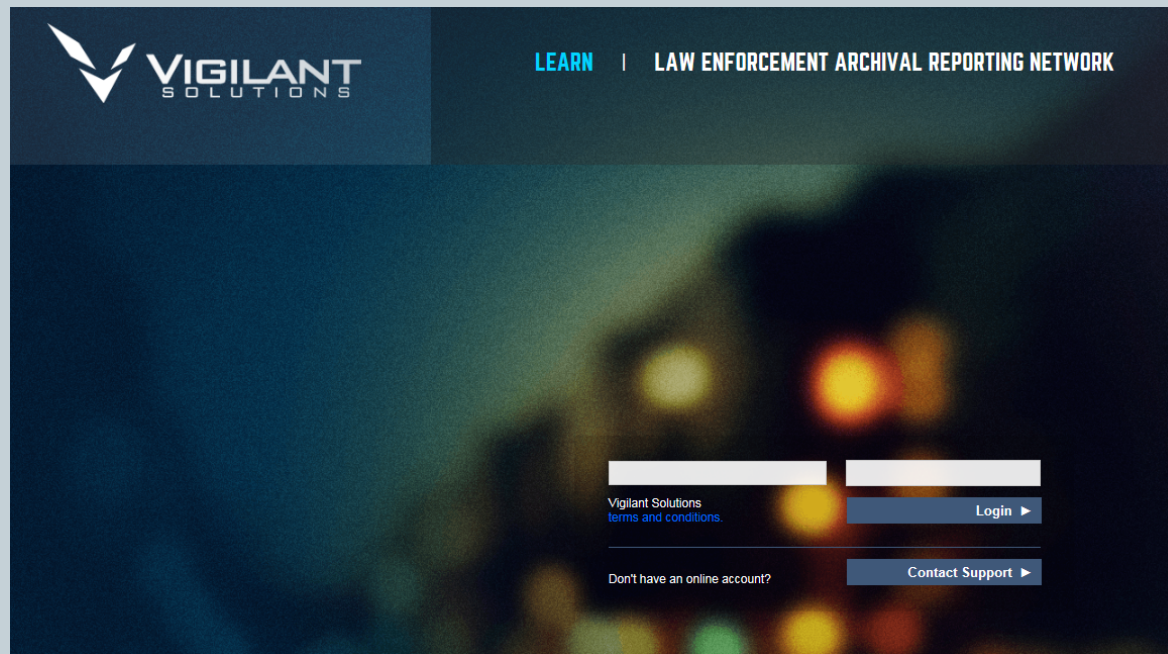

Learn_NVLS (Vigilant)



The Vigilant database will house license plate reads collected by our vehicles (including the mall LPR), and also contains millions of commercial reads collected daily by LPRs hired by insurance companies looking to recover vehicles.



Learn_NVLS (Vigilant)



This training will provide you with a knowledge of how to use the system, and the benefits of it's use. Throughout this PowerPoint, there are 3 short videos that will teach you how to use this program.

This training will take approximately 20 minutes to complete.

Learn_NVLS (Vigilant)



What it's for:

Vigilant/Learn_NVLS can be used for a number of types of cases. If you have already used this resource then you know how valuable it is. It's most common uses will be:

- Locating common areas visited by suspects/leads and,
- Locating Stolen Vehicles

After logging in, click on “My Profile”
to get started.

Set your profile to either get alerts or to make sure you do not get alerts.

(This will depend on how you intend to use this program.)

Receiving too many email notifications? Do the following to make it stop.

It is likely that you will be spending most of your time in “License Plate Query,” to look up license plates.

Using Learn_NVLS (Vigilant) Using this tool



License Plate Query

Start by entering the plate information and date range if needed.

Using this tool



The results will show you pictures of the license plate by date and time, allow you to map the LPR reads, and also create reports.

You can also use “wildcards” if you have been given a partial plate.

Other valuable tools are the
“Locate Analysis” and the
“Stakeout” functions.

Using Learn_NVLS (Vigilant)

Using this tool



The “Locate Analysis” function is like “License Plate Query”, but it also groups all of the LPR reads for a specific plate into specific locations. It is most important when looking to find likely hangouts or residences of suspects/IL’s.

Using this tool



The “Stakeout” function is largely important when the location is more important than a specific license plate. This might be necessary when trying to find what plates were located in an area when a crime was committed.
