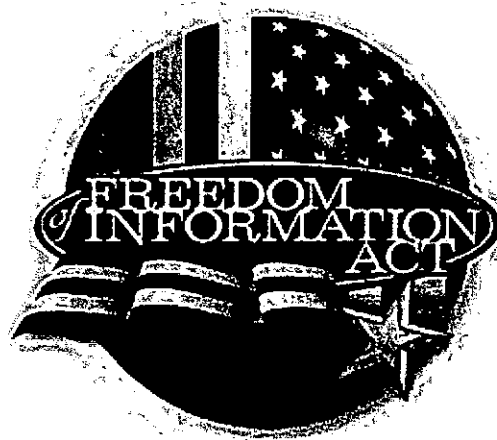

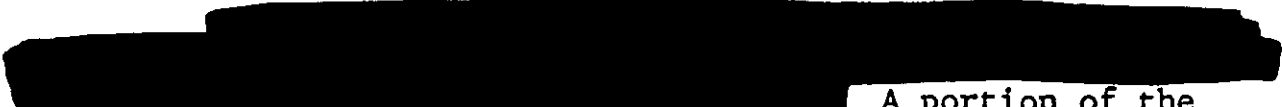

A portion of the conversation thereon pertained to captioned matter and that portion is set forth below:

Howard Miller:

You know the IRS doesn't audit on honest people, there's no reason....

Abbie Hoffman:

They a, they a think that that's how they're going to get us, a you know through the use of the IRS, but a I would say in terms of not charging money for speeches a for books, a, and the trial here in Chicago and the appeal costs something like \$400,000 and a as I say, the profits from this book go a to the radio station WPAX, which broadcasts antiwar news to servicemen and servicewomen and a, a profits from other books went to committee to defend the panthers, went to other trials, went for bail money and a, I just think you know a, that a

school administrations, rich school administrations, a, television shows, you know, publishers, can afford to pay for a, myself, Anita and brothers and sisters who get ripped off and put in jail.

Howard Miller:

Okay, thank you for your call sir. Number seven, you're on "Chiago".

Hello.

Yes.

I would like to know, ask Abbie where did he get, where did he actually do his research for his book? Was it just on the basis of street knowledge or ....

Anita Hoffman:

A lot of people did research for it. About at least six different people have a, and specialist like a, the people who do, did the a telephone stuff for engineers and uhm, all of us have been....

Abbie Hoffman:

Television people yes.

Howard Miller:

These are people who have contributed their knowledge to you so yours is a compilation of all their knowledge.

Anita Hoffman:

Yeah.

Abbie Hoffman:

Yeah, they get a cut, they get a cut to the book too, but a, a for example there's a section on

You keep elaborating that expression survival, survival from what?

Abbie Hoffman:

Well, ah, your going to live a, outside the system, you have....

Howard Miller:

Outside the law?

Abbie Hoffman:

Yeah, you have to devise certain methods of putting food in your mouth, living on land, etc., etc, so that involves a certain system; although, some of the methods are legal, some are illegal, you know I don't make the distinction. Neither me nor the Chicago Police Department get hung up in those technicalities that I'm saying Howard.

Howard Miller:

We're going to be back now in just a moment on "Chicago".

Howard Miller:

Abbie and Anita will you tell me about WPAX; now this is a radio syndicated format that you sent to troop overseas, a, WPAX call letters that you just made up. Now what stations broadcast ah, those syndicated programs that you're making.

Abbie Hoffman:

Well, uhm, first of all its mainly news and music that the Armed Forces network won't broadcast for its own peculiar reasons and, a, we have a studio in New York we send a tape-- We offered the tapes to the Armed Forces network, South Vietnam, loads of governments, ah, North Vietnamese will play it on radio Hanoi.

Howard Miller:

So, in other words you're doing almost the same as Tokyo Rose did to our troops during World War II, basically I think.

Anita Hoffman:

We're not advocating desertion or uhm assassinate your officers or anything like that, it's really just a, supplemental news which they don't get, uhm....

Howard Miller:

Like what?

Anita Hoffman:

Uhm, well, like news about uhm May Day, about veterans against the war, the hearings....

Howard Miller:

Have any of these tapes ever been a looked at by the Justice Department to see whether or not you a work....

Anita Hoffman:

They probably will be. (laughing)

Abbie Hoffman:

They watch us make love, not make tapes. (laughing)

Howard Miller:

Has this not started? Have these tapes started already, the flow to the North Vietnamese?

Abbie Hoffman:

Well, they have, we sent about 40, 50 hours already, a and a, a as far as we know it hasn't gone on the air yet but we expect it any day for them to start on the air.

Howard Miller:

Are you using the U.S. Mails to get it over there and how does, how do you process it then into North Vietnamese language?

Abbie Hoffman:

We use our own air force.

Howard Miller:

Seriously, how do you get it over there?

Abbie Hoffman:

We can't say, unfortunately Howard the Central Committee will not allow me to divulge that information

Howard Miller:

But you are making tapes weekly to send over there and their being broadcast on North Vietnamese radio.

Abbie Hoffman:

We're not the only ones. There's a group here in Chicago, radio free people, which makes some excellent tapes. There's groups all around the country that make, John Lennon and Yoko Ono made an original half hour tape that's being played. Uhm, but there is a new communication gap, for example, soldiers in the Mecong Delta (PH) wrote us and

What sort of message do you try  
to get to our troops overseas,  
Abbie? What do you feel is necessary  
for them to know?

Anita Hoffman:

I think they just have to know  
really the truth of what's happening  
there, like....

As you see the truth?'

Anita Hoffman:

No, well like I'm pregnant, so  
this is like an item that's  
specifically, really upsets me  
that a, there are areas of South  
Vietnam which were....

You mean that they don't know  
your pregnant?

No. There's areas of South  
Vietnam where a, the heaviest  
bombings occurred where 60  
percent of the babies, 60 percent

women are giving birth to are

Anita Hoffman:

I, I just know that if they, between their second and seventh week if they drink a liter of water a day, chances are nine out of ten that their babies will be deformed. And you don't, you don't hear about that much here but like I, I should think that that would be....

Howard Miller:

Well I don't think that in the history of man, it's ever been heard that a dynamite bomb has a fallout Anita.

Abbie Hoffman:

(simultaneous with Anita)

Abbie Hoffman:

When you're having this intense bombing, like (simultaneous with Anita).. nobody, no country has ever had this intense, the intensive bombing that's going on Vietnam.

Anita Hoffman:

It comes to about two Hiroshimas every ten days, the equivalent of....

Abbie Hoffman:

It does do things to the atmosphere and to the land itself that are irreparable and do a....

Howard Miller:

Let's go to the phones now and number one your on "Chicago" with the Hoffmans.

Abbie Hoffman:

But a, I might just say something about the broadcast Howard....

Howard Miller:

Wait just one moment, please.

Abbie Hoffman:

We might, we might for example read "Newsweek's" account of the May Day arrest in toto, a you know and we play a lot of rock music and soul music a, that's not played....

INTERVIEW WITH ABBIE HOFFMAN

ABBIE HOFFMAN is alive and well, alternately by radiating sweet wiseguy goofy Jewish bright kid vibes and being pissed off at a system which is trying, he says, to suppress him and his latest book, rather provocatively titled "STEAL THIS BOOK," published by PIRATE EDITIONS and distributed by GROVE PRESS. By the way, according to the overleaf of the title page, Pirate Editions, at 640 Broadway, New York, N.Y. 10012 says that they are interested in helping revolutionary and radical writers publish their books.

I went to see and interview Abbie well equipped with biggie cans of Miller's and butter flavored pretzels. The great man of the new American Revolution did not exactly refuse to be interviewed otherwise, but he did allow that the cans of Miller's would be highly welcome. So there you are, your unfaithful reporter, Abbie, his nose swollen and pudgy and

taped up and he can't breathe through it, and his lady Anita notorious aut horess, seven months pregnant, they are going to call the kid America, they have an apartment which is simply beautiful which they built themselves on the roof of a factory building not far from Union Square, they call each other Babe and seem very much in love after being together four or five years, they took each into a union you can call marriage if you wish at a ceremony in Central Park, how about that? Their place is full, I mean full of plants, flowers, growing things, a long row of spice jars marches down a shelf on the side of I guess the living room, aren't all rooms in an apartment living rooms? They have several pictures by Martin Carey, a fantastic artist Abbie went to school with long, long ago, many books, magazines, papers, Abbie waves a sheaf of Xerox copies of unbelievable but true sinister thought control

letters from some of the most respected liberal media REFUSING ads for STEAL THIS BOOK.

"They are trying to suppress it," he says, and you can see the hurt in his voice. "Thirty publishers turned the book down"...even though hundreds of thousands of copies of his previous books were sold, Revolution for the Hell of It, 800,000 (figures Abbie), Woodstock Nation 200,000 and now going into a new special paperback edition. They still all turned out his book and Abbie had to publish it himself. One publishing house said "It wasn't radical enough." Another one complained that "it lacked literary merit." "I was offered \$40,000 by one publisher if I would only take out three chapters and change the title of the book." He shows me the letters from the great liberals and the great underground stations, the New York Times, the Los Angeles Times, WCBS-FM, all refusing for one reason or another to accept ads. The radio stations gave as an excuse un-named FCC regulations. He shows me the copy for the radio commercial, a completely inoffensive little skit that any station would accept were the product a new brand of tomato juice.

Is our hero discouraged? Not on your revolutionary bippy he ain't, even though 5,000 copies of his book were just seized on the Canadian border. 80,000 copies of STEAL THIS BOOK have been sold already and Abbie is already working on STEAL THIS BOOK No. 2. With the con mpt that it deserves he silently dismisses my suggestion that he call it SON OF STEAL THIS BOOK. Instead, taking a long and healthy pull on the beer he tells how he destroyed the copyright by writing all the "underground" papers in the country and telling them to

reprint part or all of STEAL THIS BOOK and give it away or sell it and put the money into some RIGHT ON CAUSE.

The phone rings every so often, Anita is shelling green peas, they share the housework though and Abbie is obviously very conscious of past male-chauvinist sins and very active overcoming them in his own life. But in a nice real way, no big fanatical preaching way like some people I could mention. But won't, followed by a big sigh of collective relief from anybody reading this guff. The phones ring, Abbie stretches on the couch, his back is in constant pain, he has slipped a disk as well as the broken nose as souvenirs of a recent visit to the Nation's Capital, but although he groans once in a while he isn't letting it all get him down, not even the pain of being interviewed again, he is warm, very often funny, full of a high level of the kind of magnetic aliveness that Chico Marx shines with in nearly all the brothers' glorious movies. Maybe that's why he was offered the role of Lenny Bruce in the Broadway Play. "I didn't take it because I couldn't see myself saying the same lines night after night for ninety days," says Abbie, "but I'll be happy to do a film on Lenny. I hope they offer me the part."

Ask him about his indictment, yelled Allen Katzman, as I left the EVO offices to interview Abbie, so I asked him about the indictment.

"I was indicted under section 2101 of the U.S. code Vol. 18 under a civil rights law authored by that great fighter for individual rights Strom Thurmond," says Abbie. "I gave this speech in Okalahoma in which I said three things for

which they indicted me. I said we are going to Washington to stop the government and the war, I plugged Jerry Rubin's book "DO IT," and I said we are going to make Chicago look like a YAF convention in comparison with what we are going to do in Washington. So anyway they indicted me under Thurmond's law, which is a very metaphysical law. It's the only law ever passed which makes it a crime to cross state lines with the intention to incite a riot. In other words with a state of mind. So I don't even KNOW whether I'm guilty or not." He is beginning to get up, but not in a vicious way, he just is facing an unpleasant fact which he doesn't like. "The government wants to put us away. We speak on campuses, we are doing everything we can to weaken the power of the Phillistines in Washington. I guess I am guilty of everything, the D.C. demonstrations, the bombing of the Capitol, the Los Angeles earthquake... actually, I break the law every time I speak. Everyone who believes in civil liberties should expand the frontiers of free speech every time they speak, everything else is just masturbation. I have got a list of twenty laws I'm working on. Every time I speak I break about five and tickle another ten." What about the indictment? But Abbie wants to talk about his arrests and the FBI first.

"I've been arrested four or five times, and let me tell you, the FBI used to be really nice to be arrested by, they were gentle, they would give you your rights... but here there has been a big change in the FBI recently, the last few months, they are pissed 'cause they can't get the

Weather people, they are offering \$100,000 reward for information leading to the arrest of the Capitol bombers, they are mad that nobody is snitching. On his 88th birthday J. Edgar finally flipped his lid. So of late the FBI has been involved in illegal raids on communes, beatings and intimidations of people...do you know, most people don't know that a week before Mayday, my phone, Dave Dellinger's phone and the phone of the Mayday Collective in Washington were all cut off! These FBI terror tactics are all part of the Justice Department's vendetta. Why, the Attorney General now even suggests that we got money from foreign, ugh, Communist, ugh, ugh, countries. Hal! Abbie was also indicted for interfering with a police officer, a felony in Washington.

"The way I interfered with that police officer," says Abbie, "was by running away, getting tackled and getting a broken

nose, a slipped disk in my back and a lot of stitches. I was caught in the Georgetown part of Washington and I was beat up by this one really sadistic cop. Most cops in Washington on Mayday were relatively restrained, I just wound up with this really sadistic one, he asks me, aren't these your shades, then he stomped on them, he gave my gas mask away to somebody, then he beat me up. So after I got patched up by Dr. Spock at RFK stadium I got smuggled out in a garbage can, just like on Hogan's Heroes...I split since I wasn't really arrested, right, so I figured what am I doing here. I was arrested here in New York a few days ago. First they charged me with assaulting a police officer but when they saw what shape I was in they changed the charge."

Now it was time to split, Abbie was on his way to a clinic for a doctor to look at his nose. He can't breathe through it, he is all taped up on account of his slipped disk and in constant pain, but his spirits seem as high as ever. The global revolution seems to buoy him up, he switches from serio-comic to groans like comedy asides, to hugs with Anita to proposed laws like Presidents shouldn't be allowed to wear make-up on television. As the actress said to the bishop, we haven't seen the last of you yet.





Abbott H. Hoffman

On February 18, 1970, Jerry Rubin and David Dellinger were found guilty in the United States District Court, Northern District of Illinois, Chicago, Illinois for violating the Federal Anti-Riot Law Statute for traveling in interstate commerce from outside the State of Illinois with intent to incite riots in Chicago, Illinois, during the Democratic National Convention in August, 1968. On February 20, 1970, they were sentenced to five years imprisonment and fined \$5,000. On February 20, 1970, the United States Court of Appeals, Seventh Circuit, Chicago, Illinois ordered them released on \$25,000 bond pending appeal of their conviction.

This report is predicated upon the participation by ABBOTT HOWARD HOFFMAN in the May Day activities on May 3, 1971, in Washington, D.C., his alleged arrest by the Metropolitan Police Department (MPD), at the intersection of Wisconsin Avenue and "R" Street, N.W., Washington, D.C., as a result of that participation, and an alleged assault on an MPD officer, LARRY W. SAPPINGTON, at the named intersection. Subject previously made a speech at the University of Oklahoma (OU), Norman, Oklahoma, on 4/29/71, in which he is said to have invited OU students to join two weeks of protest in Washington, D.C.

With regard to the information set forth below, it is noted that same is presented in a logical rather than a chronological order. Thus interviews concerning certain aspects will be grouped by aspect rather than by the dates on which they were conducted.

[REDACTED] which covered an interview of ABBIE HOFFMAN by the news media in Oklahoma City.

The only audio portion of this recording which was retained [REDACTED] and which records comments made by HOFFMAN on that occasion, reads as follows:

"I should also mention that the next two weeks will probably gonna be the most decisive two weeks in the in the history of the war in Vietnam and in the antiwar movement here in this country. Throughout the next two week period, you will begin to see a rebellion taking place among our units in Vietnam. We'll be on the radio from Radio Hanoi, a radio station called WPAX, advocating support for the May Day activities in Washington, and urging troops, armed servicemen and servicewomen, to join with us. There's been increased military activity on the part of the Freedom Forces and the Vietnamese people equal only to the Tet offensive.

"In Washington, all the attention will be focused this weekend when we plan to have over 100,000 people participating in a celebration of the People's Peace Treaty in a 48-hour rock concert and then on Monday at dawn, if the Government refuses to ratify this People's Peace Treaty that's been signed by hundreds of thousands of people both here and in Vietnam; at dawn, we will march into Washington, into the offices that are responsible for this illegal and immoral war, and begin the process of closing down this Government, that refuses to close down the war. We have pledges from over 50,000 people now committed to civil disobedience or civil disruption and planning on being arrested or on submitting themselves to an arrest situation."

On the morning of April 29, 1971, ABBIE HOFFMAN made a surprise visit to the University of Oklahoma (OU) campus, Norman, Oklahoma, where he spoke to several hundred students.

[REDACTED] article entitled, "HOFFMAN Talks at OU, Too," which appeared in the April 29, 1971, evening edition of the "Oklahoma City Times" and reflects in part as follows:

"Radical Yippie leader Abbie Hoffman drew orderly applause and solicited student help in a government-crippling series of May demonstrations this morning, in a surprise University of Oklahoma visit. . .

"Hoffman, who is free on bond while appealing a conviction of incitement to riot in the 1968 Chicago violence, invited OU students to join two weeks of protests beginning Saturday in Washington, D. C.

"He (Hoffman) said the activities 'will make Chicago in 1968 look like YAF (the conservative Young Americans for Freedom) meeting. We plan to do it and we plan to do it in the streets when the government opens next Monday'.

"Hoffman drew final, standing applause when he concluded his talk with another reference to the May demonstrations" "We're into stopping the government - unless they want to stop the war. They've got about 47 hours'."

[REDACTED] HOFFMAN, in his speech at OU, April 29, 1971, was generally critical of the Vietnam war and he encouraged OU students to go to Washington, D. C., to participate in the May demonstrations. [REDACTED] HOFFMAN's

The following is a transcription of a tape recording of a speech made by ABBIE HOFFMAN at the University of Oklahoma, Norman, Oklahoma, on April 29, 1971:

An unidentified speaker made the following introductory comments:

"The following tape recording is that of the address made by ABBIE HOFFMAN at the University of Oklahoma on Thursday, the 29th of April, 1971. The first thirty seconds of his comments were not recorded. They consisted primarily of a negation by HOFFMAN of the invitation to speak from the speaker's stand. He preferred to address the crowd standing in the orchestra pit."

HOFFMAN's comments are as follows:

"We are finally going to be (illegible). . . There're already thousands of young people in Washington. This Saturday and Sunday will be a 48-hour rock concert, there are over thirty rock groups, ARLO GUTHRIE, PETER, PAUL and MARY, MOTHER EARTH, ARETHA FRANKLIN and loads of people. JAMES BROWN just announced two days ago that he was going to go there and play and there should be somewhere upwards of 100,000 people supporting and celebrating the People's Peace Treaty that's been signed by people throughout this country and throughout Vietnam, and indeed in fact throughout the world, because people throughout the world see the war in Vietnam and U. S. imperialism as a world problem. They recognize that they, too, live in a global village and there are people from at least ten different countries to form youth international brigades that plan to march this weekend in Washington.

"On Monday, when the Government opens at dawn, well, I think it's about 9 to 5 they work down there. Early birds get the worm, so we'll be up early."

We'll march out from the Washington Monument, the phallus on the Potomac, and we'll go into the streets of Washington and into the offices and we plan to do it and we plan to do it in the streets and we hope the people will come. We expect it to be the most largest, the most militant demonstration. It's gonna make Chicago in August of 1969 look like a YAF meeting. So there are over 300 groups from around the country that have been working out with automobiles and buses that are gonna self-destruct in the street.

"We'll visit J. EDGAR HOOVER and take a lot of good pictures of him. Yesterday, as you probably know, they arrested one of the key organizers of the May Day Demonstrations, LESLIE DAGON, nineteen years old, in connection with the Capitol bombing. LESLIE was definitely not in the men's room in the Capitol on that day, but somehow, the FBI, you know, has managed to connect her in some way, but we think it's a direct attempt to cripple these demonstrations. It's no coincidence that it comes four days before the climax of these demonstrations and it's no coincidence that she has been an active organizer and we have heard that the FBI plans to arrest a number of people. They have been kicking in doors, they have been putting guns under the chins of people, they have been offering loads of rewards to people to turn in their brothers and sisters, not the kind of stuff you see EFREM ZIBALIST carrying out every Sunday night (illegible). (Voice from background: 'Tell us something we don't know already.') I ain't got nothing you don't know. (illegible) What are you here for? (illegible)

"There are number of - there are things we can do. First of all, we have to begin to understand that the Vietnamization program is just a racist policy of seeing to it that non-white people, ten to one, die instead of white people and we have got to guard against that and we are gonna say that,

you know, we just don't want to see this war brought to a speedy conclusion, you know, and the troops home. We want to see a government in Southeast Asia, in Vietnam, that is representative of the needs of the people and that contributes to the welfare and the general well being of the people in that entire area. That is what we want to see and we have to fight for that. We have to fight against the Vietnamization program. We have to be careful not to fall into the trap of, you know, seeing Lieutenant CALLEY or My Lai, you know, or people pick up somebody's head and cut it off, you know, and responding to that without failing to respond to the saturation bombings, free fire zones and these general policies of institutional genocide that are set in Washington that have contributed to the defamation of eighteen per cent of the arable land in Vietnam, that have turned it from an exporter of rice into an importer of rice, you see, that have totally and barbarically, you know, defoliated the land and tried to kill all the people. They realize that they can't defeat the Viet Cong or the Pathet Lao or the Cambodians or the North Vietnamese or any of those heroic people militarily, so they can't defeat the fish that swim in the sea, so they attempt to drain the sea. And we have to understand that the people who are responsible for that kind of institutional violence are gonna be the people that are gonna have to be the defendants in the war crimes of the future. And it's not gonna be Lieutenant CALLEY, he is the scapegoat, his hands are in blood, you know, but you shoot somebody point blank, you know, it is some existential thing you have to think about it and you have to confront it. But in Vietnam, the latest tactic is planting a radio detective, they drop them from planes and they pick up sounds of life within a half-mile or mile radius, water buffalo, child crying, Viet Cong, makes no distinction, and radios this information to an airplane 50,000 feet high in the sky, which immediately cables this information to a computer in the Seventh Fleet off the China Coast and buttons are all pushed, you know, none touched by human hands, and the

bombing, total bombing saturation for a two-mile radius in the countryside of Vietnam within ten minutes and the whole war is automated and we have to put ourselves in the positions of our brothers and sisters who are Vietnam people and if we truly believe in a global village, they are our brothers and sisters, and they walk out of a hut in their simple village and they look up and all they see, all they see with technology is death.

"We were in Paris just three weeks ago talking with the Vietnamese and we wanted to use the tape recorder and one of the people had, one of the sisters had a camera, you know, and all of a sudden you could see the people getting a little edgy and then they ran it down to us. They said in North Vietnam they had six tape recorders. Everything we see about technology, every time somebody puts in a plug; every time somebody uses the word 'electricity,' every time somebody talks of media, every time (illegible) the people are talking of death, you know, and that's the unfortunate part about this war, that it's shown that great technology, you know, as well as serving people can be used to exterminate people and this country has perfected it, you know, and taken it one step beyond the Nazis, because we don't even respond to it. A million people killed and people say, 'Well, bombing's part of war, that's the way it goes, you know,' and they learn that they can revise the movies, you know, and not stick people in ovens and concentration camps, that's bad P.R., you know, fortunately the Nazis didn't have Madison Avenue to use terms like protective reactive strike and saturation bombing and things like that.

"And you look at MELVIN LAIRD, you look at General MITCHELL, you look at President AGNEW, and you look at these people and you say they're reasonable, they're rational, they're responsible people, you know. They're not violent, they're not crazy, you know, like the hippies and Yippies and

blacks and Indians and everything. But we have got to wash those myths out of our minds and begin to see those so-called reasonable, responsible, rational people that run the banks, that run this university, that run the Government, and you look around and you know, you've seen one Board of Trustees, you've seen them all.

"So we hope you come to Washington and if you don't, we hope you'll sign the People's Peace Treaty and declare peace and live it, and start to build a new society, a new nation, you know, that rejects the values and the institutions, the competition and the greed and the brutality of a decadent racist empire whose days have come, and like the dinosaurs of old, the Philistines in Washington, we go down there, we'll be joyously dancing on their graves, because we know their days have come. We know we can whip them in court rooms, we can whip them in the street and whip them right in their own office buildings, right in their own nests, and I hope you can swipe a plane or something and come on down. If you can't make it, you might come out on May 5, you know, and go on strike in this nursery school, you know, and join the nationwide student strike on May fifth, you know. But all the dates, the dates are just high points in a, in an organizer's trip. I mean we have got to begin to live the revolution in our daily lives and begin to have, you know, get our minds straight so we walk down the street, every place we go, we see an issue, every place we go, we see pigs, you know, and then we begin to think right.

"We're, we got some bread from last night's rappin' and goes to a radio station that we started called WFAX, a group of us in New York; and we noticed for a long time there's been a tremendous communication gap in the information broadcast by the Voice of America and the Armed Forces Network and we prepared these tapes - radio shows, and we send them to governments and stations around the world that will play them two hours a day for servicemen and servicewomen overseas; and we think that if we are gonna affect U. S. foreign policy, we've got to reach the people in the front lines that are carryin' it out and any day now before

May first, we will come boomin' out of North Vietnam and certain liberated stations in the south and JIMMIE HENDRIX sings the Star Spangled Banner and a new nation is on the air, live, and it's gonna be cool and if there's a group of radio freaks here that want to get together and work on a tape, you know, come up and I'll tell you where to send the tapes. Tapes come from all over the country, from people's groups, JOHN LENNON, YOKO ONO, did original tape, just sent it to us last week, good raps like that. Stuff goin' on, you know, that they won't play. The communication gap is somethin' fierce. We learned from GIs in the Mekong Delta, for example, wasn't til four weeks after the invasion of Laos occurred that they were even informed that such an invasion was occurin'. You know, just total censorship. We have one show of lawyers giving legal advise, you know, every week to GIs who write in to our post office box, WPAX, Post Office Box 410, New York, New York, Zip Code 1003, 0 0, couple zeros. So if you're into helpin' us out with tapes, things like that, you know, might dig it. I'll take a couple answers - questions (illegible). You've got a point."

(Unidentified voice from audience: "I want to ask you some questions. (illegible). When are you gonna write another book?")

"Well, I did write one, cause they're all sellin' like hot cakes, you know, and all these publishers were diggin' me. I sat down after the trial and tried to write a book that nobody would publish, and it took me about eight months, and I did it. It's a romantic love ballad called "Fearless F--- (obscene)." Says it right on the cover, you ain't referrin' to the last one, had on the back. See, yeah, see, I did the one had on the back, you know, when I was in jail cause at Random House, you know, they were gettin' all these letters so they took it off, you know, and I went up and I - you know - p--- (obscene) on BENNETT CERF's desk. (illegible). So then they put it back.

You know, there've been eight printings of that book. (illegible) And if you look at it, you'll see every art edition has "Fearless F--- (cbscene)" on the back and every evening edition has not, and you can just like trace my steps, you know, running up to Random House and so I figured it was doing so good I'd put it on the cover and thirty publishers rejected the book, and you know, they just couldn't believe it. You know, they just couldn't believe that I would write a book that they wouldn't publish, you know, and it was no mean feat, you know. People said things like, 'this book will end free speech,' you know, and stuff like that. But I published it myself. Most book stores in the country won't carry it, (illegible) Nobody will accept that. It's how to rip off everything in the country. It's how to live and survive as outlaws and there's lots of neat, you know, ways, how to forge credit cards, counterfeit money, got good stuff in it, you know."

(Unidentified voice from audience: "Is there an excerpt from that in 'Ramparts'?")

"Yeah. There was a hunk of it."

(Unidentified voice from audience: "What do you do with the bread from your books?")

"Well - which book, 'Revolution (illegible)?' I got 25 grand, was five times the most I ever had in my life, I ever accumulated in one spot and I turned over (illegible) committee to defend the Panthers for bail, for one of the Panthers (illegible). Guilt money. I'm not so sure (illegible) I should be giving the money for bail, you know, but most of the money, unfortunately, goes to keep us out of prison. The trial in Chicago cost like \$320,000, you know. Twice as much as the movies. But in fact, the Government has its forces totally mobilized. They know we don't keep the money in Swiss banks, see, and that's why, for example, all the money that

we gave to the Chicago Conspiracy Trial, you know, from like we used to go around and give speeches, that's how we raised the money, and we gave the money to the Chicago Conspiracy Trial and now, the IRS claims that we can't do that and they charge us personal income tax, \$110,000 for the whole trial, so, like the IRS - I mean the FBI, I mean, they ain't into nothin'. I mean, EFREM ZIMBALIST is their best Agent. Let's face it, you know. And the IRS, they got their s--- (obscene) together and Army Intelligence (illegible) you know, they don't understand the whole thing that's going on. I mean. They can't catch Weathermen and Weatherwomen, you know, they all look alike, they all (illegible) clap, they all got halitosis, they (illegible) take baths, all f--- (obscene) in the same room, the music's too loud, et cetera, et cetera. Cultural revolution is, you build cultural revolution so the fish that live as outlaws and revolutionaries can swim in this hairy sea and then they can't find them. It's always done that way. There's no other kind of revolution except cultural revolution."

(Unidentified voice from audience: "Do you have anything more to say about EUD WILKINSON since you did last night?")

"I don't know. Is he around here? This is the place that put him on the map. Yeah. He's a monument. A living monument to America's past. Yeah. Well, I don't know. (illegible) He's okay. What can you say? It's not about individuals, you know. It's about, well - (illegible)."

(Unidentified voice from audience: "Who's the Presidential candidate?")

"Actually, the question about bread is really the only valid question even asked. What did you say?"

"I don't know, but we plan to go to the Republican Convention in '72. We've been formally invited. We hear they are gonna hold it in Norman, though. It's the only safe place. The only Republicans left live here."

(Unidentified voice from audience: "Who are you radicalizing that isn't already radicalized? Who are you reaching that needs to be reached?")

"I got a, I got a neat letter, I got a letter from an eleven-year-old kid who wants to talk to my (illegible) at school. What?"

(Unidentified voice from audience: "Who's gonna listen to you that isn't already in to what you say?")

"I don't know. I don't particularly care."

(Unidentified voice from audience: (question illegible))

"It keeps me busy and it's a lot. Before I decided to overthrow the Government, I was assistant sales director, a salesman, you know, with a white picket fence and a house and a lawn mower you know, in suburbia, with two life insurance policies. I didn't find it a very rewarding life, so I, you know, bigged out and went to Mississippi and learned things that I didn't learn at school, so, yeah, I think it's a good life. Yeah. We aim to turn our six or seven year old kids, because by the time they get your age and get into college, you know, they are already brainwashed too much. Because in college, you learn things that nothing can - you can't do nothing, (illegible) the f--- (obscene) up. (illegible). Well, that's groovy. Lots of people are cynical in college. It makes you that way."

(Unidentified voice from audience: "I'm not cynical. I just want to know what you're doing that needs to be done. You're sitting here talking to a bunch of people who agree with you.")

"I'll tell you something. Someone called me up at two a.m. in the morning last night and he didn't agree at all. In fact, we had to move pretty quick. I'll tell you, that would be weird you know, cause people in Oklahoma agreed. (Illegible), but it's possible, I mean, there are things that I don't understand. Seventy-five per cent of the people now favor immediate withdrawal from Vietnam in the country, according to the polls, and yet the Government doesn't move. Well, you know, I'm saying that, you know, it has to go beyond this, you know, petty little dialogue here, the people have to begin to move. That they can't learn any of the things that I wrote about in that book, about swiping, about living as an outlaw, about creating radical change in this country unless they do it. The only way you know what a pear tastes like is take a bite, that MAO's famous rock group from the East. And revolution is the same way. If you want to know about it, you have to get in and work with the struggle, to work with the contradictions, you know, and fight and you can do it right, you can do it here in Oklahoma. JULIUS ROFFMAN is the judge down the street. Every political trial at Chicago takes place every day here. Because all trials are political. It just takes a lawyer with certain kind of vision, you know, to see it as a political trial and it takes certain kinds of people who identify and recognize that all trials are political, you know, and that the institutions of the courts are not there for justice, but are there to protect the power and property of people who already have it, and you start looking around like that and (illegible) all the early misfits, you know, we were taught in schools, we can start to struggle, you know, we got to do it. (Illegible question asked in audience.) Huh? I've got the flu, so,

gonna bug out, but I hope if there is anybody here with the treaty, I hope they pass it around and people get into signing it, you know, and bring it to Washington. I hope some people get a chance to come."

"We ain't marchin'. We ain't marchin'. I mean, we're not gonna march. That was last week. That was a TROTSKYite fund-raising rally. We are not into that. We're into trying to stop the functioning of the government. Unless, of course, they want to stop the war. They've got about 47 hours."

Count number one charges that HOFFMAN on or about April 29, 1971, traveled in interstate commerce from outside the District of Columbia (D.C.) with intent to organize, promote, encourage, participate in and carry on a riot. Further that on May 3, 1971, in the vicinity of Wisconsin Avenue and R Street, N.W., Washington, D.C., he participated in a riot in that he, as part of an assemblage of more than three persons, erected a barricade in a public thorough fare, for the purpose of organizing, promoting, encouraging, participating in and carrying on a riot in violation of Title 18, United States Code, Section 2101.

Count number two charges that on May 5, 1971, within D.C., the subject did commit and attempted to commit an act to obstruct, impede and interfere with a law enforcement officer, LARRY W. SAPPINGTON, Metropolitan Police Department (MPD), Washington, D.C., who was then lawfully engaged in the lawful performance of his official duties incident to and during the commission of a civil disorder, which disorder obstructed, delayed and adversely affected commerce and the movement of articles and commodities in commerce, and the conduct and performance of a federally protected function in violation of Title 18, United States Code, Section 231 (a) (3).

[REDACTED] advised that he was working in his position as [REDACTED] on May 3, 1971, between the hours of 8:00 a.m. to 4:00 p.m., and that at least on one occasion during that day, he entered the lock up cell located withing the Emergency Ward of the hospital.

During this visit to the lock up cell, the interviewee noticed an individual who was either being treated or who was awaiting same, and recognized this person to be one ABBIE HOFFMAN. [REDACTED] said that there was no doubt in his mind that this person in the cell was the subject HOFFMAN, since he had seen photos of subject in the past both on television and in the newspaper. [REDACTED] feelings were so strong about his identifica-tion of subject that he approached the latter and asked the man if he was ABBIE HOFFMAN. To this query, subject responded, "Please don't say anything," or words to that effect. [REDACTED] said he assumed subject did not want to be recognized and thus bothered by a lot of people and thereafter, left the room, having no further verbal contact with subject.

Interviewee thereafter, was told by other persons who were in the ward for treatment that the man with whom he had spoken was HOFFMAN.

Within a very short time, he noticed that this individual was being pursued by a police officer on foot across a parking lot which adjoins the Japan Inn construction site located at 1715 Wisconsin Avenue. The police officer had hastily dismounted his scooter, chased the individual in question, and tackled the latter on the east side of the lot. At this point, [REDACTED] lost track of the incident and could furnish no further information.

# Senate approves May 4 memorial

By Jack Corliss

Student Senate last night announced its support for the proposals for the 90-minute memorial service on May 4, which had undergone revision earlier in the day.

The report of the May 4 Memorial Service Committee, a sub-committee of the May 1-4 Recognition Committee and chaired by Dr. Robert Dyal, was presented to Student Senate by Paul Hagemann, a member of the committee.

The report dealt primarily with the program for a memorial service to be held on May 4 from 11 a.m. to 12:30 p.m. The theme for the service is "A Call to Reconciliation and Peaceful Change."

The proposals announced last Thursday provide a roster of speakers to include Judy Collins, the Rev. Dr. Jesse Jackson, Pete Seeger and Eugene McCarthy.

The May Day Coalition Committee had previously announced its support for the Dyal sub-committee's program at a meeting last Thursday.

However, earlier yesterday, in a meeting with Dr. Richard Bredemeier, dean for students and coordinator of the May 1-4 Recognition activities, Dr. Bernard Hall, vice-president and provost, and Dean John J. Flower, assistant provost, the members of the sub-committee revised the recommended proposals for the memorial service by recommending that "faculty-student peace marshals

should be used to the greatest extent possible."

Dr. Ronald Beer, general executive assistant to President Robert I. White, presented the administration's position on the May 1-4 recognition activities at the Student Senate meeting.

He stressed throughout the presentation that the maintenance of the institution was at stake and "dignity and solemnity" must be preserved at these services.

He conceded that there may exist many mediums through which to express commemoration of the

tragic event of last May 4, including folk concerts. Yet, while this medium must be recognized, the events must be held indoors to "dissuade" participation from outside communities.

Currently valid identification cards will be checked at indoor events, he said.

Dr. Beer said he hoped that the university community would vocally express to the other communities desiring to share "our grief" its acknowledgement of such noble actions and motivations.

However, he added, outside communities are urged to remain at home and organize activities whereby they may express these feelings.

**JD** [REDACTED] mentioned on April 13, 1971, that ABBIE HOFFMAN was recently telling some people that HOWIE EMMER of Kent, Ohio, wanted him to come to Kent on May 4, 1971, but HOFFMAN did not think he could make it because he was in a heavy legal struggle in order to keep his bail from being revoked. HOFFMAN was scheduled to speak in Iowa the night before (May 3, 1971) and HOFFMAN felt that if the people at Kent wanted to put him on the program it would be OK but he did not want the entire program built around him. HOFFMAN was going to try to get to Kent for May 4, 1971, but he could not guarantee it.

ABBIE HOFFMAN

ABBIE HOFFMAN was found guilty in the United States District Court, Northern District of Illinois, Chicago, Illinois, during February, 1970, of violation of a Federal Anti-Riot Law Statute, arising out of his participation in the riots during the Democratic National Convention held in Chicago in August, 1968. On February 20, 1970, HOFFMAN was sentenced to five years imprisonment and fined \$5,000. As a result of the trial, HOFFMAN was also found guilty on February 14, 1970, of 23 separate criminal contempts and sentenced to 8 months imprisonment. On February 28, 1970, the U.S. District Court of Appeals, Seventh Circuit, Chicago, Illinois, ordered that HOFFMAN be released on \$25,000 bond.

Bond will speak on Sunday evening, May 2, at 8 p.m. in Memorial Gym. Gregory will speak Monday, May 3, at 3:30 p.m. in the Gym. Ahern will be presented that evening at 8. Brewster and McKuen will speak Tuesday, May 4, at 2 p.m., the site of which has not yet been determined.

"Agamemnon" will be presented Saturday evening in University School Auditorium at 2 p.m. That evening, the dance company will appear in the same auditorium at 8.

Ruth Greco will deliver her presentations on Monday, May 3, at 4 p.m. in Van Deusen Hall. The site and times of the workshops have not yet been determined.

# Coalition issues call to strike against war

The May Day Coalition, at yesterday's press conference, issued a call to the nation to become involved in a solidarity strike against the war.

MAY 4<sup>th</sup> REVIVAL!

The Administration of Kent State University claims that the events of last May were "uniquely ours alone", and that our remembrance of our fallen brothers and sisters should be a "family affair". We can dig it, but we consider all of you part of our family.

We say that our family is people the world over struggling against the U.S. government. Our family is at war:

- it is a war between life and death;
- it is a war between human beings and machines;
- it is a war between cultures;
- it is a war between oppressor and oppressed.

The university is playing its corporate liberal games. Their "peace and harmony" is but "law 'n order" by another name. Their attempts to make the memorial a funeral wake are but an effort to deny the ongoing struggle which is the only valid means of honoring our fallen comrades. We want to revive their spirit and their struggle. The university hopes to keep both buried.

Behind that liberal facade lie war, racism, and repression. Despite years of struggle against ROTC, the KSU Board of Trustees and the administration are determined to keep it on campus and the Faculty Senate showed where it was at by voting to retain the Corps. They mumble about "justice" and "due process" while 25 of our brothers and sisters are being ripped off for last May's events instead of the real criminals.

So, too, would those in power have us ignore or forget Nixon's "revolutionary" programs.

Pogroms that have brought vegetable and animal life, as well as human, to the verge of extinction in South Vietnam.

Pogroms that play the numbers game of "calculated withdrawal" while the genocidal air war escalates.

Pogroms which murder or imprison those who would resist.

STUDENTS FOR A DEMOCRATIC SOCIETY

Students for a Democratic Society, commonly known as SDS, came into existence at a founding convention held during June, 1962, at Port Huron, Michigan. From an initial posture of "participatory democracy," Marxist-Leninist ideology of various shadings became predominant during 1968-1969 with debate centering on how best to create a revolutionary youth movement. SDS moved from involvement in the civil rights struggle to an anti-Vietnam war position to advocacy of a militant anti-imperialist line linking up the oppressed peoples of Asia, Africa and Latin America with the black liberation movement in the United States. All major factions within SDS embrace Marxism-Leninism and identify internationally with China, Cuba and North Vietnam as countries leading the worldwide struggles against the United States. However, the Soviet Union was regarded as imperialist and with the Communist Party, United States of America, "revisionist" in nature.

SDS operated under a national constitution which called for an annual National Convention (NC) and quarterly National Council meetings wherein programs were initiated and debated. Three national officers were elected annually with a National Interim Committee to run the organization. Regional offices and college chapters elected delegates to the national meetings but each functioned independently on local matters. Its official publication "Fire" (formerly "New Left Notes") last appeared in December, 1969.

Internal factionalism of serious proportions developed during 1968 - 1969 and the following three factions evolved as a result of a split at the June, 1969, NC: Weatherman, Worker Student Alliance (WSA), and Revolutionary Youth Movement (RYM). The effect of the split on SDS chapters throughout the country was divisive. Some aligned with one or the other of the three major factions. Others, unable to identify with any faction, disassociated with SDS completely and changed names.

The Weatherman and RYM groups no longer consider themselves associated with SDS, and the WSA group refers to itself as the true SDS.

REVOLUTIONARY YOUTH MOVEMENT

**67D** [REDACTED] that the Revolutionary Youth Movement II (RYMII) faction of Students for a Democratic Society (SDS) held a national conference at Atlanta, Georgia, from November 26 to 30, 1969. At this conference it was decided to form a new organization to be known as Revolutionary Youth Movement (RYM), characterized as a mass anti-imperialist youth organization, said organization being proposed as separate and distinct in form and content from SDS. The "Principles of Unity" adopted by the conference included a struggle against white supremacy and male supremacy; fights against imperialism, anticommunism, fascism and oppression of youth; and support of the right of self-determination of all "oppressed nations," also support of the right of all "oppressed and exploited" peoples "to armed self-defense." It was agreed that RYM would not be a Marxist-Leninist organization; however, source said this was decided in order to indicate an organization broad enough in form to be acceptable to everyone. A temporary National Steering Committee (NSC) made up of eight females and two males was elected to govern RYM until national officers could be elected during the Spring of 1970.

RYM publications have listed the RYM National Office (NO) at Post Office Box 5421 and Post Office Box 77012 C, both Atlanta, Georgia, and a second source has advised that the NO has no office space but would probably be considered as located at Apartment 27, 1067 Alta Avenue, Northeast, Atlanta.

[REDACTED] that women dominated the founding conference and have continued to dominate NSC meetings to the point that "women's liberation" has apparently become the RYM's principal issue - also that RYM's poor financial condition has resulted in its failure to publish a paper. During early 1970, RYM has decided to cater to the working class rather than youth, since the potential for social revolution lies in workers.

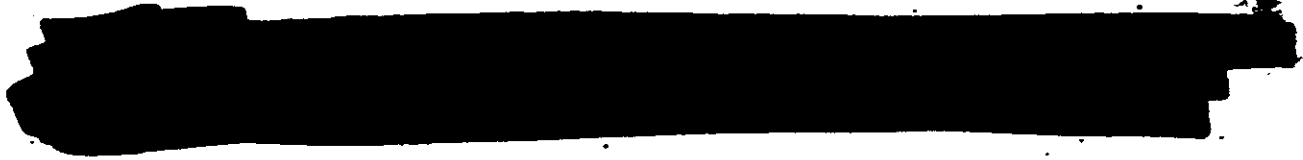

WEATHERMAN

Initially called the "Action Faction," Weatherman came into being immediately before the June, 1969, Students for a Democratic Society (SDS) National Convention (NC). At this NC Weatherman won all three national officer positions and a majority of the National Interim Committee as well. Subsequently, they took over the SDS National Office (NO) in Chicago, and controlled its funds, paper and national records. Although internal struggle existed until late 1969, Weatherman for all major purposes controlled SDS nationally from June, 1969, until its NO closed in February, 1970. At this time it no longer considered itself part of SDS.

The term Weatherman emerged from an ideological paper prepared by its leaders entitled "You Don't Need a Weatherman to Know Which Way the Wind Blows" ("New Left Notes" June 18, 1969). This statement outlined the basic stance of Weatherman: Marxist-Leninist in content but with strong advocacy that action not theory would bring about revolution in the United States. This posture was complemented with an international identification to the Cuban revolution and Castro's statement that the duty of a revolutionary is to make revolution.

During October, 1969, Weatherman riots in Chicago resulted in more than 260 arrests for mob action and related charges. A program of armed struggle was finalized during a December, 1969, "War Council" wherein terrorist tactics and political assassination were contemplated. The basic strength of Weatherman was then revealed to be some 300 - 350 nationally and geographically apportioned to the Midwest, New York, and some Northwest.

As its rhetoric of violence escalated, Weatherman leaders increasingly discussed the necessity of an underground operation wherein more than 90 percent of the organization would be submerged; "affinity groups" of three - five members would function independently. In February, 1970, Weatherman leaders announced a program of "strategic sabotage" with police and military installations as primary targets.

[REDACTED] that at the National Convention (NC) of Students for a Democratic Society (SDS) held in Chicago, Illinois, during June, 1969, a split arose between the Progressive Labor Party (PLP) and the National Office (NO), the NO becoming known as the Weatherman faction. The PLP faction drew the largest support among those in attendance at the NC.

[REDACTED] that during late Summer, 1969, the PLP faction of SDS established its National Headquarters (NH) on the second floor of a loft-type building at 173A Massachusetts Avenue, Boston, Massachusetts. The campaign on which the PLP faction centered was to build a worker student alliance or a campus worker student alliance. Thus, they adopted the names of Worker Student Alliance (WSA) or Campus Worker Student Alliance.

[REDACTED] that the "New Left Notes," printed in New York City, is the official publication of the WSA faction.

[REDACTED] that within the SDS, the WSA is a caucus of which the PLP constitutes the leadership.

[REDACTED] that during demonstrations staged in the Boston area during the Spring and Summer of 1970 by the NH, the main theme of previous demonstrations staged by the NH shifted from protestations of the Vietnam War and other United States foreign policy matters to attacking domestic issues such as racism and unemployment and demonstrating support of the "workers' struggle."

PROGRESSIVE LABOR PARTY

"The New York Times" city edition, Tuesday, April 20, 1965, page 27, reported that a new party of "revolutionary socialism" was formally founded on April 18, 1965, under the name of the Progressive Labor Party (PLP) which had been known as the Progressive Labor Movement.

According to the article, "The Progressive Labor Movement was founded in 1962 by Milton Rosen and Mortimer Scheer after they were expelled from the Communist Party of the United States for assertedly following the Chinese Communist line."

67D [REDACTED] that the PLP held its Second National Convention in New York City, May 31 to June 2, 1968, at which time the PLP reasserted its objective of the establishment of a militant working class movement based on Marxism-Leninism.

[REDACTED] that at the Second National Convention Milton Rosen was unanimously reelected National Chairman of the PLP and Levi Laub, Fred Jerome, Jared Israel, William Epton, Jacob Rosen, Jeffrey Gordon, and Walter Linder were elected as the National Committee to lead the PLP until the next convention.

The PLP publishes "Progressive Labor," a bimonthly magazine, and "Challenge-Desafio," a monthly newspaper.

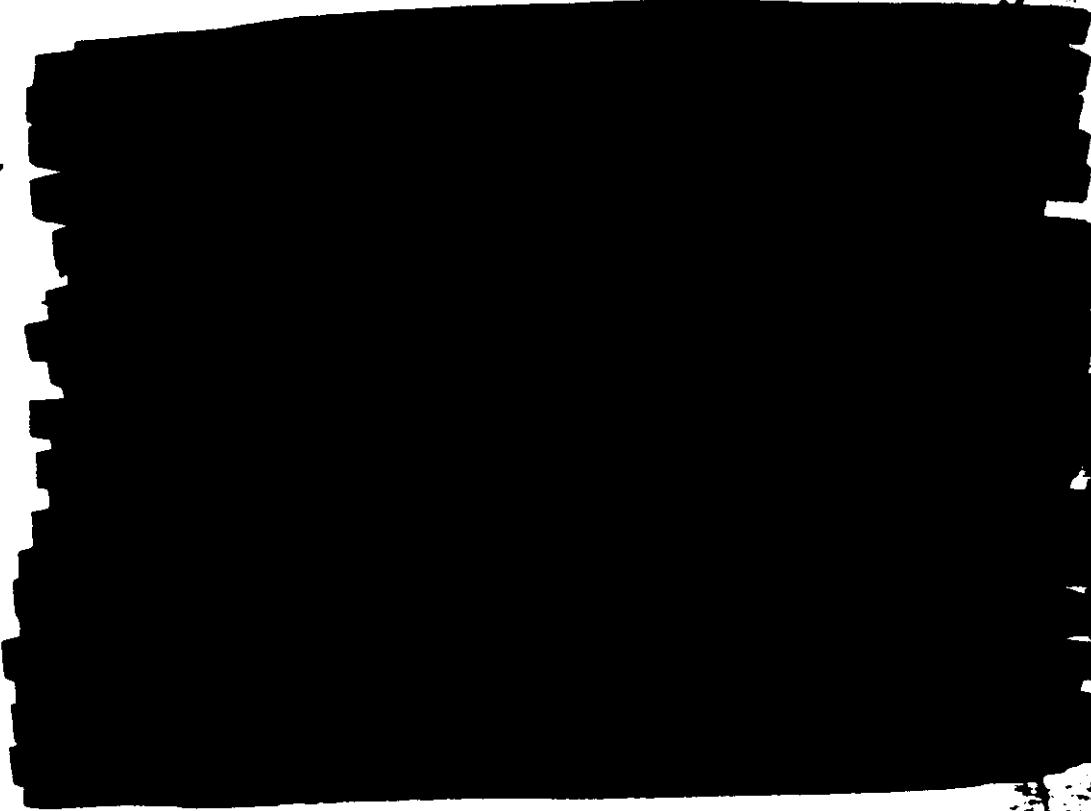
