HOFFMAN's attorneys have filed a Post Argument Memorandum before the Court and the Court has not as yet decided whether or not to accept this memorandum. No decision has been reached by the Court concerning the merits of the case as argued.

Canadians Bar Hoffman At Border

FORT ERIE, Ont. —(AP)—Abbie Hoffman, one of the Chicago Seven, was refused entrance to Canada Wednesday at the Peace Bridge, linking this city with Buffalo, N.Y.

Canadian immigration officials would not say why Hoffman was turned back at the bridge, though Immigration Minister Otto Lang issued a statement Tuesday which said "Mr. Hoffman didn't behave himself particularly well the last time he was here."

Immigration officials at the bridge said they were acting in accordance with a ruling by Lang which bars Hoffman from the country.

Hoffman said Tuesday he would attempt to enter Canada to appear on a CBC television program called Under Attack originating at the University of Western Ontario at London, Ont.

He called the decision made Tuesday to bar him from Canada "a disgrace, coming from a country that is supposed to have a libertarian attitude."

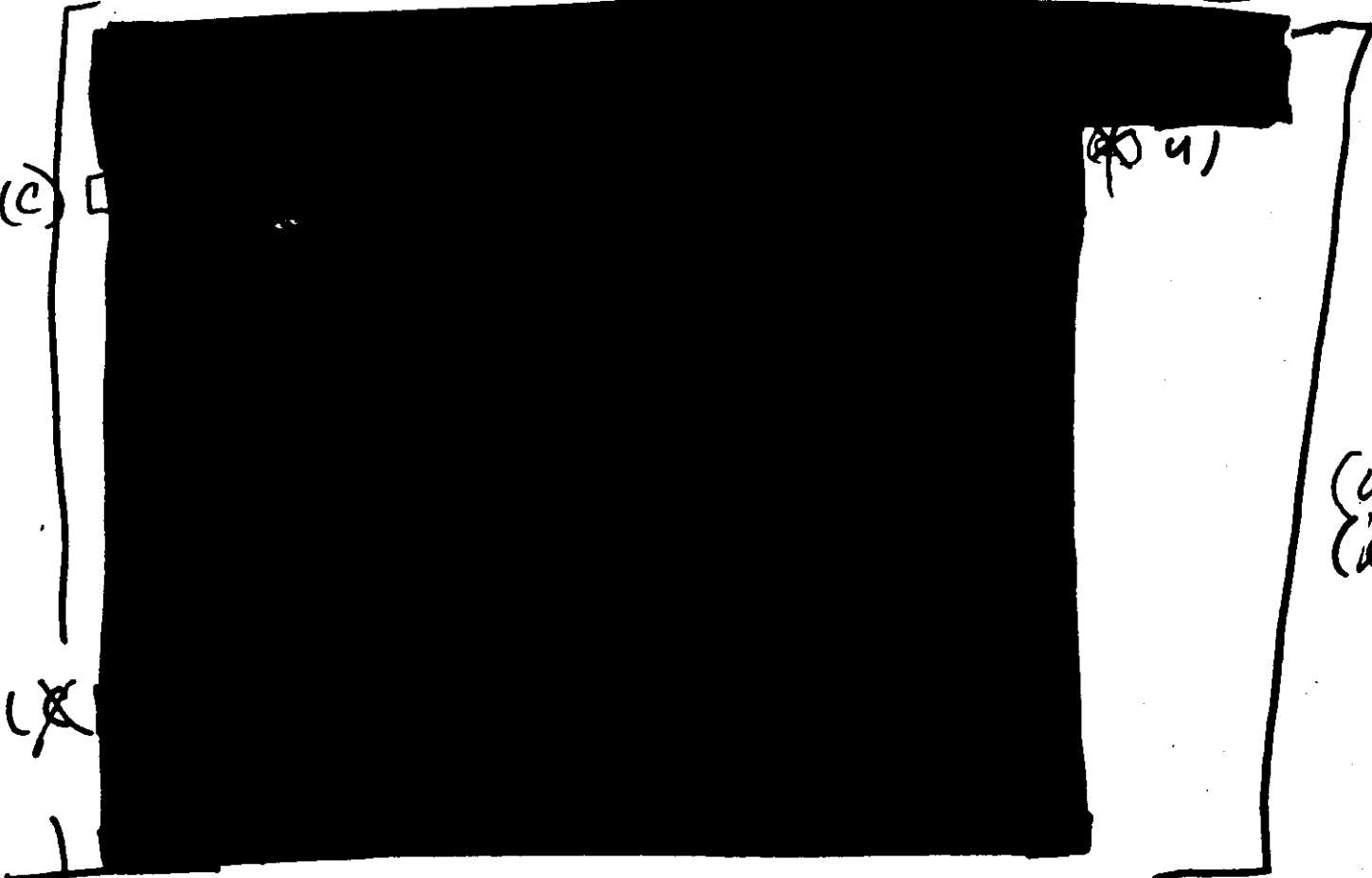

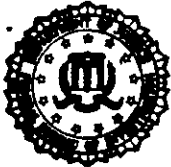

D: Arrests

1. Federal Indictment, Chicago, Illinois

On March 20, 1969, ABBOTT HOFFMAN was indicted by a Federal Grand Jury (FGJ), Chicago, charged with a violation of the Antiriot Laws (ARL), Title 18, United States Code (USC), Sections 2101 and 371. HOFFMAN was charged with conspiring with others, and himself traveling in interstate commerce from outside Illinois, to Chicago, Illinois, with the intent to incite, organize, promote and encourage, a riot and thereafter, on or about August 26, 1968, at Lincoln Park, Chicago, Illinois, and on or about August 27, 1968, at Lincoln Park, Chicago, Illinois, and on or about August 29, 1968, at Grant Park, Chicago, Illinois, he did speak to assemblages of persons for the purposes of inciting, organizing, promoting, and encouraging a riot.

Trial in this matter commenced in Chicago, Illinois, on September 24, 1969, and on February 18, 1970, HOFFMAN was found by a jury to be guilty of Section 2101 of the above statute, as related to his own travel interstate for the purposes as noted. On February 20, 1970, he was sentenced by United States District Court (USDC) Judge JULIUS J. HOFFMAN, trial judge in this case, to five years in the custody of the Attorney General (AG), fined \$5,000.00 and court costs.

In addition, as a result of his conduct and statements in court during this trial, HOFFMAN was found by USDC Judge HOFFMAN to be clearly a dangerous individual and on February 14, 1970, was sentenced to a total of eight months and fourteen days in the custody of the AG for twenty-four separate instances of summary contempt of court. Bond was denied on both the contempt and ARL convictions.

On February 28, 1970, the United States Seventh Circuit Court of Appeals, Chicago, Illinois, ordered ABBOTT HOFFMAN and those convicted with him admitted to bail, with the provision that he not travel outside the state of his residence (New York), without notifying the United States Marshal (USM), Chicago, Illinois, further that he was not to travel outside the continental United States without the express approval of the Court of Appeals.

On November 12, 1970, the United States Court of Appeals ordered a hearing be held in USDC, Chicago, Illinois, before Judge JULIUS J. HOFFMAN, to inquire into deliberations of the jury in the case. This Court of Appeals order was based on a lengthy motion filed with the Court of Appeals earlier by counsel for the defendants, alleging that the jury was in effect coerced into a guilty finding through remarks made during its deliberations by Deputy United States Marshals in charge of the jury, also that information concerning communications to the trial judge (Judge HOFFMAN) by the jury, regarding its inability to reach a verdict, was not made available to the defendants or their counsel.

On November 18, 1970, a Special Agent (SA), of the Federal Bureau of Investigation (FBI), observed the arrival of ABBOTT HOFFMAN at O'Hare International Airport, located in the north suburban area of Chicago, Illinois via Delta Airlines flight 387 from Atlanta, Georgia. Upon disembarking from this flight, he was met by representatives of the Chicago news media and numerous persons dressed in "hippie" garb.

The November 19, 1970, edition of the "Chicago Sun Times", a daily Chicago, Illinois newspaper, under the byline of PAUL MALLOY, contained an article entitled "Uninhibited, unbathed Abbie flits into Chicago for hearing". The article reflected that ABBOTT HOFFMAN, described as groggy and unshaven, had flown in from Tallahassee, Florida where he had given a speech. HOFFMAN

"was brimming with plans for a crusade to Vietnam, where the youth of the world would negotiate a peace - 'or else'", according to the article. He was noted to have said to the press at O'Hare upon his arrival that American members of his party - "students, lawyers and doctors" - would confer in the next four months with their counterparts in Japan, Mexico and Latin America, coordinate plans and then journey to Vietnam to work out details for a peace treaty.

The article related that HOFFMAN had stated that if United States troops are not out of Vietnam by April 25, (no year noted), then the Yippies would arrange to be in Washington, D.C., en masse on May 1. HOFFMAN, according to this article, was not explicit about the nature of this demonstration, describing it once as an "attack" and later as a "confrontation". When asked by a reporter what form the "attack" would take, the article quotes him as stating, "We have lots of weapons".

HOFFMAN reportedly was in Chicago, Illinois, for hearings to begin November 19, 1970 on whether any of the jurors in the Chicago 7 Conspiracy trial received improper communications during their deliberations. Regarding these hearings, HOFFMAN had stated "We always thought the jury is the highest authority in the courtroom, but Judge What's-His-Name (HOFFMAN) didn't think so." The article continued that HOFFMAN described four of the jurors as sympathetic to the defendants during the trial, and hoped that at the hearings they would reconfirm their sympathy. "We always had the feeling that if the jury had considered all the evidence we would have been freed. So I hope those jurors stick to their guns", he is quoted as stating.

At one point, the article described HOFFMAN further as at times somber and at times bursting into unexplained laughter. He had interrupted the brief press conference on one occasion to state, "Man, have I got a headache. Has anybody here got any acid."

On November 19, 1970 and November 20, 1970, ABBOTT HOFFMAN was observed by SAS of the FBI in the United States District Courtroom of Judge JULIUS HOFFMAN, where the above referred to hearings took place, sitting at the defense counsel table throughout both

days hearing sessions.

2. Arrest in Chicago, Illinois

The "Chicago Daily News", a Chicago, Illinois daily newspaper, in its November 9, 1970 issue on page 1, column 1, contained an article entitled "High Court Won't Hear Abbie Plea".

This article which is datelined "Washington" stated as follows:

"The Supreme Court Monday refused to review the conviction of Yippie leader Abbie Hoffman, who was arrested in Chicago in 1968 because he had an obscene four-letter word painted on his forehead.

"In a brief order without comment, the court let stand a trial court opinion that acquitted Hoffman of disturbing the peace but convicted him for resisting arrest.

"Hoffman is free on \$25,000 bond for contempt of court in the Conspiracy 7 trial.

"Hoffman was arrested Aug. 28, 1968 in Chicago after a woman flagged down a squad car and told three officers that Hoffman had an obscenity written in red on his forehead. Hoffman said he offered no resistance."

The "Chicago Tribune", a Chicago, Illinois daily newspaper, edition of November 20, 1970, contained an article noting that a hearing had been held that date in Municipal Court, Chicago, before Judge KENNETH WENDT, at which Judge WENDT had refused a motion made by a local attorney on ABBOTT HOFFMAN's behalf, calling for a new trial on a conviction for resisting arrest during the Democratic National Convention in Chicago in August, 1968. Judge WENDT had then set December 3, 1970, for HOFFMAN to surrender and begin serving a fifteen day jail sentence imposed earlier on that conviction.

[REDACTED] Cook County States Attorney's Office, 26th and California, Chicago, advised that HOFFMAN had been originally convicted by Judge WENDT, in a bench trial on January 28, 1969, in Mass Arrest Court, Chicago. He was sentenced to one year probation on the charge of resisting arrest, August 28, 1968 with the first fifteen days to be served in Cook County Jail.

He advised that this conviction had been upheld March 24, 1970 by the Illinois Supreme Court. The conviction was then appealed to the United States Supreme Court, which on November 9, 1970 denied HOFFMAN a hearing on the conviction. On November 19, 1970, in Judge WENDT's court, counsel for HOFFMAN had moved for a new trial, however, that motion was denied by the court and the case was then continued to December 3, 1970 at which time HOFFMAN was ordered to appear to commence serving the fifteen day sentence imposed.

[REDACTED] advised that the subject had appeared in Judge WENDT's court, had been taken into custody by Cook County Authorities, and had subsequently been incarcerated at Cook County Jail, Chicago.

An SA of the FBI observed the subject's appearance in Municipal Court, December 3, 1970. There were no incidents surrounding this appearance.

In this connection, "Chicago Today" a daily Chicago newspaper, edition of December 3, 1970, contained an article entitled, "Abbie Put in Jail Here." The article referred to the subject's surrender in Judge WENDT's court, and noted he had stood silent, solemn and unshaven as the Judge had warned him that an infraction of his probation, upon his release from jail in fifteen days, would result in his being returned to jail for the remainder of the year's period.

[REDACTED] of Cook County Jail (CCJ), Chicago, advised that on December 15, 1970, HOFFMAN had been released from CCJ two days early,

having been granted this two days as a result of his "good behaviour" while a prisoner here. Upon his release, HOFFMAN had indicated his intention to return immediately to his residence in New York City, New York.

On December 16, 1970, the "Chicago Daily News," carried an article entitled "Abbie 'Good,' Leaves Jail 2 Days Early." The article quoted RICHARD ENGLISH, Superintendent of CCJ, as stating "He was a good prisoner. We've had him here before and he has never caused trouble."

According to this article, HOFFMAN had worked in the jail's kitchen during his period of confinement. After his release he had picked up some personal items at the office of his local attorney, FREDERICK COHN, and then had flown directly to New York City.

b7D [redacted] (u) that the subject had returned to New York City after his release from incarceration in Chicago, Illinois and that as of December 17, 1970, he was residing at his residence 114-116 East 13th Street, New York City.

3. Arrest in Washington, D.C. b7C

On December 29, 1970, [redacted] United States Court of Appeals, Washington, D.C. advised SA [redacted] that the case of ABBIE HOFFMAN vs. the United States (case number 23514) is still pending before the United States Court of Appeals.

[redacted] stated that this case which is an appeal of the subject conviction on November 20, 1968 in the Court of General Sessions, District of Columbia on the charge of defiling the American flag by wearing a shirt resembling the flag, was argued on its merits before the Court on December 18, 1970. The subject's attorneys have filed a post-argument memorandum before the Court and the Court has not as yet decided whether or not to accept this memorandum. No decision has been reached by the court concerning the merits of the case as argued.

that the subject and his wife, ANITA HOFFMAN, returned to their residence at 114 - 116 East 13th Street, New York City on the afternoon of October 30, 1970 from their recent European trip.

B. Canada

On January 6, 1971, Assistant United States Attorney (AUSA) JAMES BREEN, Northern District of Illinois, made available a copy of a motion filed on January 5, 1971, by counsel acting for HOFFMAN, with the United States Court of Appeals (USCA) for the Seventh Judicial Circuit, Chicago.

In this motion, HOFFMAN requested permission of the USCA to travel to Canada from on or about January 12, 1971 through on or about January 15, 1971. The purpose of this travel was to fulfill the following invitations:

- a) January 13, 1971 - To appear on a television show called "Under Attack", which is being presented by Screen Cems. This show will be produced at the University of Western Ontario in London, Ontario, Canada.

b) January 14, 1971 - To speak at Dalhousie University, Halifax, Nova Scotia, for the American Program Bureau.

c) January 15, 1971 - To speak for the American Program Bureau at Loyola University in Quebec, Province of Quebec, Canada.

AUSA JAMES BREEN further advised that on January 5, 1971 the USCA had issued an order authorizing HOFFMAN's travel to Canada as requested.

The "New York Post", a New York City daily newspaper in its January 13, 1971 issue on page 4 contained an article entitled "Abbie & His Huskies Charging on Canada", which stated in part as follows:

"Not too many people are declared unwelcome in Canada, but then not too many people are like Yippee leader Abbie Hoffman.

"So sometime today in Buffalo, Hoffman will try to force his way past border guards, having been denied entry into Canada under a rarely invoked section of the immigration law that bars persons convicted of crimes 'involving moral turpitude.'

"Hoffman, who promises to have a band of Yippies on hand for support, plans to cross the appropriately named Peace Bridge, connecting Buffalo with Fort Erie, Ont., and 'let them tell me to my face that I can't come in.'

"After all, he says, 'there are two sides to every bridge

"The only time you're welcome in Canada is if you're an American imperialist bent on drinking Canada dry,' he went on. 'They welcome you and your money.'

"More is involved, though, than Hoffman's spending habits, said Canadian government officials, who banned the Chicago 7 trial defendant while having greeted numerous other radicals and hundreds of American draft resisters.

"Immigration Minister Otto Lang's decision yesterday to deny Hoffman an entry permit was apparently prompted by what he regards as the Yippie's misbehavior on a trip to Canada in September.

"When told that Hoffman planned to resist a border stop, the Immigration Minister replied: 'I don't know what he means by that, but if he chooses to flaunt the law, then he will see how well our enforcement of it is.'

"Hoffman declared he was just as prepared for possible Yippie action on the American side of the Peace Bridge today, saying 'we have a good active chapter up there, you know. It maintains a good border patrol.'

"He then let loose a broadside at the Canadian government, whose action, he said, 'is a disgrace, coming from a country that is supposed to have a libertarian attitude.'

"'I understand from reading the papers that Canada seems to have suspended democracy,' he said.

"'It's another move for societies that supposedly believe in free speech, and it's something that happens regularly here in the States and is now happening in the 51st state, which is Canada.'"

The "New York Post" in its January 15, 1971 issue on page 8, contained an article entitled "Abbie Thwarted At Border".

This article which is datelined "Buffalo (AP)" stated in part as follows:

"Abbie Hoffman, the Chicago Seven defendant and founder of the Yippie movement, was thwarted in his bid to enter Canada over the Peace Bridge linking Buffalo with Fort Erie, Ontario.

"Canadian Immigration officials questioned Hoffman yesterday for more than an hour, the drove him back to the United States side of the span, where he cleared United States Customs and Immigration without incident.

"He Had Misbehaved

"Canadian officials at the bridge refused to comment on why Hoffman was denied admittance but they acted in accordance with a ruling Tuesday by Immigration Minister Otto Lange barring his entry.

"'Mr. Hoffman didn't behave himself particularly well the last time he was here,' Lange said.

"After his experience yesterday, the bushy-haired Hoffman complained that he had been given the runaround by Canadian officials.

"'They told me to go back where I came from. They don't want the likes of me around,' he said."

67D [redacted] (u) that the subject was, at that time on board Penn Central Railroad train #72 from Buffalo, New York bound for New York City. The train was due to arrive at Grand Central Terminal in New York City at 6:00 PM on January 14, 1971.

On January 14, 1971, SAS of the FBI observed the subject depart Penn Central Railroad train #72 alone at Grand Central Terminal in New York City at 6:50 PM. No press conference or other activities was noted.

III. ACTIVITIES

A. YIP, San Francisco, California

The September 11 - 18, 1970 issue of the "Berkeley Tribe" an underground newspaper published in Berkeley California on page 13 contained an advertisement which stated that the YIP was forming a National organization and that a Western Regional Conference would be held in San Francisco, California on September 25, 1970.

67D [redacted] (u) the YIP conference held during the period 10:30 PM through approximately midnight on September 25, 1970 at Pier 42, San Francisco, California. [redacted]

[redacted] (u) It was announced that the meeting had been organized by ~~CATHY PEARL~~ and ~~PAMELA GARRETT~~, both of San Francisco, who explained during the course of the meeting that its purpose was to organize a San Francisco chapter of YIP and to introduce ~~ABE HOFFMAN~~ to prospective members.

The leadership of the meeting was then turned over to HOFFMAN. HOFFMAN explained that it was his belief that YIP should be organized around local chapters who were responsible to a national headquarters. He stated that he personally felt that YIP should strive to obtain national scope and national recognition. HOFFMAN continually stressed the importance of organization to achieve the Party's goals. HOFFMAN stated that he and other YIP leaders were contemplating the organization of a national YIP newspaper.

HOFFMAN stressed to those in attendance the advantages of displaying the YIP flag at rallies and demonstrations so as to give high school and college students a flag to identify with which is opposed to the United States flag.

HOFFMAN stressed the potential for power that could be gained from the organization of various youth groups and from the organization of the entire youth culture.

HOFFMAN displayed a building stone which he identified as a portion of the Federal Building in Minneapolis, Minnesota, which had been recently bombed. HOFFMAN stated that stones from this explosion had been gathered by Minneapolis youth groups and sold to raise money for various legal defense funds.

After his opening comments, HOFFMAN opened the meeting to a discussion session among those in attendance. The general topic of this group discussion was the relative merit of organizing YIP on the basis of strong local chapters as opposed to a more centralized national organization. After approximately 1 1/2 hours of discussion, the meeting degenerated into disorganized arguing. HOFFMAN then canvassed the group for persons who were available to assist in the organization of a San Francisco chapter of YIP. Several persons indicated they were available and desired to assist in this task. CATHY PEARL and PAMELA GARRETT explained that assistance was needed and that YIP had opened an office at 86 - 3rd Street, San Francisco, but that the office was presently unoccupied and had no furniture or telephone.

Approximately 70 persons attended this evening's conference. During the conference, PAMELA GARRETT stated that the space the group was currently using, which consisted of second floor office space built within the structure of Pier 42, was currently being leased by the San Francisco Local Development Corporation. GARRETT stated that she was employed by this firm and had secured permission to use its space for this meeting. She stated that there was no connection between her employer and YIP.

[REDACTED] during September, 1970 that YIP had rented California Hall, 625 Polk Street, San Francisco, for the evening of September 26, 1970, and that YIP planned to stage a benefit fund - raising festival for the Los Siete de la Raza Defense Fund. It was also hoped that YIP would share in the benefit's proceedings.

"Los Siete de la Raza" (Seven of the Race) are seven young Mexican-American males who were charged with the murder of a San Francisco, California policeman on May 1, 1969. In early November, 1970, six of the defendants were found "not guilty" of murder, by a San Francisco Superior Court jury. The seventh defendant is in fugitive status.

[REDACTED] the entertainment program at California Hall on the evening of September 26, 1970.

The program was held during the approximate hours of 8:30 PM through 11:30 PM. The number of persons present was approximately 400. A \$3.00 admission charge was made, which produced an estimated revenue for the evening of \$1,200.

The evening's entertainment began with three musical groups presenting selections. A local radio disc jockey spoke briefly after the first selection and he announced that ABBIE HOFFMAN had arrived and would speak at the completion of the entertainment. This disc jockey mentioned that YIP had established an office at 86 - 3rd Street, San Francisco.

At approximately 11:00 PM, Attorney MICHAEL KENNEDY spoke. He stated that HOFFMAN had left the Hall without speaking because he was exhausted and had found a lack of leadership in San Francisco for a revolutionary movement. The audience booted heartily when KENNEDY made this announcement. While speaking, KENNEDY was holding in his hand a piece of stone that came from the Federal Building in Minneapolis. KENNEDY stated that HOFFMAN had brought this stone to San Francisco.

"Well, thanks for bringing me out here. I can see this ain't the Lower East Side. Quite different. Beautiful. We came to San Francisco. We had a police station blow up in New York. It was, it was two days late, but, that's the way it goes, you know, long fuse. But, we're learning better living from chemistry, you see. It's a slogan. And, what goes up doesn't necessarily have to come down, the way Isaac Newton taught us in the fourth grade. And the Weathermen in New York definitely proved that fact that police station ain't never coming down again.

"Well, we came into San Francisco, and we drove down the coastline on a tourist trip visiting all the oil slicks along the way. Seven (obscene) oil slicks we saw all the way down here, I mean, the pigs really ought to take care of the Pacific Ocean a little better, cause actually there are only two others like it in the whole world...

"I was on trial in Chicago, did you hear about it, huh? Oh, you did? Yeah. We sort of felt we should have got the Academy Award for that trial, I mean, not John Wayne and those (obscene). I mean, if they were, if they were pot-heads making decisions in Hollywood, as well as Washington, you know, instead of lush whiskey drinkers, we would've won the Academy Award for sure.

"Well, it was a strange trial. We were on trial under Anti-Riot Act, twenty-one-, one-, twenty-one, ten I think it's called. Strom Thurmond passed it as a memorial tribute to Martin Luther King. It was attached on to Open Housing Act, and it's, it's only fitting in 1984 that we be tried under a civil rights act. And, it's called the anti-riot clause of the civil rights act, and a riot is defined as an act or threat of violence by one or more people in a crowd of three or more. Probably happened here about seven or eight times, but you have to be smoking what General Mitchell

"and those other people in Washington, those other Philistines, are smoking in order to recognize a riot and know one when you see one. Then it's well, you see we crossed state lines, I guess. I guess that's the only you can do it nowadays.

"But anyway, all of a sudden, everyone knew what happened in Chicago. I mean, people here, the whole world was watching, the hectic week, and everybody knew it was Mayor Daley, and the Neanderthals in Chicago that run that city. And the police you know, were responsible for the blood and the riots that flowed in the streets of Chicago. Even the government's own official investigation committee, the Walker, Walker Commission, determined that it was a police riot.

"So you see there is no court in America where you can put Mayor Daley and those other people on trial. In fact they had eight policemen to balance the eight of us, tried too. They thought that was a semblance of justice. But within one or two months after our trial happened, every single policeman was let free. One policeman had, had sent one newsman to the hospital with twenty-four stitches in his head. There were photos, movies of this event, and the judge said, well, we gotta dismiss the charge because the newsman called him a (obscene) and he did what any red-blooded American would do, sent him to the hospital. Right on said the judge and out goes the (obscene) cop...

"That's what political trials are about. You're on trial for who you are, not for what you did. Ever. No matter what it is. Wearing a shirt, you know, even killing. Because murder, murder in this country, if you have a uniform is legal. You wear costumes or run around naked, like us, it's a crime. But if you have a uniform, it's legal. So that, always remember, it's not what's happening, it's who's doing the what that counts in American Courts. That's called justice...

"Lennie Bruce once said that in the halls of justice in America the only justice is out in the (obscene) halls. And that's right on, that's for a fact in America. Nobody can get a fair trial in America. Every trial is a political trial. Remember that. If you go in the (obscene) jail, we went in the jail to have our (obscene) heads shaved, that's why I've got long hair, that's the only reason for having short hair, in America, is either you're a pig or you got your head (obscene)

'shaved by the Nazi Storm Troopers. That's why. Because it is a symbol, it is a symbol of the free life that we want in the future, free life, free as hair. Oh yes, Free. Let it grow. All this, all this has grown in three weeks. And it ain't from Geritol. So. Well. So that's what courts are about. 47 busts and loads of trials _____ . Every (obscene) one. It's always been the same.

"I was busted for wearing a shirt that looked like a flag, right? That (obscene) shirt is sold to the rich, 15, 20 dollars a shirt. Phyllis Diller wears it. I was on TV with _____. Did you see that? Merve, Uncle Merve Show. Well, Roy Rogers was on two weeks before with Dale Evans, see? They wore the same exact (obscene) shirt, see? Two weeks later, on the same (obscene) show, network, CBS, you know with Ricky Nelson, you know, Pat Boone's mistress, Ricky Nelson, was, he was on with the same exact (obscene) shirt, you see? So, once again, you know, it isn't the what that's being done, it's who's doing that what.

"And we got that power. Power to the people means power. It means the power to resist and to defend our way of life. See. I'm sitting here talking, not because some liberal senator, you know, came out and opposed our trial while it was going on. Not one (obscene) senator did. You know, not Clean for Gene, George Mc Government, none of those creeps, you know George Murphy, or none of those liberal senators, opposed the trial, you see. We're here because a half a million brothers and sisters, see, said that they were on trial too in Chicago, and they took to the streets which are the only courtrooms we have left in America. They constituted themselves a jury of our peers, you see, and they burned down the Bank of America, and other assorted Yippie sports, and that's how the (obscene) we got out. Well, that's how it's always going to be. That's the only power that's understood in America, the power to destroy.

"Well, we hope that what we did in Chicago, you know, got the people around the country, young people in particular, got them a look at the legal system in America. And then they begin to recognize what we did. That every judge is Julius Hoffman, and you've seen one courtroom, you've seen them all.

"And Chicago, a Federal Building, Judge Julius Hoffman, they're right down here. Main street San Diego same thing is happening all across this country. Them, that empire putting us, the new American empire, new American nation on trial. We don't accept those ground rules, we're going to fight."

A, a, The Yippie version of the 1812 overture, Martha Mitchell can be Dolly Madison. It would be great, but, a , anyway, we-we'd, a, in crossing state, thanks to a Cramer. He's for real.

"...It's unbelievable how much it costs to go to prison. An', a, unfortunately all the bread, contrary to a, the millions that Time Magazine says that I've, a, inherited, the money all goes for legal expenses, prison, unfortunately, but a, for dope and dynamite somethin' useful.

"...Paul Revere, I was there that night (?). He said get your (Obscene) together (?) They did. They kicked the (obscene) out of pigs. They called them lobsterbacks. That was the same thing, man, throughout history, lobsterback meant pig. King George or Ben Franklin, what (inaudible) it ain't fair. They don't fight clean. They're Vietcong. You gotta' have an Air Force to fight clean. No revolution was ever fought clean. All power to the dirty fighters.

"...This institution is violent. I can smell it. I can smell ROTC. Those (obscene) outside agitators. Yea, I know, they don't look violent. They blame it on Calley (?). They're gonna' roast him. Let the other cultures, Manson, pay for their sins. Them generals, denied Song My (?). Didn't happen. No, man, when you look at 'em. Grey hair, steel rim glasses, suits, ties, shiny shoes, that ain't violent. We got to redefine what violence is. Now look, too much violence up in Madison, Wisconsin. You know, when you look up the Army Research Center. Seven stories high, glass, brick, manicured lawns, trees, that's (obscene) violence

"Just sittin' there, it's violent, that building. An'd we're gonna' begin to understand the institutions of racism, an' imperialism an' capitalism as violence. Then we begin to get our head in order.

"You go back an' tell your people they don't have to believe that cynicism and defeatism that's taught to them in their universities. In three days, they'll be a delegation of a, 18 student, a, student council presidents of some of the largest schools in the country. A, they'll go to North Vietnam to negotiate a peace treaty. A, they'll be followed by groups of doctors an' lawyers an' rock singers an' panhandlers and a, everybody'll bring their own table so it won't be a problem. So, hello, an' a, then we say a, if all the troops aren't out of Southeast Asia by April 25th, or a, the first day of May, a, we're gonna' attack Washington. An' a, people will be coming from all, crossing all kinda' state boundaries, a, we'll be just, a, is a, a, group from France, a, yippies, oh, it's international. Youth international parties. Delegation from, a, Germany's gonna' come an' a, from Ireland, a, IRA is gonna' send some to people international brigade. It's gonna' an' a, all us conspirators, and a, they'll be different things I mean, a, y'know, defoliate the cherry trees.

"Freedom of Speech is a revolutionary thing. Thomas Jefferson, I mean you read about that (obscene) commie. He said freedom of speech is only there so you can overthrow the Government. What the (obscene) else you need it for. I mean what else is it there for. Government is not responsive to the needs of the people. So Abraham Lincoln in 1861 summed it up he said when the Government does not meet the needs of the people they should exert their constitutional right to amend that Government. If a constitutional right fails they should exert their revolutionary duty to dismember and overthrow that Government. Abraham Lincoln said that in 1861...

"...Fun is misused because uh' fun is subversive. And fun is just not something uh, just gettin' stoned. It's the kind of society we want, remember. Authentic work. It's

"It's fun. So we, uh, we can get it, we can do anything. We just gotta vomit forth the citizens and they talk to us and they say we ain't ready to grow up. There are people in Washington wrestling with those problems; responsible, reasonable, rational serious people. Yeah. We can do it. But we got to recognize a few things. First is we got to recognize that we're stoned, we're turning on, we're outlaws. In the eyes of America we are outlaws. So we got to act like it. So Dillon says he'll live outside the law cause the Law is a crook. And then we got to look around to see who's outlaws.

"...You can learn survival. What do we want to learn at the University? I want to learn to survive. We want to learn how to live, dance, and fight. I want to fight. I want to learn guerilla warfare, teach. Well. We can't have a free community. Revolutionary movements going on all over. But we learn the people of the third world, how to survive. Eventually some day we may learn how to love. To love we must survive. To survive we must fight. There's a war going on. And when you come up to Washington, May 1, we'll be there. You know. And tear down the Smithsonian Institute. You know. Who's going to take down the Washington Monument, (obscene) in the Potomac? There's a law in Washington that you cannot build any structure higher than the Washington Monument. Well, it's a clear shot.

"...Free speech is a device for revolution..Oh, what the (obscene) we talking about. I'm telling you to destroy this (obscene) society in which we live. It's a pig empire destroy it. Okay. (Inaudible)...But uh, Germany was weird. It looks a lot like this place.

"...Who's gone up to Washington? Got a car; are you going, go. Revolution ain't no spectator sport, so I hope you come up to Washington, remember the slogan, Vietnam, love it or leave it."

The "New York Post" in its November 17, 1970 issue on page 68 contained an article entitled "Abbie Plans a May Protest" which stated as follows:

"Yippie leader Abbie Hoffman has told 1500 Florida State University students that 'people will be crossing all sorts of state boundaries' for Washington, next May 1 unless the war ends by April 25.

"Our motto will be 'Vietnam: Love it Or Leave,' said Hoffman.

"Commenting on South Vietnam Vice President Ky's visit to the United States, he said 'They are taking him out to meet the real American people. First it's to West Point. Then they are going to crown him homecoming queen at Bob Jones University- and then he is going to be on 'Dating Game.'"

"...I came down here to invite you to Washington. I got a hog ranch up there (?). On a, first day of May, we just got back from a, a organizing international conspiracy. A, we were a, in five different countries in Europe and a, were forming international brigades of people that said by April 25th, there's one soldier, there's one airplane, in South Vietnam, we're gonna' attack Washington, D.C. on May first. Now, people gonna' come from Paris, Germany. We go to Tokyo next month. And a, all around the country, all symbols of American imperialism, embassies, NATO bases, Army bases, Whimpies (?), they're all goin' up. This country has one sixteenth of the world population. It owns or controls fifty-five percent of the world's natural resources. Now you don't have to be a professor in political science of Karl Marx to figure out that's a rotten (obscene) deal for most of the world, an' a people aren't takin' it.

"...We have to redefine what violence is, ROTC Buildings are violence, Army Mathematical Research Development Center Buildings, such as one that use to exist at University of Wisconsin are violence, institution of racism and imperialism ar violence. We have to get all our brothers and sisters out of prison, everybody is a political prisoner, not just the people who cross interstate lines to incite riot and the attorneys who defend them, everybody in jail.

"A new value system, a new nation is going to rise from the ashes of the old. We are a people and we're going to stick together. It's only by sticking together, by organizing, by searching out other outlaws."

daily newspaper, in its April 25, 1970, issue on Page two contained an article entitled, "White House Bars Abbie Hoffman: Tea for Two, or Tea for None."

This article stated in part as follows:

"A slicked-up Abbie Hoffman, shouting obscenities as he went, was shoved away from a White House gate yesterday as he tried to crash a ladies tea being given by Tricia Nixon.

"Hoffman, one of the flamboyant Chicago Seven defendants, arrived with pop singer Grace Slick, claiming to be her bodyguard.

"'I wouldn't let Miss Slick go in there,' he said, 'I understand they lose a President every three years. It's a dangerous place.'

"Hoffman said he was armed. He did not say with what kind of weapon.

"Miss Slick, a member of the rock group, 'The Jefferson Airplane,' was invited to the tea by a Finch College alumnae group meeting here this week.

"When Hoffman was denied admittance at East Gate she, too, hustled away. A spokesman for the alumnae group said Miss Slick 'would have been allowed' to attend the tea if Hoffman hadn't been along."

The November, 1970, edition of "Stereo Review," a monthly publication on stereo music and sound equipment, published at New York, contained an article entitled, "Rex Reed talks to the Jefferson Airplane's Grace Slick," on Pages 70 through 78.

This article is in an interview form with Grace Slick talking to the writer, Rex Reed. On Page 75 of this article she is quoted as stating the following:

"'I hated all those rich debutantes at Finch,' she says. 'What a wierd scene. Tricia Nixon is a good example

" of what they turn out. I was invited to her birthday party at the White House. They sent out these little engraved invitations to the alumni and accepted unbiasedly the first ones who responded. So I called Abbie Hoffman, and he slicked down his hair and put on a blue suit. He looked like a karate-chopping pimp. It was a gas. So we showed up at the White House and got thrown out as "security risks". Boy, were they right, because I had 600 micromilligrams of LSD in my purse that we were going to put into the tea. Can you hear them now? "Wow, the President's daughter is freaked out drawing dirty pictures on the White House walls!" The security guards were criticized in the press. People wrote, "How ridiculous - not letting someone in because she's a rock singer." Well, it's not ridiculous because I really would have done it. I figured the worst thing a little acid could do to Tricia Nixon is turn her into a merely delightful person instead of a grinning robot. But we were aiming for the Old Dad, hoping he might come down to the party and have a cup of tea. Far out. I figure if they can shoot us down, we can get them high, right?"

The "Washington Square Journal" a New York University student newspaper in its November 12, 1970 issue on page 1, contained an article entitled "Hoffman, Millett Speak at Flag-Art Exhibit" which stated in part as follows:

"I think people have the right to burn the flag (obscene) on it," said Abbie Hoffman Monday night, setting the tone for the opening of the Independent Artists Flag Show to last through Friday at the Judson Memorial Church at Five Washington Square South.

"Hoffman's remarks came at the end of his account of the depreddations he has suffered for wearing, blowing his nose into, burning and generally demonstrating his lack of reverence for what to some is the penultimate symbol of their patriotism: Old Glory.

"Kate Millett, author of Sexual Politics, quite the liberated woman in thigh length dungaree work shirt and streak-bleached blue bell-bottoms, said, 'I think he's very witty,'

" during Hoffman's deadpan description of his being arrested and trampled upon, American flag shirt and all, by Washington, D.C. police two years ago for 'desecration' of the flag.

"I think he's making his case very well. Good evidence," added Miss Millett, a receptive grin on her face. 'He knows the flag issue well all the cases.'

"One of Miss Millett's own works called 'The American Dream Goes to Pot' is among the more than 200 creations on exhibit at the open show being sponsored by the Artworkers Coalition, the New York Art Strike and the Guerrilla Art Action Group, all lumped together as the Independent Artists' Flag Show Committee."

BLACK PANTHER PARTY
Also Known As
Black Panther Party for Self-Defense

According to the official newspaper of the Black Panther Party (BPP), the BPP was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by BOBBY G. SEALE, BPP Chairman, and HUEY P. NEWTON, Minister of Defense, BPP.

The official newspaper, called "The Black Panther," regularly states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to as "pigs" who should be killed.

The newspaper, in its issue of September 7, 1968, had an article by the then Minister of Education, GEORGE MURRAY. This article ended with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is revolutionary culture. Change. Freedom everywhere. Dynamite! Black power. Use the gun. Kill the pigs everywhere."

The BPP newspaper, issue of October 5, 1968, had an article introduced with the following statement: "We will not dissent from American government. We will overthrow it."

DAVID HILLIARD, Chief of Staff, BPP, in a speech at the San Francisco Polo Field on November 15, 1969, said "We will kill Richard Nixon."

DAVID HILLIARD, in the "New York Times," issue of December 13, 1969, was quoted as follows: "We advocate the very direct overthrow of the government by way of force and violence."

In the issue of April 25, 1970, the BPP newspaper had an article by Minister of Culture EMORY DOUGLAS as follows:

"The only way to make this racist US government administer justice to the people it is oppressing, is... by taking up arms against this government, killing the officials, until the reactionary forces... are dead, and those that are left turn their weapons on their superiors, thereby passing revolutionary judgment against the number one enemy of all mankind, the racist U.S. government."

The BPP Headquarters is located at 1046 Peralta Street, Oakland, California. Branches of the BPP, and Committees to Combat Fascism, under control of the BPP, have been established in various locations in the United States of America.

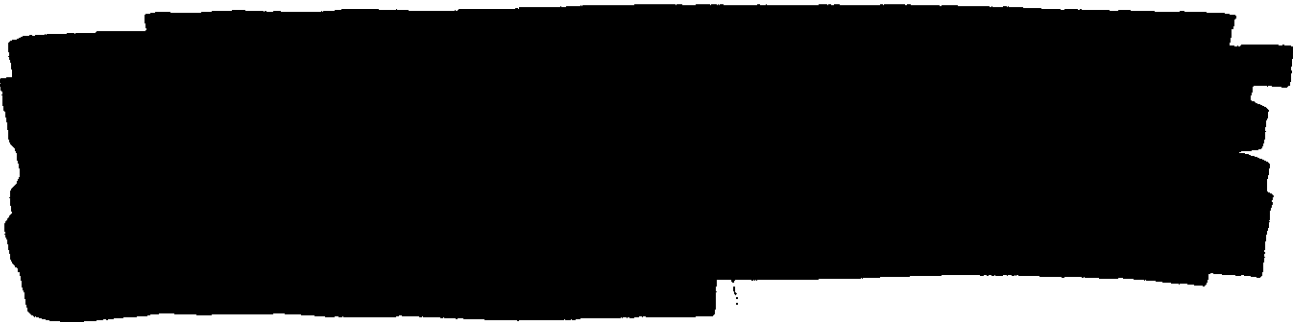

The April 6, 1960, edition of the "New York Times" newspaper contained a full-page advertisement captioned, "What Is Really Happening In Cuba", placed by the Fair Play For Cuba Committee (FPCC). This advertisement announced the formation of the FPCC in New York City and declared the FPCC intended to promulgate "the truth about revolutionary Cuba" to neutralize the distorted American press.

"The New York Times", edition of January 11, 1961, reported that at a hearing conducted before the United States Senate Internal Security Subcommittee on January 10, 1961, Dr. CHARLES A. SANTOS-BUCH identified himself and ROBERT TABER as organizers of the FPCC. He also testified he and TABER obtained funds from the Cuban Government which were applied toward the cost of the aforementioned advertisement.

The November 23, 1963, edition of "The New York Times" reported that Senator THOMAS J. DODD of Connecticut had called FPCC "The chief public relations instrument of the CASTRO network in the United States." It is to be noted that Senator DODD was a member of the Senate Internal Security Subcommittee which twice conducted hearings on the FPCC.

The December 27, 1963, edition of "The New York World Telegram and Sun" newspaper stated that the pro-CASTRO FPCC was seeking to go out of business and that its prime activity during its lifetime had been sponsorship of pro-CASTRO street rallies and mass picket lines, and the direction of an active propaganda mill highlighting illegal travel-to-Cuba campaigns. Its comparatively brief span of life was attributed to mounting anti-CASTRO American public opinion, the 1962 Congressional hearings which disclosed FPCC financing by CASTRO's United Nations delegation, and ultimately, the bad publicity which the FPCC received from disclosure of activities on its behalf by suspected Presidential assassin, LEE H. OSWALD.

On February 18, 1970, ABBIE HOFFMAN was found guilty in the United States District Court, Northern District of Illinois, Chicago, Illinois, for violating the Federal Anti-Riot Law Statute for traveling in interstate commerce from outside the state of Illinois with intent to incite riots in Chicago, Illinois, during the Democratic National Convention in August, 1968. On February 20, 1970, he was sentenced to 5 years imprisonment and fined \$5,000. On February 28, 1970, the United States Court of Appeals, Seventh Circuit, Chicago, Illinois, ordered him released on \$25,000 bond pending appeal of his conviction.

NATIONAL EMERGENCY CIVIL LIBERTIES
COMMITTEE, Formerly Known As
Emergency Civil Liberties Committee

The "Guide to Subversive Organizations and Publications" of December 1, 1961, by the Committee on Un-American Activities, United States House of Representatives, describes the Emergency Civil Liberties Committee (ECLC) as an organization whose avowed purpose is to abolish the House Committee on Un-American Activities. It stated the ECLC was established in 1951, and "although representing itself as a non-Communist group, actually operates as a front for the Communist Party."

"The New York Times" issue of April 1, 1968, contained an article reflecting the ECLC was changing its name to the National Emergency Civil Liberties Committee (NECLC), "to reflect our determination to develop a vital civil liberties organization in all 50 states as rapidly as possible."

The March, 1970 issue of "Rights," a publication of the NECLC lists the business address of the NECLC at 25 East 26th Street, New York, New York.

PROGRESSIVE LABOR PARTY

The "New York Times" city edition Tuesday, April 20, 1965, Page 27, reported that a new party of "revolutionary socialism" was formally founded on April 18, 1965, under the name of the Progressive Labor Party (PLP), which had been known as the Progressive Labor Movement.

STUDENTS FOR A DEMOCRATIC SOCIETY

Students for a Democratic Society, commonly known as SDS, came into existence at a founding convention held during June, 1962, at Port Huron, Michigan. From an initial posture of "participatory democracy," Marxist-Leninist ideology of various shadings became predominant during 1968-1969 with debate centering on how best to create a revolutionary youth movement. SDS moved from involvement in the civil rights struggle to an anti-Vietnam war position to advocacy of a militant anti-imperialist line linking up the oppressed peoples of Asia, Africa and Latin America with the black liberation movement in the United States. All major factions within SDS embrace Marxism-Leninism and identify internationally with China, Cuba and North Vietnam as countries leading the worldwide struggles against the United States. However, the Soviet Union was regarded as imperialist and with the Communist Party, United States of America, "revisionist" in nature.

SDS operated under a national constitution which called for an annual National Convention (NC) and quarterly National Council meetings wherein programs were initiated and debated. Three national officers were elected annually with a National Interim Committee to run the organization. Regional offices and college chapters elected delegates to the national meetings but each functioned independently on local matters. Its official publication "Fire" (formerly "New Left Notes") last appeared in December, 1969.

Internal factionalism of serious proportions developed during 1968 - 1969 and the following three factions evolved as a result of a split at the June, 1969, NC: Weatherman, Worker Student Alliance (WSA), and Revolutionary Youth Movement (RYM). The effect of the split on SDS chapters throughout the country was divisive. Some aligned with one or the other of the three major factions. Others, unable to identify with any faction, disassociated with SDS completely and changed names.

The SDS national office in recent years was located at 1608 West Madison Street, Chicago, Illinois. It was closed in February, 1970.

The Weatherman and RYM groups no longer consider themselves associated with SDS, and the WSA group refers to itself as the true SDS.

Characterizations of Weatherman, WSA and RYM are set out separately.

WEATHERMAN

Initially called the "Action Faction," Weatherman came into being immediately before the June, 1969, Students for a Democratic Society (SDS) National Convention (NC). At this NC Weatherman won all three national officer positions and a majority of the National Interim Committee as well. Subsequently, they took over the SDS National Office (NO) in Chicago, and controlled its funds, paper and national records. Although internal struggle existed until late 1969, Weatherman for all major purposes controlled SDS nationally from June, 1969, until its NO closed in February, 1970. At this time it no longer considered itself part of SDS.

The term Weatherman emerged from an ideological paper prepared by its leaders entitled "You Don't Need a Weatherman to Know Which Way the Wind Blows" ("New Left Notes" June 18, 1969). This statement outlined the basic stance of Weatherman: Marxist-Leninist in content but with strong advocacy that action not theory would bring about revolution in the United States. This posture was complemented with an international identification to the Cuban revolution and CASTRO's statement that the duty of a revolutionary is to make revolution.

During October, 1969, Weatherman riots in Chicago resulted in more than 260 arrests for mob action and related charges. A program of armed struggle was finalized during a December, 1969, "War Council" wherein terrorist tactics and political assassination were contemplated. The basic strength of Weatherman was then revealed to be some 300 - 350 nationally and geographically apportioned to the Midwest, New York, and some Northwest.

As its rhetoric of violence escalated, Weatherman leaders increasingly discussed the necessity of an underground operation wherein more than 90 percent of the organization would be submerged; "affinity groups" of three - five members would function independently. In February, 1970, Weatherman leaders announced a program of "strategic sabotage" with police and military installations as primary targets.

In February, 1970, Weatherman abandoned the SDS NO, 1608 West Madison Street, Chicago, Illinois, and throughout the country entered an underground status.

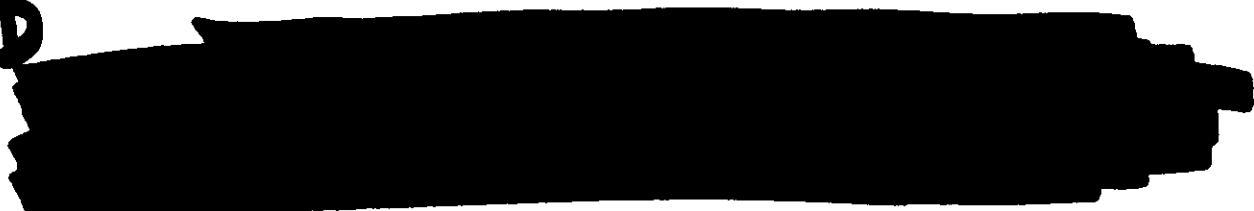

ABBOTT HOFFMAN was indicted March 20, 1969, for violation of Federal Anti-Riot Law for activity during the 1968 Democratic National Convention in Chicago, Illinois. HOFFMAN was found guilty and was sentenced to five years imprisonment and fined \$5,000. On February 28, 1970, the United States Court of Appeals, Seventh Circuit, Chicago, Illinois, ordered that he be released on \$25,000 bond, pending appeal.

ABBOTT HOFFMAN, on February 9, 1971, addressed the Dade County Young Lawyers at a luncheon held at the McAllister Hotel, Miami, Florida.

In his address, HOFFMAN discussed free speech and stated it is not generally known but that he is banned in between fifteen and twenty states in the country, including the "51st state, Canada". In Canada, he had the unique distinction of being the only person deported twice. HOFFMAN stated that other than that, we have a system that is based on repressive tolerance. We have a free speech but there is a "high glut". The average American is exposed to sixteen hundred commercials a day, and with such a system built on mass communication, the right of free assembly and free press has to be re-defined. One has to talk about ways to keep communications open to all people.

HOFFMAN stated he mentioned this because he has just written a book that had been rejected by thirty publishers on moral grounds.

HOFFMAN continued and stated a couple of years ago, he was invited to the "House Un-American Activities Committee" and wore a flag shirt that he had bought in a fashionable New York boutique. The police said he was under arrest for desecrating the American flag. This was interesting, because that night on the Ed Sullivan Show, PHYLLIS DILLER came on with a flag miniskirt and pranced around. HOFFMAN also said that he was "black~~ed~~ out" on the Merv Griffin Show, even though two weeks before, ROY ROGERS and DALE EVANS, on Hollywood Playhouse, wore the exact same shirts. HOFFMAN said he wore the shirt only as a symbol of our attitude toward all the 2,750,000 laws on the books in this country. It's not the act, but who's doing the act. "It's not what you do, but who's doing the what." The laws are there to protect the power and the property of the people.

HOFFMAN mentioned the time he returned to Canada with two immigration lawyers, because of the case against him up there. All of a sudden, it was "Yes, sir," and "Welcome back," the royal carpet treatment. When the lawyers came through the door, the whole scene changed. HOFFMAN remarked, "So you see what's going on."

HOFFMAN continued by saying that last year at this time, he was on trial in Chicago. He stated "they were actually sentenced and had the distinction of being sentenced before a verdict was returned." The trial was so weird and metaphysical, according to HOFFMAN, that not even the defendants knew whether they were innocent or guilty. HOFFMAN said it was the usual jury of our peers. If you looked at the jurors, you could in no way conclude they were from the same planet, let alone from the same peers.

HOFFMAN remarked that he did not know why anybody went to Chicago during the convention. He vaguely recalled it had something to do with criticism of the

political system. Yet the first thing they did in selecting the jury was they had to believe in the system enough to be registered to vote. HOFFMAN stated it was a political trial from the beginning to the end, and that there is no way to have a fair political trial in this country. HOFFMAN recalled when Attorney General RAMSEY CLARK was to testify. He volunteered to be a defense witness. The Government, however, contended that CLARK would tend to prejudice the jury in favor of the defendants.

HOFFMAN stated that when you think about it, the whole world knows that week in Chicago. He said there was no court in America where you could put Mayor DALEY and his kind of people on trial. He remarked that suppose you think Mayor DALEY was responsible, and asked, "Do you think any grand jury is going to indict him?" The law is there to protect the forces of order, not to guarantee the freedom of the people. Until that is changed, there will continue to be trials like the one we had in Chicago.

HOFFMAN stated that in the halls of justice in America, the only justice that can be found is out in the hall," and not just the hall, but also the streets, that we consider to be our courtroom. "When we were thrown in jail, half a million people conspired to cross state lines with the intention to incite a riot. The Bank of America got burned down and out we came." HOFFMAN mentioned that they have no illusions and that without the massive pull, without the demonstrations, they would be sitting in the Cook County Jail now.

"This week," HOFFMAN said, "I watched ALAN SHEPARD desecrate the flag by using it to sell 'Tang' orange juice. General ABRAHMS desecrated the flag by taking it into Laos. Desecration of the flag, like what is is to be an American, apparently is a state of mind."

Following his speech, HOFFMAN participated in a question and answer period. At the beginning, he stated that it was costing a lot of money to go to the Supreme Court and that if people wanted to help out in the legal aspect, they could write out a check to the Chicago Conspiracy Defense Fund.

The March 29, 1971, edition of the "Evening Star", a Washington, D. C. (WDC) daily newspaper, contained an article on Page A-4 entitled, "Court Rules Hoffman Didn't Desecrate Flag", and written by Barry Kalb. This article stated in part:

"The U. S. Court of Appeals today ruled that the flag-shirt worn by Yippie Abbie Hoffman to a 1968 congressional hearing did not constitute a desecration of the American flag.

"Hoffman was arrested outside the Cannon House Office building on October 3, 1968, as he was preparing to attend a hearing before the House Internal Security Committee:

"The hearings had been called to investigate the disorders surrounding the Democratic National Convention in Chicago less than two months earlier.

"Hoffman was wearing a shirt made of shiny material whose design resembled parts of the American Flag. On the shirt were pinned two buttons, reading, 'Wallace for President, Stand Up for America,' and 'Vote Pig - Yippie in Sixty-Eight.'

"Judge Charles Fahy, writing the unanimous opinion, ruled that congressional intent in writing the bill was clearly 'to condemn only physical mutilation, defacement or defilement of the Flag,' and that Hoffman's acts did not meet these descriptions.

"Considering appete's testimony as to his political views and ideology, we may well assume that the episode had a distinct flavor of scarcasm or mockery, with an added element of childishness in his playing of the yo-yo, but appete's performance to his audience did not include the physical injury to the material of the shirt essential to be proved beyond a reasonable doubt to support a conviction of the crime defined in the statute,' Fahy wrote.

"Judge George M. Mackinnon in one of two concurring opinions, said that a study of the original trial records shows a lack of any evidence to demonstrate a knowing casting of contempt upon the flag by Hoffman."

On April 7, 1971 [REDACTED] United States Court of Appeals, advised a representative of the FBI that the case of Abbie Hoffman versus the United States (Case Number 23514) in a unanimous opinion, was reversed and a judgment was entered reversing the judgment of the United States District Court.

[REDACTED] further advised that an order was entered on April 1, 1971, amending the opinion but that this amendment pertained only to form and did not affect the substance of the opinion whatsoever.

[REDACTED] stated that this appeal was based on Hoffman's conviction on December 20, 1968, in the Court of General Sessions, District of Columbia, on a charge of defiling the American flag by wearing a shirt resembling the flag.

OSU Protests Urged

Hoffman Says Antiwar Drive at Critical Point

STILLWATER (AP) - Terminating the next two weeks the most critical in the history of the antiwar campaign. Yippie leader Abbie Hoffman Wednesday night predicted troop rebellions in Vietnam and civil disobedience in Washington.

He urged an audience of about 2,500 at Oklahoma State University to join scheduled antiwar demonstrations in May, staging their own demonstrations in Stillwater if they cannot go to Washington.

On May 5, he said, "there will be strikes at universities and on May 5 there very damned well be strike (sic) at Oklahoma State University."

ON HIS arrival at Oklahoma City's Will Rogers World Airport, Hoffman had predicted the troop rebellions.

"Rebellion by armed units in Vietnam will begin in the next two weeks," he told newsmen. He added that antiwar leaders would be broadcasting encouragement over Radio Hanoi to urge American troops in Vietnam to rebel. He said tape recordings made in New York by his group will be broadcast to the troops.

Hoffman's appearance was without incident, although it had been delayed a year by a speaker policy that banned him from a scheduled talk on campus last year. A federal suit to overrule the policy was dismissed this spring because regents adopted a new policy which did not prohibit his appearance.

Hoffman is free on \$25,000 bond pending appeal of his conviction in connection with the riots at the Democratic national convention in 1968.

HE TOLD THE OSU audience there "is more to being a revolutionist than smoking grass and hanging a picture of Che Guevara on the wall," as he cautioned students about what drugs they use. He drew his biggest applause of the night when he told students to avoid all needle-injected drugs, adding "The only dope worth shooting is Richard Nixon."

Earlier in Oklahoma City, Hoffman said government officials have been harassing leftist leaders for the past few weeks, and he predicted that

all of the Chicago Seven defendants will soon be arrested, including himself, within the next two weeks.

He described Leslie Bacon, the 19-year-old girl arrested Wednesday as a material witness to the March 1 bombing of the nation's Capitol, as "one of the key organizers of the May Day demonstrations."

"ISN'T IT convenient," he added, "that four days before the demonstration, they arrest one of the key organizers?"

He said two FBI agents followed him to Oklahoma.

"They tried to revoke my bond several months ago when I was caught with a firebomb in Belfast (Ireland)," he said.

"But they couldn't. You know how our permissive court system is."

When he opened his talk, he held out a ring and told the audience:

"I have just come from having tea with the Viet Cong in Paris. Mme. Vinh gave me this ring made from an American plane which had been shot down."

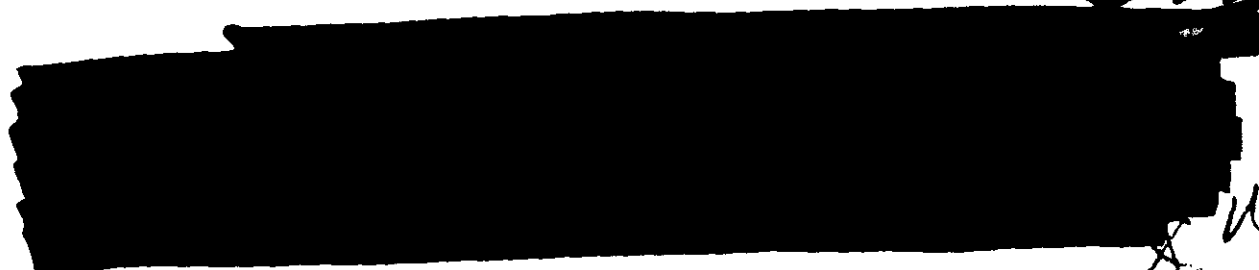

Antiwar Activists Say Protests Will Continue

Evening News Staff Writer

Leaders of the just-concluded antiwar protests in Washington said in Newark yesterday that the government can expect more of the same as long as the war in Indochina continues. In a press conference at Newark Airport, Rennie T. Davis, Abbie Hoffman and John Froines also predicted that the government would indict scores of protesters in the wake of demonstrations in Washington, but that the charges won't stick. They were accompanied by their lawyer, Leonard Weinglass of Newark.

"We've come to New York to set off a chain of events which will end the war," said the 30-year-old Davis.

The three men, who were defendants in the Chicago Seven trial, are under new indictments in connection with their activities in Washington and elsewhere. All are free on bail.

Hoffman said he expects "30 to 50 more people to be indicted as a result of the recent protests because the 'Nixon administration is attempting to blame us for all the ills of American society.'"

Sporting a bandage on his nose, the Yippie leader said the recent indictments are the result of Nixon administration attempts to suppress protest.

"A couple of years ago the Justice Department decided to put us in jail," Hoffman commented, adding, "They failed in Chicago so now they are trying again."

View on Protests

Contrary to most evaluations of the protests in Washington, the three last night said the activities were a giant success.

"What happened is the most momentous movement in the history of this country," said Froines, "young people have proved once again they are the cutting edge of the peace movement."

"People came out (of Washington) with an incredible sense of tenacity," he added.

The 30-year-old Davis, who is the leader of the Mayday Tribe, said that plans presently are being drawn to implement the second "Peoples Peace Treaty" in Washington within the next six to 10 weeks.

Hoffman, referring to the bandage over his broken nose which, he said he got it by assaulting a policeman's club with his nose in Washington.

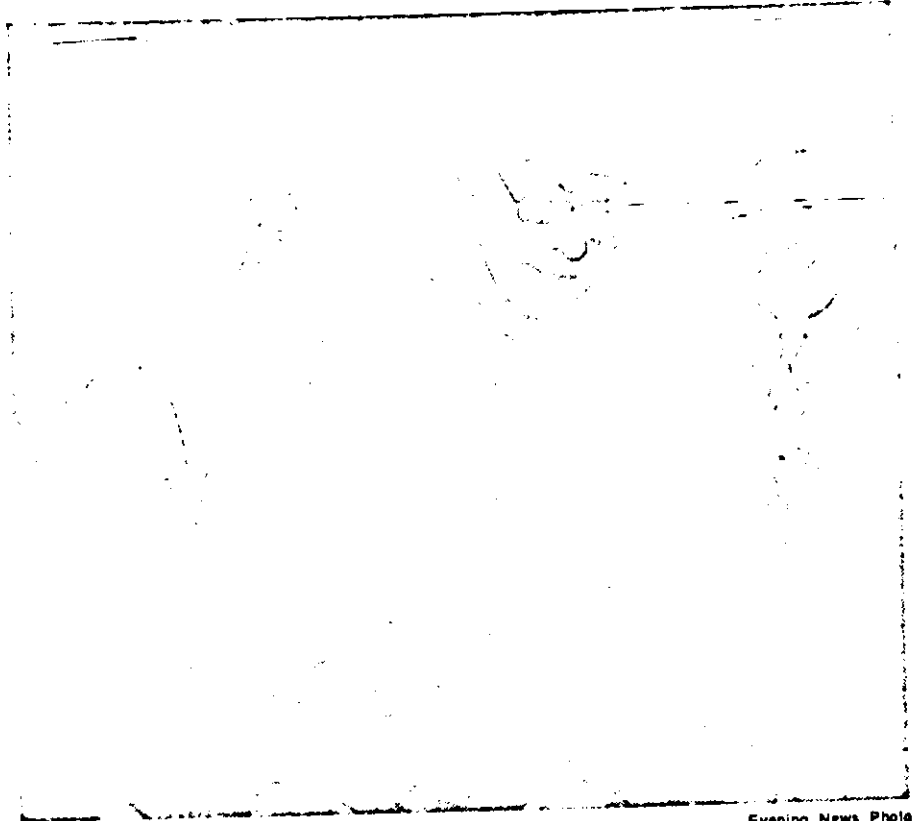
"We'll be back this summer in Washington," he said.

Davis, Hoffman and Froines, a 32-year-old former Chemistry instructor at the University of Oregon, were joined at the press conference by Weinglass who was a defense attorney during the six-month trial in Chicago.

Davis and Hoffman were convicted in the trial of inciting to riot during the 1968 Democratic convention and Froines was acquitted. All are appealing contempt of court citations.

Rennie and Abbie say protesters won in D.C.

A second attempt to implement the "Peoples Peace Treaty" was promised last night at Newark Airport by Rennie Davis, a spokesman for the antiwar demonstrations just held in Washington.

Accompanied by University of Oregon professor John Froines, Yippie leader Abbie Hoffman and attorney Leonard Weinglass, Davis claimed "the government suffered defeat by the demonstrations in Washington," and there would be a national conference of antiwar groups to plan a second attempt to implement the peace treaty and end the war.

Hoffman also predicted that 30 to 50 antiwar activists will be indicted soon as a result of a grand jury just empaneled in Washington, D.C.

"Grand juries are rubber stamps," Hoffman charged. "We expect more charges. The government can't accept the fact that it is morally and politically bankrupt."

Froines, Hoffman and Davis who are free on bail in the Chicago Seven conspiracy trial in 1968, are also out on bail after being arrested on charges stemming from the Washington demonstrations.

Hoffman, however, said the charges stemmed from speeches all three made, and not their part in the demonstrations.

Davis and Froines were both arrested on civil rights charges of interfering with citizens' constitutional rights and for violating a federal law against interfering with government workers.

in Washington and is free on \$20,000 ~~cash~~. He was arrested late Wednesday in the hallway of his New York apartment by FBI agents on a warrant issued by Judge Burnett.

The warrant charged that between April 29 and May 3, Hoffman traveled to Washington from outside the district "with intent to incite, organize, promote, encourage, participate in and carry out a riot."

An affidavit by an FBI agent, attached to the warrant, cited a speech Hoffman made at the University of Oklahoma in Norman, where he was quoted as saying the D.C. demonstrations would "make Chicago in 1968 look like a YAF (the conservative Young Americans for Freedom) meeting."

Last night Hoffman sported two small bandages on his nose which his wife explained was broken during the Washington demonstrations.

Hoffman is also charged with assault for allegedly threatening a Washington policeman with a board during attempts to tie up commuter traffic Monday.

"I'm also charged with assaulting a policeman's nightstick with my nose," Hoffman laughed last night.

Although demonstrators' attempts to "close down the government" failed to do more than tie up traffic during rush hour on Monday, Froines declared again last night, "We're going to shut down the government."

He described the series of demonstrations as a "most momentous event."

Hoffman went him one further.

"It was the greatest event since we demolished the Democratic Party in '63," he declared, referring to the

demonstrations and violence during the Democratic Convention in Chicago which led to the conspiracy charges against the Chicago Seven.

Although all three men insisted the "government lost" in the week-long confrontation with antiwar demonstrators, they wouldn't explain how they arrived at that conclusion, since the government had prevented them from obtaining their main objective — forcing government offices in the Capitol to shut down.

After making his statement last night, Davis was pressed on this point but wouldn't answer after Hoffman whispered in his ear. "We hold the press conference, not the press."

Davis did explain, "We went to Washington to demonstrate the possibility of non-violent tactics. The American people begin to resist the government. The time has come for Americans to say, 'We are not going to be good Germans'."

He said demonstrators tried to impress upon government workers who were angry over a two-hour traffic jam as they went to work that, because of the war, "a million Vietnamese will never go to work again."

Davis admitted later that in one respect, the demonstrations failed, because the concept of a "Peoples Peace Treaty" was lost as the media concentrated on the demonstrators' tactics.

Davis and Froines had taken a flight from Washington to Newark to meet with Weinglass and Hoffman, who was en route to Chicago.

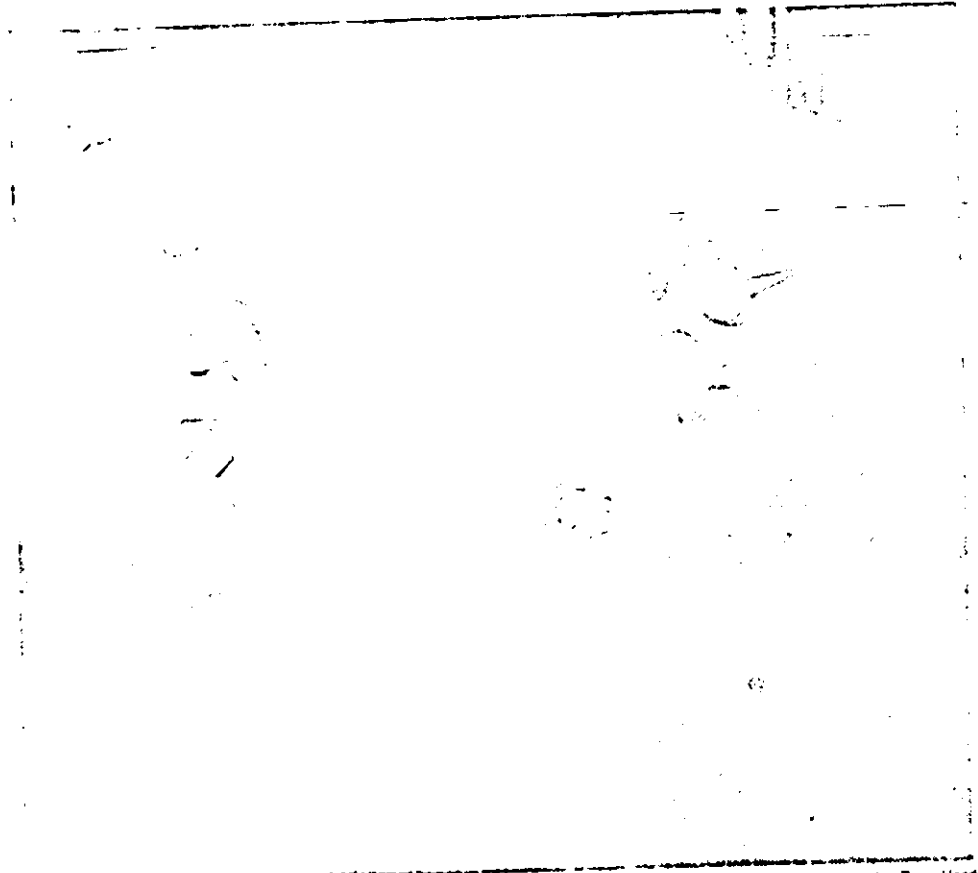
When asked what they discussed with Weinglass, the much-arrested Hoffman replied with a smile, "Bribes, bribes for the attorney general."



STILLWATER (AP) — Terminating the next two weeks the most critical in the history of the antiwar campaign, Yippie leader Abbie Hoffman Wednesday night predicted troop rebellions in Vietnam and civil disobedience in Washington.

He urged an audience of about 2,500 at Oklahoma State University to join scheduled antiwar demonstrations in May, staging their own demonstrations in Stillwater if they cannot go to Washington.

On May 5, he said, "there will be strikes at universities and on May 5 there very damned well be strike (sic) at Oklahoma State University."

ON HIS arrival at Oklahoma City's Will Rogers World Airport, Hoffman had predicted the troop rebellions.

"Rebellion by armed units in Vietnam will begin in the next two weeks," he told newsmen. He added that antiwar leaders would be broadcasting encouragement over Radio Hanoi to urge American troops in Vietnam to rebel. He said tape recordings made in New York by his group will be broadcast to the troops.

Hoffman's appearance was without incident, although it had been delayed a year by a speaker policy that banned him from a scheduled talk on campus last year. A federal suit to overrule the policy was dismissed this spring because regents adopted a new policy which did not prohibit his appearance.

Hoffman is free on \$25,000 bond pending appeal of his conviction in connection with the riots at the Democratic national convention in 1968.

HE TOLD THE OSU audience there "is more to being a revolutionist than smoking grass and hanging a picture of Che Guevara on the wall," as he cautioned students about what drugs they use. He drew his biggest applause of the night when he told students to avoid all needle-injected drugs, adding, "The only dope worth shooting is Richard Nixon."

Earlier in Oklahoma City, Hoffman said government officials have been harassing leftist leaders for the past few weeks, and he predicted that

all of the Chicago Seven defendants will soon be arrested, including himself, within the next two weeks.

He described Leslie Bacon, the 19-year-old girl arrested Wednesday as a material witness to the March 1 bombing of the nation's Capitol, as "one of the key organizers of the May Day demonstrations."

"ISN'T IT convenient," he added, "that four days before the demonstration, they arrest one of the key organizers?"

He said two FBI agents followed him to Oklahoma.

"They tried to revoke my bond several months ago when I was caught with a firebomb in Belfast (Ireland)," he said.

"But they couldn't. You know how our permissive court system is."

When he opened his talk, he held out a ring and told the audience:

"I have just come from having tea with the Viet Cong in Paris. Mme. Vinh gave me this ring made from an American plane which had been shot down."

The remark drew applause.

Twins, 3, Suffocate In Old Refrigerator
