Secret Service Security Measures

On September 17, 1968, LILBURN BOGGS, Special Agent in Charge, United States Secret Service, Chicago, Illinois, was interviewed concerning security measures considered necessary by Secret Service during the Democratic National Convention (DNC) in Chicago, Illinois, in August, 1968, and furnished the following information:

The U.S. Secret Service had the duty under the law to protect a number of candidates for nomination by the Democratic Party for the office of President of the United States during the DNC. In pursuance of this duty Secret Service cooperated with the National Guard, the Chicago Police Department and other law enforcement agencies to arrange the necessary security. Secret Service had seen a number of reports of such serious nature concerning the possibility of harm to candidates for the nomination that no doubt whatsoever existed that extensive security precautions were necessary.

Beginning on August 24, 1968, the U.S. Secret Service "secured" the Amphitheatre and the immediate area. By this, he said he meant that a "bomb sweep" was conducted and all appropriate searches made and thereafter, the Amphitheatre was placed under a security guard.

Security precautions were not only necessary at the Amphitheatre and its immediate vicinity but were necessary elsewhere in the city for the purpose of securing ingress and egress for candidates for nomination to and from the Amphitheatre and further, to secure their temporary residences in downtown Chicago hotels.

In connection with security arrangements to be in effect during the DNC, the City of Chicago inquired whether in the judgement of the Secret Service a march of demonstrators to the Amphitheatre would constitute a threat to those persons being protected by the Secret Service. The Secret Service responded that in its judgement such

A march by demonstrators would unquestionably jeopardize the safety of the candidates for the nomination. Secret Service further recommended that the City of Chicago should not waive any law, regulation or injunction currently in force to control marches and demonstrations in the city with one exception which concerned whether a demonstration should be allowed to divide and march at the same time in two or more groups instead of one. Such division of demonstrators crowds would not be considered objectionable by Secret Service.

With specific reference to the march led by GREGORY on August 29, 1968, Grant Park to 18th and Michigan Avenue where the march was halted by police and the Illinois National Guard, Mr. BOGGS said that those authorities acted with the full support by the Secret Service in halting the march at that point. To have allowed that march, which obviously contained people hostile to Vice President HUBERT H. HUMPHREY who had the night before been nominated for President by the Democratic Party, would have been a breach of necessary security precautions. Mr. BOGGS said concerning the march led by GREGORY that he himself had heard GREGORY speak in Grant Park on August 29, 1968, prior to the beginning of the march. He heard GREGORY say that he was going to his home and was inviting the crowd of demonstrators to accompany him. He also heard GREGORY say that when they got to GREGORY's house, those in the crowd who wanted to "could go west" to use GREGORY's words. Mr. BOGGS said that west from GREGORY's house would obviously have been in the direction of the Amphitheatre where the final session of the DNC was in progress. Such a march to GREGORY's residence or to an area close to the Amphitheatre by the demonstrators could not be allowed for security reasons. The Secret Service was concerned not only with the necessity of protecting the Amphitheatre itself from possibly hostile demonstrators but also was concerned that if the march was admitted near the Amphitheatre, there would be a number of possibly hostile demonstrators in a position to stop the Secret Service motorcade, in which the Vice President would be traveling. Mr. BOGGS said that even a few persons could block a motorcade which when halted is, of course, more vulnerable to attack by anyone wanting to do so.

With reference to security arrangements at the Conrad Hilton Hotel on August 28, 1968, when demonstrations occurred in front of the hotel and on other days during the DNC, Mr. BOGGS said that several candidates for nomination by the Democratic Party were staying at the Conrad Hilton Hotel during the DNC. These candidates included Vice President

HUMBERT HUMPHREY, Senator EUGENE MC CARTHY, and Governor LESTER MADDOX of Georgia. Before the convention selected its nominee, all of them were being protected by the Secret Service. Obviously, maintenance of proper security at the Conrad Hilton Hotel required that the police and National Guard prevent that hotel from being taken over by demonstrators.

[redacted], advised that a young girl of approximately 22 or 23 years of age named BEVERLY BAYSINGER occupied an apartment at 1717 North Hudson. She stated she was not certain but thought that she was probably attending school. She advised, however, that several days before the beginning of the National Democratic Convention at Chicago she observed numerous individuals whom she concluded were "yippies" entering and departing from the BAYSINGER apartment. She stated she later learned that many of the individuals camped on the floor of the apartment and used all available space there during the Democratic Convention.

[redacted] advised that although she never met ABBIE HOFFMAN in person she had observed his picture on numerous occasions through the local news media. She stated that as a result of her observations she is certain that she observed ABBIE HOFFMAN entering and departing from the BAYSINGER apartment on numerous occasions.

[redacted] She stated she had no opportunity to hear any remarks made by these individuals bearing on planned violence or disruption in the City of Chicago during the National Democratic Convention.

On August 28, 1968 [redacted]

At approximately 8:45 a.m., while patrolling in the vicinity of Wisconsin and Lincoln Avenues they were hailed by an unknown woman standing at a bus stop on Lincoln Avenue. This woman, whose identity he did not determine, told him that she had just seen a "beatnik" walk by her with an obscene word painted on his forehead. She said this person had walked southeast on Lincoln Avenue and had entered the Lincoln Hotel Restaurant.

[redacted] parked the squad car and entered the Lincoln Hotel Restaurant at 1819 North Wells Street. In the restaurant they observed two men and two women occupying a booth.

[redacted] walked up to this group and observed that one of the men was wearing a tan colored sombrero type hat. He asked this individual what he had on under his hat. This man removed his hat with a grin and the obscene word "F----" was printed on his forehead in at least two inch letters with what appeared to be a red marking pencil. In addition, this individual had a large letter "Y" printed on each cheek. [redacted] informed this man that he was under arrest for disturbing the peace. At this point this individual appeared to become very frightened and nervous as [redacted] noticed his hands to tremble.

This individual told [redacted] that he wanted to finish his breakfast before submitting to arrest and in response to this [redacted] took this individual by force out of the booth and handcuffed him on the spot. One of the unknown females in the

booth claimed to be married to the individual under arrest and she kept holding his arm to keep him in the booth. [REDACTED] told this female to release her husband's arm or she would be arrested. This female then released the individual's arm and [REDACTED] removed the arrested person from the restaurant and placed him in their squad car. He did not learn the names of the two females and the one male in the booth with the arrested individual.

When the arrested person was placed in the squad car the arrested person asked "Do you know who I am? You guys got number one--the big cheese." This person then said that he was ABBIE HOFFMAN, a "revolutionary artist" from New York City who was residing in Chicago in Lincoln Park. HOFFMAN said that he had been arrested 22 times around the country but this was the first arrest in Chicago. [REDACTED] asked HOFFMAN how he was able to write the obscene word so neatly on his forehead and HOFFMAN said his wife printed it on his forehead. HOFFMAN also said the reason he was so frightened when placed under arrest was that he was afraid the police officers were there to kill him since he had recently received numerous threats on his life.

HOFFMAN was transported to the 18th District and booked on state charges of resisting arrest and disorderly conduct and city charges of resisting arrest. [REDACTED] said HOFFMAN has not as yet appeared in local court in answer to these charges.

[REDACTED] stated that he could not recall HOFFMAN making any other statements to him. He added that at the 18th District he had HOFFMAN photographed while the obscene word was still on his forehead.

follows:

He was in Grant Park, across from the Conrad Hilton Hotel, shortly after noon, August 29, 1968, on the occasion of a number of speeches being made by various persons who were in the large crowd of demonstrators at that location at that time. Various speakers appeared to be taking their turn, one of whom was ABBE HOFFMAN, the Yippie leader from New York City. HOFFMAN thanked the people of Chicago for being so polite in welcoming the demonstrators. He also thanked the participants in the various demonstrations for their support, even though they had not got their pictures on the front pages of the newspaper as had he. He liked to see his picture in the newspapers, this was why he had written (obscene) on his forehead. He advised the Yippies had come to Chicago to nominate a pig and had been successful, since a pig was nominated. There were some five hundred to a thousand persons in the crowd at this time; however, the crowd was in motion and many people were obviously curiosity seekers.

No further remarks of HOFFMAN were recalled and he was not overheard making any public remarks on any other occasions.

[redacted] Special Agent, Region I, 113th Military Intelligence Group, 1819 West Pershing Road, Chicago, Illinois, advised he was assigned to work undercover during the Democratic National Convention (DNC) in Lincoln Park and Grant Park, Chicago.

He stated that during the week prior to the DNC the National Mobilization Committee held training sessions in Lincoln Park, mostly for the marshals scheduled to participate in the demonstrations to be held during the DNC. RENNIE DAVIS was observed quite often during these training sessions and the general theme was to "cool it" until August 28, 1968.

He said that they had a very thorough first aid course, teaching them how to protect themselves from gas attack, how to stop bleeding, and how to care for broken bones. They were told there would be medical people present to help those injured during the DNC and they had first aid centers set up throughout the city, one of which was close to the Amphitheater.

They were taught non-violent self-defense. They were told to do what they wanted to a policeman and then fall to his feet and leave it to his morality as to what he would do to you. He could not recall who made that statement.

The National Mobilization Committee had legal principle classes. They were told who to contact for help, who to call in case they were arrested, and were advised to be sure and get the badge number of a policeman if arrested.

On one day, early in the week of the DNC, BOBBY SEALE spoke in Lincoln Park and was very emphatic in his speech. He told the crowd "Go home and get your guns, be revolutionary and barbeque a pig". He said that "If you are going to be a revolutionist, be one and die for it".

During the afternoon of Saturday, August 28, 1968, DAVID DELLINGER spoke at Grant Park. DELLINGER said that they were going to march out of there because their request to march had been turned down. He said he would lead a peaceful march attempting to go to the Amphitheater.

DICK GREGORY spoke and attacked Mayor DALEY for not letting the peaceful kids march and for the way he treated the kids who came from out of town. He said the Police Department is under paid and he welcomed the policemen to come over to his side. He said he would be going on a non-violent march.

NORMAN MAILER said a few words stating he is working on a manuscript and could not take time off to go to jail, but his heart was with the demonstrators.

[redacted] was interviewed at the Chicago Office of the Federal Bureau of Investigation. He furnished the following information:

During the period immediately preceding the 1968 Democratic National Convention, he was assigned to gather intelligence information on subversive or disruptive groups and individuals who were gathering in Chicago during this convention in Lincoln Park, Chicago, Illinois. His tour of duty during this period was from 2:00 a.m. to 2:00 p.m. from August 23, through August 30, 1968.

While on duty in Lincoln Park, he frequently saw an individual he identified from a photograph as ABBOTT HOFFMAN, beginning on August 23 or 24, 1968. During this period, HOFFMAN was primarily engaged in making statements to the press and organizing with groups of leaders of the demonstrators. He was likewise engaged in addressing smaller groups of demonstrators in Lincoln Park, telling them the plans for the day. On one occasion, he overheard HOFFMAN speaking to a group of individuals wherein he was referring to information in the newspapers concerning the makeup of the demonstrators arriving in Chicago. His statement was "They say we are Communists. So what."

[REDACTED] Chicago Police Department, 11th and State Streets, Chicago, advised that he was assigned to work on a physical surveillance of ABBIE HOFFMAN during the Democratic National Convention (DNC). [REDACTED]

He stated that the only time he observed HOFFMAN incite a crowd was on Sunday, August 25, 1968, at Lincoln Park. At about 6:00 pm on that date, HOFFMAN and other individuals, including JERRY RUBIN and ED SANDERS, wanted to use a flat-bed truck for a stage for their Yippie Music Festival in Lincoln Park. The police would not allow them to bring the truck in to the park. HOFFMAN then ran up and urged a huge crowd to help in driving the truck through the Police barricade. They finally decided not to use the truck and this was the only time he heard HOFFMAN attempt to incite a crowd.

On August 26, 1968, HOFFMAN advised a group of 30 or 40 people at 1800 Stockton Avenue, Chicago, that demonstrators were needed at the Chicago Transit Authority barn at Diversey Avenue and Clark Street, Chicago. He did not go himself but he got several people to march there.

HOFFMAN told the surveilling Agents that it was all right for them to be with him and indicated that he considered them to be his bodyguards. But he stated to them "the 28th belongs to us. We are going to tear up the city and march." He made it a point to advise the Police officers that he was "on the outs" with JERRY RUBIN.

He advised that HOFFMAN would meet with two, three or four people, get them organized and then go organize another group. HOFFMAN appeared to be a coordinator but never appeared before a large group.

During the afternoon of August 25, 1968, JERRY RUBIN got the crowd in Lincoln Park riled up and had them march down Clark Street to a bridge on the north side of the Loop in Chicago. RUBIN, as usual, urged the group on

and then moved to the rear.

HOFFMAN resided at 1437 West Belmont Avenue, Chicago, and at 1717 North Hudson Avenue, second floor, Chicago, while here for the DNC. The landlord at 1437 West Belmont Avenue, objected to the Yippies who were congregating and asked them to leave. HOFFMAN then went to 1717 North Hudson Avenue to reside.

HOFFMAN spent quite a bit of time at National Mobilization Committee headquarters, 407 South Dearborn Street, Chicago. In the afternoons he usually would go to his apartment at 1717 North Hudson Avenue, for a siesta.

He advised that ED SANDERS, from New York City, was the "money man" for the Yippies. He had a room at the Lincoln Hotel and was observed with HOFFMAN on several occasions, but did not make any speeches.

He said that the day HOFFMAN was arrested, August 28, 1968, HOFFMAN left the Police Department, 11th and State Streets, at 8:30 pm, and, to his knowledge, did not participate in the demonstration at Balbo and Michigan Avenue, Chicago, that evening.

Due to his surveillance, he, on several occasions, talked with HOFFMAN and [redacted] on one occasion, which he believes to have been on August 22, 1968, HOFFMAN made the statement to him that no one would ever make a conspiracy case between HOFFMAN and RUBIN because they have a "thing" going and they are not talking with each other. [redacted] stated that RUBIN was JERRY RUBIN, another leader of the "Yippie" movement who was also in Chicago. [redacted] got the impression that HOFFMAN made this statement to him in an attempt to make him believe that HOFFMAN and RUBIN were not communicating with each other. [redacted] stated, however, that during the times which he was able to observe HOFFMAN, he is sure that HOFFMAN and RUBIN were communicating with each other by notes which were being carried back and forth by an individual whom he identified as BRADFORD FOX. He stated that FOX resided at 1725 Buckingham during the time he was in Chicago and that he drove a motorcycle, bearing 1968 Illinois License 8349B. [redacted] stated that after checking vehicle registration records, it was determined that this license was registered to a 1966 Brigstone, which is owned by Ken Brown's Leasing, Limited, 1261 North Wells.

[redacted] further advised that on another occasion when he was talking to HOFFMAN, HOFFMAN told him that he knew they could never disrupt the convention or get to the Amphitheater and that the best they could hope for was to cause newspaper publicity so that everybody would know they would need armed guards in order to hold the convention in Illinois.

He stated that on Sunday, August 25, 1968, he saw ABBEY HOFFMAN in Lincoln Park talking to a group of persons whom he described as being "hippies" or "yippies". He remarked that he was not close enough to this group to overhear their conversation.

# Yippies coming --by freeway all the way!

By Lynn Langway

Abbie Hoffman is a punhandling pro who probably could freeload his way through a loan shark convention.

But he's staying small, with the Democrats and Chicago, as one of the members of a sort of non-group (no meetings, rules, officers or secretaries), the Youth International Party.

"I consider myself an urban planner," says Hoffman, who has moved here temporarily from New York, to find hand-outs for the flower children expected Aug. 27-30 for the Democratic Convention.

"I don't know. Chicago's more uptight than New York, but we'll make out. Somebody gave us 100 pounds of soy-beans today," he says triumphantly. "Now we're working on recipes."

Like your more orthodox experts, Hoffman has written a book about his specialty. But you can't buy it—it's a give-away—and if you ask for it by name in some places, you might get arrested for disorderly conduct. (It's called "F-- The System," without the dashes.)

"I was going to call it 'Free New York,' but you gotta admit 'F-- The System' has a more McLuhanesque impact," says Abbie the author, a Shirley Temple-coiffed, Brandeis and Berkeley product who is either 29, 30, or 31, depending on when you ask.

THE 30-PAGE BOOKLET tips off the penniless to free food at city wholesale markets and supermarket backyards ("If you want to be really professional, dress as a priest and go over and ask"); bus rides ("get on with a large denomination bill just as the bus is leaving"); bread, edible and spendable ("Cptown guys with dates are the best touch, especially if they are just leaving some guilt movie like 'Guess Who's coming To Dinner,'" ) and such other life-sustainers as free buffalo.

"In order to keep the herds at a controllable level," Abbie says, "the government will give you a reel, five minutes if you can guarantee shipping expenses and adequate grazing area. Write to the Office of Information, Department of the Interior, Washington, D.C."

"Like those poor guys have gotten about 200 letters," Abbie says cheerfully in his Massachusetts-flattened voice.

"They didn't tell me you were supposed to be an institution, not a person, to get a buffalo, but that's typical of the system."

Abbe is usually a system-bucker, but the booklet does dispense sermons on venereal diseases and bad "trips"—particularly those from methedrine, the amphetamine known as "speed."

"Don't get hooked on any drug, whether it be heroin, school, Coca-Cola, benzedrine, suburbia, meth or politics. They can all rot your brain," he admonishes.

"If you really want to live for free, get some friends together and seize a building at Columbia University; the cops come free, as do blue ribbon committees with funny long names."

HOFFMAN WILL BE distributing between 5,000 and 10,000 copies of his new yipie guidebook in Chicago, and hopes to do another on local angles for the "maybe 100,000" yippies he thinks will congregate here for a "festival of life."

"Some of 'em are ridin' their own buses and some are comin' with the Resistance and mobilization of McCarthy, and like that.

"They got a message, that's why they're goin'. We are the message. Dressed like this, with our hair, when we walk by the delegates say, 'There goes one of them,'" says the former SNCC worker, who favors early thrift-shop haberdashery and one gold earring for public appearances. "We'll be livin' in Chicago as an illustration of how middle-class white society makes people take off. Yipie isn't a group, it's a slogan, it's something to yell, it gives the participatin' mystique, you belong.

"We're sayin' conventions are archaic, come over to the (Lincoln) park and see what we're doin'," Hoffman explained before leaving Manhattan, where the Yippies run a leaflet-strawed, somebody-pays-the-rent-but-we-don't-know-who office in the Commercial Traders' building on Union Square.

The phone (three extensions, yet) keeps ringing after he leaves, with callers eager to carry the pink-and-purple Yipie standard to Chicago, willing to test the Hoffman theory that everybody and everything is free.

[redacted] stated that Continental Air Transport Company, Incorporated, has two supervisors one of whom supervises the day shift and whose office is at 27 East Monroe Street, Chicago, and the other who supervises the [redacted] from an office located at O'Hare International Airport, [redacted] stated the [redacted] for August 28 and 29, 1968, was [redacted] who prepared the day shift tour of duty reports for the hours 9:30 a.m. to 7:00 p.m. The [redacted] for August 28 and 29, 1968, was [redacted] whose shift was from [redacted]

[redacted] advised the day shift tour of duty report for August 28, 1968, prepared by [redacted] contains a notation under the heading "Service Irregularities" that during his shift there were "...heavy delays around the Hilton Hotel due to the yippie demonstrations..."

The evening shift tour of duty report prepared by [redacted] for the hours 4:30 p.m. to 2:00 a.m. contains a notation under the heading "Passenger Service Irregularities", "7:50 p.m. - no Hilton or Congress service - Palmer House only on south loop segment. Hippie rioting." Under "General Comments" is a notation "Rioting still going on as of 2:00 a.m. - reroute still in effect."

The day shift tour of duty report for August 29, 1968, prepared by [REDACTED] for the hours 9:30 a.m. to 7:15 p.m. contains a notation under "Service Irregularities" that "...delays up to 45 minutes from the Hilton due to the yippie demonstrations - running time two hours due to heavy traffic on the expressway and Loop areas..." The evening shift tour of duty report for August 29, 1968, prepared by [REDACTED] for the hours 4:30 p.m. to 2:00 a.m. under "Passenger Service Irregularities" contains a notation "10:45 p.m. - service to Congress and Hilton stopped because of rioting" and under "General Comments" the notation "Congress service resumed at 4:00 a.m. Loop supervisor will check for Hilton service to resume..."

[REDACTED] stated that the Palmer House, Pick-Congress and Conrad Hilton Hotels are grouped as the south segment of the downtown bus service from downtown Chicago to and from O'Hare Airport and Midway Airport and this was the segment of the Continental Bus Service which was disrupted since the buses had to be rerouted which, therefore, eliminated the Pick-Congress and Conrad Hilton passenger pickups and deliveries. This disruption occurred as a result of the demonstrations which occurred in that area on August 28, 29 and 30, 1968.

[REDACTED] made available the published schedule of the Continental Air Transport Company and stated this schedule was in effect throughout August, 1968. This schedule reflects that buses were scheduled to leave the Pick-Congress, Conrad Hilton and Palmer House Hotels for O'Hare Airport every 15 minutes from 7:00 p.m. to 10:00 p.m.; every 30 minutes from 10:00 p.m. to 1:00 a.m.; and every 60 minutes from 1:00 a.m. to 5:00 a.m. Buses were scheduled to depart from the Palmer House Hotel with stops at the Pick-Congress and Conrad Hilton one hour prior to flight time for flights leaving from Midway Airport. On the return trip from O'Hare Airport to Chicago's downtown area, buses were scheduled to deliver in-bound

passengers at the Pick Congress and Conrad Hilton Hotels every 15 minutes from 6:00 a.m. to 8:00 a.m.; every 12 minutes from 8:00 a.m. to 2:00 p.m.; every 10 minutes from 2:00 p.m. to 7:00 p.m.; every 12 minutes from 7:00 p.m. to 11:00 p.m.; and meet each in-bound flight from 11:00 p.m. to 6:00 a.m. Buses meet each in-bound flight at Midway Airport.

[redacted] also made available the original trip sheets prepared by the Continental Air Transport Company agents at the Conrad Hilton Hotel for August 28, 29, and 30, 1968. [redacted] explained that a trip sheet is a company record which is used to record the number of passengers who board the buses at the various stops. Continental Air Transport Company, Incorporated, maintains an agent on duty at the Conrad Hilton Hotel on a daily basis for two shifts which are from 6:00 a.m. to 2:00 p.m. and from 2:00 p.m. to 10:00 p.m. These agents have the duty of preparing the trip sheets which reflect the number of passengers who board the buses at the Conrad Hilton and Pick-Congress stops.

[redacted] advised the trip sheet prepared by [redacted] for the 2:00 p.m. to 10:00 p.m. shift on August 28, 1968, reflects that the last Continental Air Transport Company bus picked up passengers at the Conrad Hilton Hotel at 7:50 p.m., on August 28, 1968. [redacted] stated that from the trip sheet prepared by [redacted] on August 28, 1968, service to and from the Conrad Hilton and Pick-Congress Hotels was disrupted at 7:50 p.m. and no buses were able to load or unload at either the Conrad Hilton Hotel or the Pick-Congress Hotel after that time as a result of the demonstrations occurring in the Chicago Loop that date. August 29, 1968, reflects that as of 6:55 a.m. service to O'Hare Airport resumed. The trip sheet prepared by [REDACTED] on August 29, 1968, for the hours 2:00 p.m. to 10:00 p.m., reflects service was disrupted at the Conrad Hilton and Pick-Congress Hotels as of 9:35 p.m., as a result of demonstrations occurring in Chicago's Loop on that date. The trip sheet prepared by [REDACTED] on August 30, 1968, for the 6:00 a.m. to 2:00 p.m. shift reflects that service was resumed to O'Hare Airport at 6:35 a.m. on August 30, 1968. [REDACTED] stated that the large number of passengers (40) which left the Conrad Hilton at 6:35 a.m. would indicate that this bus was the first bus to pick up passengers at the Conrad Hilton that morning for O'Hare Airport.

[REDACTED] stated that from the published schedule in effect during August, 1968, as compared to the trip sheets and the supervisors' tour of duty reports for August 28, 29 and 30, 1968, according to his best figures bus service of the Continental Air Transport Company from the Conrad Hilton and Pick-Congress Hotels to O'Hare Airport and Midway Airport was terminated from 7:50 p.m. on August 28, 1968, to 6:55 a.m. on August 29, 1968; and from 9:35 p.m. on August 29, 1968, to 6:35 a.m. on August 30, 1968. [REDACTED] stated, therefore, approximately 21 scheduled bus pickups of passengers at the Pick-Congress and Conrad Hilton Hotels for transport to O'Hare International Airport were not made during the evening and early morning hours of August 28-29, 1968; and approximately 12 scheduled bus pickups of passengers for O'Hare International Airport were not made during the evening and early morning hours of August 29-30, 1968. In addition a number of passenger pick-ups for Midway Airport were not made during these periods. In-bound passenger service from O'Hare Airport and Midway Airport also was unable to discharge passengers at the Conrad Hilton and Pick-Congress Hotels due to the rerouting as a result of the demonstrations.

In accordance with your instructions, the following is a brief resume concerning the activities of this department and interruptions of service on the Chicago Division.

In view of the possibility of trouble as a result of agitators being in the city for the Democratic convention, necessary precautions were taken by cancelling all days off for personnel of this department and assigning our personnel to 12-hour shifts beginning August 24. Additional help was ordered in from other divisions consisting of 16 men who started 12-hour shifts on August 25.

Routine patrols and protection were maintained until August 28; at which time, in view of the rally held in the Band Shell in Grant Park and the subsequent demonstration, most of our personnel were assigned between Randolph Street and 18th Street. As a result of the demonstrations on this date, it was necessary to occupy our radio Channel No. 1 frequency exclusively for use of this department due to the numerous incidents. This resulted in a slow down of switching operations as the crews who normally use this channel were required to handle by hand signals and telephone. It was also necessary to block our suburban bridge at 12th Street which leads from the west side at Michigan Avenue of our right of way to the east side at Outer Drive opposite the band shell in Grant Park. This was necessary as the bridge was not built to withstand the traffic which would have used this facility, as the City authorities had blocked their bridge just north of ours and were directing all the public to cross our tracks at Balboa Drive to control the mob. Due to this necessary precaution, this resulted in an inconvenience to our passengers as we were not able to determine the passengers from those just desiring access to the bridge. This precaution was necessary from 2 p.m. until 11 p.m. that night.

At about 6 p.m. we received a report that demonstrators were throwing stones and other debris in the Congress Street Yard area. Furthermore, some of the demonstrators were climbing on the equipment adjacent to the east wall of our Congress Street Yard necessitating extra precaution on the part of our crew in the area to avoid personal injury, and I had to dispatch personnel to evict these people.

At 6:30 p.m. a switchman complained of being sick as a result of tear gas used in the area and reported off duty. This resulted in a two-hour delay to this crew waiting for replacement.

At 7:30 p.m. due to the increase of activity in the Congress Street area, it was necessary to remove our switch crew until approximately 8:15 p.m. This was a result of their fear for their personal safety due to mob action.

At various times during the demonstration on August 28, we had to refuse entry by the public to our Van Buren Street Station due to the fact many of the demonstrators were trying to use this station as a shelter to evade authorities. During these periods we are sure that some of our regular passengers were prohibited from use of our facilities.

On Thursday, August 29, at approximately 5:30 p.m. we received a call from our Weldon Yard Tower Operator indicating several demonstrators on the Air Line at 16th Street and Clark had stopped a SOO Line engine proceeding west. Representatives were dispatched and with the aid of National Guard and City Police, we evicted the trespassers. However, at this time, I am unable to determine the exact delay to this engine.

From this date through August 30, we took necessary precautions to protect our property, passengers and employees from any injury or damage as a result of these demonstrations. This was accomplished by 12-hour shifts and the additional personnel.

To my knowledge, we have received no reports of any serious incidents after those indicated above.

[REDACTED] observed the disturbances and activities of demonstrations at the Democratic National Convention in Chicago, Illinois, held in August, 1968, provided information on September 6, 1968 that on or about 2:00 PM, Monday, August 26, 1968, a public meeting was being held at Lincoln Park, Chicago and that a loud speaker announced that groups would be formed near the various leaders. Hoffman's name was mentioned as a leader. The general comments over the loud speaker system were encouraging the young people to "... show Chicago for what it is-- disrupt the system--force the pigs to react".

[REDACTED] that everyone was asked to do his part in the various demonstrations, whatever his part might be, and that the crowd of about 1,000 was told mainly to simply add numbers to the different demonstrations. [REDACTED] that the crowd was told over and over again not to be violent and that most of the crowd cheered this comment, however, some of the crowd laughed at it.

[REDACTED] that on Tuesday morning, August 27, 1968, a press conference was held at the housing office of the National Mobilization Office on Clark Street, Chicago, Illinois, and that during the press conference, Hoffman told newspapermen that he had been "making love" to his wife in Lincoln Park the night before when the Chicago police began their "attack".

[REDACTED] He stated there were no specific statements on the part of Hoffman that he could recall or elaborate. [REDACTED] He assumed Hoffman was a leader because Hoffman was introduced and the loud speaker system was made available to him and there were reports from unknown individuals that Hoffman was in fact one of the leaders.
