The LAPD can refer the homeless individuals to our Union Rescue Mission clinic on Skid Row for emergency care. If the individuals are seeking comprehensive care, the clinic would need a referral letter from their case workers. Union Rescue Mission also has a medical clinic run by UCLA that they can obtain the medical referral form, if they don't have their own provider.
