this is Officer Biondo from LAPD, Southwest Area. We spoke some time ago regarding the 110 FWY /39th Street bridge and the homeless. It seems a new encampment has developed just south of the original one we spoke about. This one is inside the fence

I was approached today by members of the Figueroa Business Improvement District, (BID) regarding the encampment. It seems they have been attempting to contact someone from CHP to assist, but have so far been unable to get the necessary assistance. It seems that yesterday, 3/22/16, there was a fight amongst members of this encampment that turned pretty violent. Individuals who responded were not able to enter the location due to the fencing and barrier. As this falls within Cal Tran's sphere of influence, any assistance you can provide with abating this issue would be appreciated.
