Happy Friday! This week, the FIG BID team outreached a total of 16 hours and covered 3 hours reviewing and completing paperwork. The team covered 4 hours in the field Tuesday, a full 8 hours in the field Thursday, and 4 field hours today, May 27th, 2016. The team outreached additional hours this week in order to accommodate their future absence on Thursday, June 2nd, 2016 and Tuesday, June 7th, 2016 due to a mandatory PATH meetings and trainings. Below is our weekly summary, please review.

- **This week we worked with approximately 16 people**
 - o Of these, 2 were new contacts
- **39th Underpass continues to have the most contacts**
- **5 currently have potential housing referral options:**
 - o Of these, 0 will need pet-friendly options
- **Approximately 7 people may have been identified as the most vulnerable clients**
- **Special notes and request**
 - Followed up with [REDACTED] and provided them with more hygiene kits and clothing
 - Assisted [REDACTED] to search for apartments and provided some more housing listings

- Team completed a CES with a new client and enrolled them in the outreach program - a request from the FIG ambassadors
- Completed additional requested information on HACLA application for [REDACTED]
- Referred a family to LA Family Housing
- Provided a housing opportunity for an upcoming tax credit building to 10 people who meet the criteria
