I hope you are happy & healthy! Thank you again for all of your assistance with the NoHo ArtWalk (=

I just got of the phone with Karen from the Special Events office and I'm trying to find out if there is a way to pull a Special Events permit on the 3rd Thursday of every month that will allow Visual Artists to sell their art in the NoHo Pedestrian Plaza if we have a Special Events Sales & Use Permit for the entire area of Weddington to Magnolia?

Aaron said to ask Karen, but Karen said to ask you... so, here I am!

Can you help answer this question?

The problem is that the contract that Aaron has states that the NoHo Pedestrian Plaza can NOT have any type of commercial use, so currently I tell all of the Visual Artists that they are NOT allowed to sell their art during the NoHo ArtWalk. But if we pull the Special Events permit, the artists are allowed to sell on the sidewalks... which is fine, but I'd like to see if we can get approved for commercial use of the NoHo Plaza during the NoHo ArtWalk on 3rd Thursdays.
