SAN FRANCISCO INDICES CONTAIN ONLY A NEWSPAPER CLIPPING, DATED 4/3/72, WHICH DESCRIBES THE AMYS AS A GROUP WHOSE MEMBERS ATTEMPT, THROUGH SELF DISCIPLINE AND MEDITATION, TO FIND ECSTASY AND INNER PEACE. SOCIETY IS ALLEGED TO HAVE EIGHTY BRANCHES IN THE UNITED STATES, AND IN SAN FRANCISCO MAINTAINS LARGE HOUSE AT 27160 MOODY ROAD. NEWSPAPER ARTICLE DESCRIBES GROUP AS DEDICATED TO TEACHING SENSITIVITY EXERCISES AND YOGA.

ADMINISTRATIVE:

US SECRET SERVICE, POLICE DEPARTMENT INTELLIGENCE UNIT AT SAN FRANCISCO, HAVE BEEN ALERTED.

PROTEST WILL BE COVERED BY SPECIAL AGENTS WHO WILL BE ALERT FOR POSSIBLE VIOLATIONS OF ACT FOR PROTECTION OF FOREIGN OFFICIALS AND RECORDING AND PHOTOGRAPHIC EQUIPMENT WILL BE AVAILABLE.

SAN FRANCISCO WILL FOLLOW AND ADVISE OF OUTCOME.
