The AM was founded in 1955 by Prabhat Rainjan Sarkar, alias "Baba", and advocates the overthrow of the Government of Indian and takeover by a group called "Sadvippas," an elite section of AM. The group reportedly has indicated that such overthrow would be accomplished by bloody revolution.

In the past, the primary objective of the terrorist activity conducted by members of AM was to gain the release of their leader who was imprisoned on charges that he ordered the murders of several "defectors" from AM. However, prior to and after the release of the leader in 1978, AM has committed several acts of violence which appear to be concerned with Indian domestic issues.

The AM was founded in 1955 by Prabhat Rainjan Sarkar, alias "Baba", and advocates the overthrow of the Government of India and takeover by a group called "Sadvippas," an elite section of AM. The group reportedly has indicated that such overthrow would be accomplished by bloody revolution.

In the past, the primary objective of the terrorist activity conducted by members of AM was to gain the release of their leader who was imprisoned on charges that he ordered the murders of several "defectors" from AM. However, prior to and after the release of the leader in 1978, AM has committed several acts of violence which appear to be concerned with Indian domestic issues.

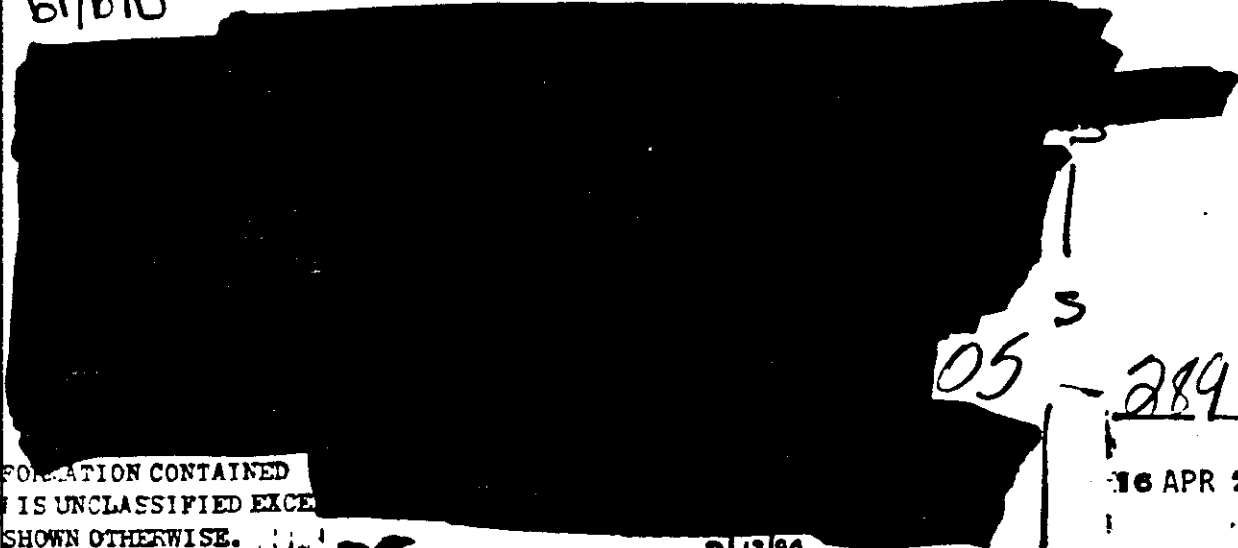
