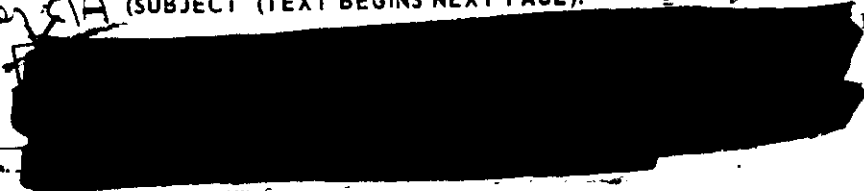

On November 28, 1977, Silla Koteswar, Assistant
Director for Supply, Indian Embassy, 2536 Massachusetts
Avenue, N. W., Washington, D. C., was stabbed by an unknown
assailant outside the Embassy Annex. On December 1, 1977, the
Indian Embassy, Washington, D. C., received a letter from a
group identifying itself as the Universal Proutist Revolutionary
Federation (UPRF) claiming credit for this attack and demanding
the immediate and unconditional release of political prisoner
P. R. Sarkar. P. R. Sarkar is the founder of Anand Marg (AM)
and is currently incarcerated in India for conspiring in the
murders of several former followers, who defected from AM.
AM is headquartered in the United States, in Denver, Colorado.
Following the stabbing of Mr. Koteswar, AM leaders in Denver,
Colorado; Washington, D. C.; and elsewhere in the United States
initiated contact with the Federal Bureau of Investigation,
disclaiming any connection with the UPRF or any knowledge or
responsibility regarding the stabbing of Mr. Koteswar or any
other acts of terrorism directed at Indian establishments and
personnel within the United States or elsewhere. Additionally,
AM leaders in Denver and other United States cities offered to
be of assistance to this Bureau in developing information
regarding the UPRF attacks.

Therefore, it would appear that the AM proposes to tackle the challenge to its credibility on the part of the UPRF by cooperating with this Bureau and other law enforcement agencies in solving these UPRF-claimed attacks. It would appear that by continually denying any association with the UPRF and by publicly condemning the UPRF, the AM hopes to maintain its credibility.

A separate domestic security or foreign counterintelligence investigation has not been instituted regarding AM or the UPRF. Therefore, this Bureau is not in a position or in possession of information to respond to Paragraphs 2, 3, and 4.

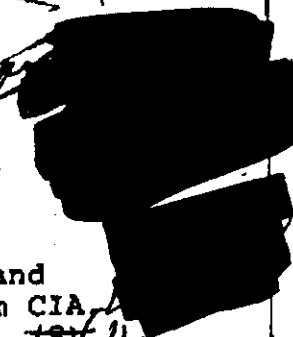

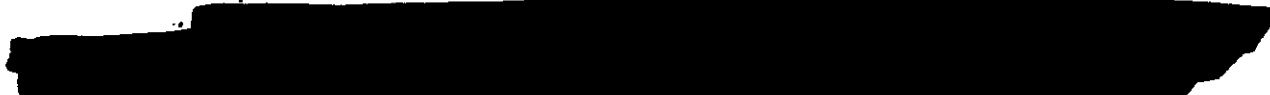

"Mr. Sarkar was charged with murder and kidnapping in seven cases, in two of which he was acquitted last month by the Patna high court. Today, another court granted him bail pending judgement in the remaining cases".

"The secretary of the sect, A.S. Awadhoot, who is also involved in the charges, was released today with Mr. Sarkar. Four other members who were charged have been acquitted."

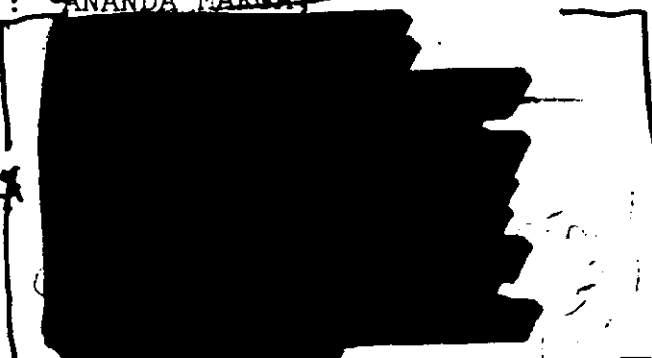
