Enclosed for Los Angeles is one copy each of San Francisco LHM captioned "DEMONSTRATION SPONSORED BY ANANDA MARGA YOGA SOCIETY AT CONSULATE GENERAL OF INDIA, 215 Market Street, San Francisco, California," and WFO LHM captioned "ANANDA MARGA YOGA SOCIETY," both dated 3/29/73.

The above described LHMs are being enclosed for Los Angeles to provide background information regarding captioned group.

Investigation regarding captioned organization in the past has failed to develop any information indicating the group or any of its members advocated violence. Investigation to date has been conducted under the caption "Demonstration Sponsored by Ananda Marga Yoga Society at Consulate General of India, 215 Market Street, San Francisco, California, IS - INDIA."

In view of the allegation presented in referenced Los Angeles LHM indicating that the Ananda Marga Yoga Society (AMYS) may engage in violent activities, San Francisco is initiating captioned investigation.

FBIHQ does not believe that a sufficient basis has been established to conduct investigation of captioned organization and San Francisco should therefore close its investigation of Ananda Marga at this time.

For the information of San Francisco, Ananda Marga Yoga Society has been self-described as a group whose members attempt, through self-discipline and meditation, to find ecstasy and inner peace. While there have been conflicting reports as to the exact nature of captioned organization abroad, some describing it as a legitimate religious organization and others as being involved in terrorist activities, this group is not known to have ever engaged in any illegal type activity within the United States.

The fact that [REDACTED] has been alleged to advocate violence is not a sufficient basis for opening an investigation of captioned organization. If San Francisco during its investigation [REDACTED] develops information which warrants reconsideration concerning investigation of captioned organization, this information should be furnished to FBIHQ.

BY THE INDIAN GOVERNMENT IN ONE NINE SEVEN ONE. ANANDAMURTI WAS ARRESTED BY THE INDIAN GOVERNMENT FOR THE MURDER OF SIX PEOPLE.

THESE DEMONSTRATIONS WERE CONDUCTED IN A LAW ABIDING AND PEACEFUL MANNER; HOWEVER, A DEMONSTRATION AT THE INDIAN EMBASSY ON APRIL TWO THREE, ONE NINE SEVEN THREE, RESULTED IN THE ARREST OF TWO DEMONSTRATORS BY THE EXECUTIVE PROTECTIVE SERVICE FOR THE "DEPOSITING OF TRASH IN A PUBLIC PLACE." THE DEMONSTRATORS WERE ATTEMPTING TO DELIVER TO THE INDIAN AMBASSADOR THE ASHES OF A MONK WHO HAD IMMOLATED HIMSELF. IN THE PROCESS, THE CONTAINER OF ASHES WAS DROPPED AND BROKE ON THE EMBASSY STEPS.

IN ONE NINE SEVEN THREE, THE SOCIETY PUBLISHED A MONTHLY MAGAZINE ENTITLED "SADVIPRA." IT IS NOT KNOWN IF THIS MAGAZINE IS STILL BEING PUBLISHED.

BUREAU FILES CONTAIN NO IDENTIFIABLE INFORMATION CONCERNING THE TWO AMERICAN CITIZENS YOU ADVISE ARE ACTIVE LEADERS OF THE ABOVE CAPTIONED ORGANIZATION.







"Struggle is the essence of life. Yours should be a pauseless struggle against corruption, hypocrisy, and animality," wrote Shrii Shrii Anandamurti to his disciples on New Year's Day, 1960.

Then his words seemed only inspirational rhetoric. Now Anandamurti and his disciples are fighting for their lives. In 1960, Ananda Marga, the organization founded by Anandamurti, was barely five years old and just beginning to exert its moral and spiritual influence on Indian society. Today it is bearing the full force of Indra Gandhi's repressive attack on civil liberties and dissent. Anandamurti himself has been imprisoned for over four years; for the past three years he has been on a liquid fast in protest against the mistreatment he has undergone in jail, including an attempted poisoning.

Ananda Marga formed

Eight years after India's independence, in 1955, Anandamurti (then known by his given name, Prabhat Rainjan Sarkar) gathered together several of his personal disciples and formed an organization to propagate Ananda Marga (the Path of Bliss), a synthesis of traditional Tantric and yogic practices with a carefully planned program of service and social reform. By the early 1960s the organization was large enough to support full-time workers, and it formed an order of renunciates, who spread all over India, initiating others and founding schools, children's homes, and relief teams. The motto of the Margiis (as the members of Ananda Marga came to be called) was "Liberation for the Self and Service to the World."

The goal of Ananda Marga's service work was not simply to fill minds and bellies and to bandage wounds but to engender a dynamic, spiritual society. It gave out inspiration and hope along with bread and milk—"You are the child of a great Father, the whole universe is your home, you have every right to use it to the fullest." It raised expectations and offered a means for realizing them.

Dealing with poverty

The effectiveness of ERAWS (the Education, Relief, and Welfare Section of Ananda Marga) in dealing with the problems of poverty and disaster greatly accelerated the growth of Ananda Marga and gave it a base among the common people. In one village that had been struck by an earthquake, the Ananda Marga workers were on the scene almost before the tremors had stopped a well before other agencies had a clear idea of what had happened. The villagers were impressed by the promptness and efficiency of the relief that they joined Ananda Marga en masse.

In another village, the Margiis performed a different kind of service. A band of thugs who styled themselves as communists were extorting protection money from shopkeepers in the local market. Members of Ananda Marga visited all the shopkeepers and persuaded them to resist the extortion. The next time the "communists" came to collect, the people refused to pay. Returning that night to destroy the shops, the thugs found the market well defended by the organized shopkeepers. They were forced to end their harassment.

In just eight years (1963-71), ERAWS founded 250 primary and secondary schools. At the height of its popularity, Ananda Marga had two million members, many of them intellectuals and government officials dissatisfied with India's slow growth and pervasive corruption. The Congress Party paper, Current, reported that half the police

superintendents in Bihar State were members of Ananda Marga, a situation that disturbed the central government, since Ananda Marga is becoming much more specific in its criticisms of the government and the social structure.

Position begins

In 1969 the government tried, unsuccessfully, to ban all government employees from membership in Ananda Marga, which, it was claimed, was itself a political organization. Where its opponents were taking more direct action, Ananda Nagar, the Ananda Marga headquarters, located on a large tract of land in rural West Bengal, had a children's home, primary school, liberal arts and technical colleges, a lepers' home, and a medical clinic, as well as an ashram and printing press. These programs gave it a strong local influence, and local officials sought its support for their own careers. Rebuffed, they began a campaign of public denunciation and harassment of Ananda Marga, stirring up the villagers and tribesmen with tales of landgrabbing and sacrilegious acts by the Margis. They succeeded in gathering a mob which attacked Ananda Nagar and killed five unarmed workers on March 5, 1967, while the police stood by. After several years of legal wrangling, nine of these local officials were convicted and given sentences ranging from three years to life imprisonment, while none of the sixty-five charges brought against the Margis held up in court. In July, 1975, Ananda Nagar was ransacked, and all the workers and students either fled or were arrested.

Anandamurti arrested

Despite his quiet demeanor, there was no denying the powerful effect Anandamurti had on other people, and in 1971 Ananda Marga's enemies singled him out for attack. This group of enemies was not composed solely of corrupt officials and wary politicians. Conservative

Hindus reacted against Anandamurti's program to abolish the caste system, prosperous businessmen and landowners felt threatened by his socialistic ideals, and, most importantly, communists found his organization eroding their base among the poor and among disaffected intellectuals. The Communist Party of India (CPI), the pro-Soviet bloc) was an important factor in Mrs. Gandhi's rising power, and it was not averse to contributing its power to the effort to suppress Ananda Marga. Anandamurti has accused the Soviet KGB of organizing much of the anti-Ananda Marga activity; recently, the Soviet press carried articles denouncing Ananda Marga and calling for its abolition not only in India, but throughout the world.

Serious harassment of Anandamurti began in June 1971. After he had moved the Ananda Marga headquarters from Ranchi to Patna, the vacated headquarters building in Ranchi was searched by the police and nothing was found. Shortly after, the still vacated building was searched again and a large cache of guns and explosives was allegedly found. Anandamurti was arrested in Patna and released on bail six weeks later.

Also arrested in the Ranchi incident was a monk known as Madhavananda, who sometime later confessed to having murdered a number of disaffected workers of Ananda Marga. Madhavananda received a government pardon for implicating Anandamurti as the head of this murder conspiracy. In December, 1971, Anandamurti was arrested on these charges.

From the beginning, Anandamurti and his co-defendants have maintained that the charges are fabricated and the case itself is politically motivated. The judge who originally committed the case to trial did so with major reservations, citing "defects" on "every material point" of Madhavananda's testimony and the lack of corroboration. Meanwhile Mrs. Gandhi, at total variance with the committing court's findings, made a prejudicial statement to a Canadian Member of Parliament declaring that there was "overwhelming suspicion" of Anandamurti's guilt.

The Canadian's inquiry was written during a flurry of protest which followed the alleged poisoning of Anandamurti by the prison doctor in February, 1973. Despite massive protests at home and official inquiries from abroad, the government refused to investigate the incident. Anandamurti therefore started a protest fast on April 1, 1973.

He was still fasting in June, 1975, when Mrs. Gandhi declared a "state of emergency" throughout India, claiming that internal and external forces were preparing to topple her government. The real reason, however, was obvious. Mrs. Gandhi's ruling Congress Party, despite her most determined campaigning efforts, had suffered a defeat in Gujarat, India's westernmost state. This was seen as a barometer for the national elections to be held in the spring of 1976. News of the Gujarat defeat was followed immediately by another blow—on June 12, the High Court at Allahabad found Mrs. Gandhi guilty on two counts of electoral corruption, stemming from her election to the lower house of Parliament in 1971.

The Allahabad decision, if upheld by the Supreme Court, would have cost Mrs. Gandhi her Prime Ministership. Before the Supreme Court had a chance to decide, Mrs. Gandhi lashed out against her critics. She ordered massive arrests of her opponents and clamped a censorship on the press that was harsher than any imposed during India's wars. Meanwhile, Mrs. Gandhi assumed essentially dictatorial powers. A week later she banned twenty-six organizations, including Ananda Marga.

Under this ban, all members of Ananda Marga are subject to arrest and indefinite detention without formal charges, with the probability of torture and the invitation to admit to, or implicate others in, various political crimes. Several Margis have recently been charged with the 1974 bombing that killed railway minister L. N. Mishra. Once again, despite the strong evidence to the contrary, Mrs. Gandhi has personally proclaimed the Margis guilty before the trial has even begun.

All Ananda Marga activities and meetings are forbidden, and all properties have been confiscated. According to Indian sources, 50 percent of Ananda Marga's monks and nuns have been arrested, along with nearly 50 percent of the lay members. Those full-time workers who escaped arrest have forsaken their orange robes, cut their hair and beards, and tried to return to civilian life in order to avoid detection. They face a whole new life in a country plagued by chronic unemployment and critically scarce commodities.

According to the Washington Post of March 5, 1976, there are still over 100,000 victims of Mrs. Gandhi's summer crackdown in the Indian jails. Officials of Amnesty International and other groups closely following the prisoner situation say that number may be as high as 200,000. The censorship on the press has tightened, and the national elections scheduled for early 1976 have been postponed for a year. Anandamurti, one of the first to be singled out and attacked by the current administration, is entering the fourth year of his protest fast. He faces a possible death sentence if convicted. Ananda Marga members throughout the world are attempting to focus international attention on this situation in the hope that the trial may be brought to a just conclusion.

It was founded in India by Prabhat Rainjan Sarkar, who is imprisoned in India for conspiring in the murder of some former followers who defected from AM. Recently, there have been several attacks directed at Indian establishments and citizens within the United States. A group, United Proutist Revolutionary Federation (UPRF), which alleges to be a front organization for AM, has claimed responsibility for these attacks. The FBI does not have a separate FCI investigation on AM or UPRF, but we do have two PFO investigations as a result of UPRF attacks.

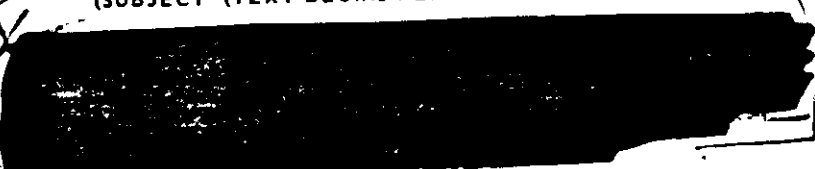

Initial investigation by MPD failed to develop witnesses or suspects.

Mr. Koteswar was transported to the George Washington University Hospital, Washington, D. C., where he underwent immediate surgery. He remains in serious but stable condition following surgery.

Weapons utilized in the attack on Mr. Koteswar were two hunting knives [REDACTED]

Laboratory examinations for blood or any other evidence are continuing. Neighborhood investigation conducted by WFO with negative results.

To date, no individual or organization has claimed credit for this assault, but it is the opinion of [REDACTED] that this incident was an act of political terrorism perpetrated by the Ananda Marga (AM) or its front organization, the Universal Proutist Revolutionary Federation (UPRF). The AM is basically a religious organization concerned with social services and peaceful social reform. It was founded in India by Prabhat Ranjan Sarkar, who is imprisoned in India for conspiring in the murders of several former followers who defected from AM.

On 11/29/77, WFO interviewed [REDACTED] member of the AM acting in a public relations capacity, and [REDACTED] denied that AM is involved in terrorist activities and advised the UPRF is a separate organization from AM, but is connected by a common founder, Sarkar, and by the fact they have a somewhat overlapping membership.

perpetrated around the world and more specifically, in the United States, by a group calling themselves the UPRF, the AM has been somehow linked with the UPRF and accused of these violent actions. [REDACTED] the AM organization denies any connection with these violent acts and indicated that condemnations of the acts have been made publicly at all levels of the organization and that AM Headquarters, Denver, Colorado, has contacted the Denver FBI regarding this. [REDACTED] advised AM has been in contact with USDS, U. S. Secret Service and the Indian Government regarding AM's concern in this matter. He offered his and his organization's fullest cooperation to ensure that the individual or individuals responsible for the acts of violence claimed by the UPRF are identified and punished.
