A preliminary inquiry was instituted on May 12, 1978, to determine if the Anand Marg (AM), also known as Ananda Marga, Ananda Marga Yogi Society (AMYS), Universal Proutist Revolutionary Federation (UPRF), is engaged in terrorist activities pursuant to the direction of a foreign power.

Investigation to date by the Federal Bureau of Investigation (FBI) has not determined that AM has been involved in terrorist acts pursuant to the Attorney General Guidelines.

AM members have furnished the following information concerning the AM:

AM was founded in India in 1955 by Prabhat Rainjam Sarkar as a peaceful, religious, social service organization. Its goals are meditation and social programs. It is a volunteer organization which teaches meditation and performs community service functions. Its purposes are personal development through meditation and social services, involving pre-schools for children, halfway houses, food for the needy and disaster action teams. AM is a sociospiritual organization, whose objective is to relieve human suffering and promote the teachings of Sarkar.

AM has been described as an international sociopolitical movement propagating spiritual philosophy and practices based on ancient Indian meditation and Yoga techniques.



Proutist Universal is the social philosophy of Sarkar. Some AM people espouse the proutist philosophy, but generally the membership does not.


The Universal Proutist Revolutionary Roundation (UPRF), founded by Sarkar, is a political organization based on spiritual values. It is totally separate from the AM, which is not connected with any other organization throughout the world.



In December, 1971, Sankar was arrested harges of Conspiracy to Commit Minder. In July, 1975, the Indian hove the Congress Party in 1977. The AM is now legally operating.



The following acts were committed or claimed by the AM, its cover or splinter groups, or members in the United States:



#### ANAND MARG

- 1, On October 20, 1977, a brick and fire bomb were thrown through the window of the Air India office at 400 Park Avenue, New York, New York.
- 2. On November 11, 1977, an employee of the Air India office in Los Angeles, California, was assaulted with a knife by an unidentified female.
- 3. On November 25, 1977, Silla Koteswar, Attache, Embassy of India, Washington, D. C., was stabbed.



AM officials in the United States have denied that the acts of terrorism have been done under the direction of AM. Some individuals participating in violence allegedly have been expelled from AM.

AM discussions concerning these terrorist activities attribute these activities to a small tight-knit group acting on its own or acts by agents of the Indian Government to ruin the reputation of AM.


In the fall of 1977, AM members at Los Angeles, California, denied that any members participated in any

acts of violence and advised that to do so would be contrary to the teachings and principles of AM. The AM would never condone violence to achieve the release of Sarkar.



advised that Didí Uma committed suicide by self-immolation in February, 1978, at Berlin, Germany.

AM is an international organization founded in India. There are headquarters offices in various countries. The U. S. headquarters is located at 854 Pearl Street, Denver, Colorado. Within the U. S. are various regional offices and approximately 80 units or chapters, called Ashrams, in major cities in all 50 states as well as about 45 other countries.

The majority of AM members in the U.S. are full or part-time workers, headed by chapter leaders. Next in the hierarchy are the acharyas, the nuns and monks, who in turn are led by the auadhoots. They are under Sarkar,

who is the supreme guru or teacher, who dlaims total "enlightenment" or knowledge of the truths.

The appeal of AM is that people in it live by example. The leader in the U.S. is Dadaiji Yatiishvarananda, Denver, Colorado. There are perhaps six or seven full-time teachers in the U.S.

In November, 1977, the AM National Public Relations Representative (NPRR), Denver, estimated that around 5,000 individuals are considered active in the U. S. AM membership in the U. S. is estimated at about 500 to 1,000. The present NPRR, Craig, Runde, Denver, has directed that any proper questions for the AM should be written and sent by letter to his office at 854 Pearl Street, Denver, Colorado, 80203.

AM nationally publishes a monthly newspaper, "Crimson Dawn," containing articles dealing with AM meditation, inspiration and AM projects.

Local units collect money from members according to what the members, who support themselves, think they can afford, sending surplus funds to the regional office, which remits its supplies to national headquarters. A great deal of the money has been sent to India in connection with the Sarkar defense efforts and other amounts are sent to various countries for disaster relief, administered by the AM relief team.

In Denver, Colorado, a small business produces shampoo and health care products, providing some income to the AM national office.

AM receives most of its funds by voluntary contributions through its membership. It does receive some Federal monies in the form of CETA grants for its permanent projects. Donations are proportioned with certain percentages forwarded to sector offices. AM receives no funds from any Indian sources.









It is noted that numerous American-type names and known American citizens have been involved in terrorism activities in countries other than the United States.

This file has been designated for routine destruction under provisions established by the Bureau.

A review of captioned matter reflects that members and prior members of captioned organization have committed numerous terrorist type acts, including bombings, stabbings, and kidnappings in the U.S. and abroad in an attempt to force the Indian government to release Ananda Marga (AM) leader P.R. SARKAR. The "Washington Post" reflects on 8/4/78 that P.R. SARKAR had been freed from jail in India on bail after more than six years of imprisonment.

In view of the violent nature of acts of terrorism which have been attributed to followers of P.R. SARKAR, and the possibility that these violent acts could recur in the future should SAPKAR be reconvicted in India, it is recommended that this file be retained ten years at WFO.



The Anand Marg, founded in India by Prabhat Rainjan Sarkar, is self-described as a religious, social organization whose goal is peaceful, social reform. Sarkar, who is known to his devotees as Anadmurti (Bliss Incarnate) and Baba (father), was imprisoned in India after being found guilty of conspiring in the murders of six former followers who had defected from Anand Marg. The Anand Marg and its splinter groups, i.e., Universal Proutist Revolutionary Federation, etc., have committed numerous acts of terrorism throughout the world demanding the release of their leader Sarkar, and social revolution in India.

The Anand Marg was founded in 1955 by Prabhat Rainjan Sarkar, alias "Baba" or Ananda Murthiji, and advocates the overthrow of the Indian government and a takeover by a group called "Sadvippas," an elite section of Anand Marg. The group reportedly had indicated that such overthrow would be accomplished by bloody revolution. Sarkar has been imprisoned since 1971 on charges he ordered the murder of several defectors from the Anand Marg. He has since been released in 1978 on bond pending an appeal before the Indian Court.

Ananda Marg established itself in the United States in 1971 when Acharya Yatishwarananda Avadhoot, alias R. Venkatanarayan, was sent to propagate the group's philosophy. The headquarters were established in Wichita, Kansas, under the name of the Ananda Marga Yoga Society of USA. In 1973 the Society bought its own three-story building at 854 Pearl Street, Denver, Colorado, and moved its headquarters there.

The Ananda Marga Yoga Society is self-described as a group whose members attempt, through self-discipline, and meditation, to find ecstasy and inner peace.

In 1975 the Society claimed to have 80 branches in the U.S. In 1972 and 1973, it engaged in demonstrations in Washington, D.C., and San Francisco, California, protesting the jailing of its spiritual leader, Shrii Shrii Anandamurti (Sarkar). These demonstrations were peaceful; however, a demonstration at the Indian Embassy on April 23, 1973, resulted in the arrest of two Society members. They were charged with "Depositing of Trash in a Public Place" after they attempted to deliver to the Indian Ambassador the ashes of a monk who had immolated himself. In the process, the container of ashes was dropped and broke on the Embassy steps.

In late 1976, Sarkar claimed to have eight million followers in India, Great Britain, the United States, Canada, The Philippines, and Australia.

#### Activity in the United States

On October 20, 1977, a brick and fire bomb were thrown through the window of the Air India office at 400 Park Avenue, New York, New York.
