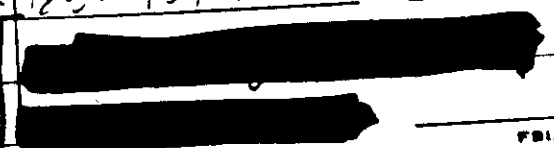

In response to your teletype request dated August 24, 1979, for information concerning six individuals, you are advised our files reveal no information identifiable with the following individuals and their aliases:



Regarding the captioned individual, our files reveal Sarkar, born April 1, 1923, in Bihar, India, is the spiritual leader and founder of Ananda Marga (AM), which was founded in India in 1955, and is self-described as a religious, social organization whose goal is peaceful, social reform. Sarkar, who is known to his devotees as Anadmurti (Bliss Incarnate) and Baba (father), was imprisoned in India during 1971 after being found guilty of conspiring in the murders of six former followers who had defected from the AM. The AM and its splinter groups have committed numerous acts of terrorism throughout the world demanding the release of their leader Sarkar, and social revolution of India.

On an appeal in 1978, Sarkar was acquitted in India of one homicide charge and as of March, 1979, one homicide charge was still pending against him and he remains on bail. There is attached one copy of an FBI memorandum dated January 3, 1977, which contains information concerning Sarkar (105-289420)

Our files contain no additional pertinent information concerning him.



In response to your letter dated November 16, 1979,  
from [redacted] requesting information  
concerning the above captioned organization and individual, a  
review of our central files reveal the following information.

The organization, Ananda Marga (AM), also known as  
Anand Marg and Ananda Marga Yogi Society, was founded in India  
in 1955 and is self-described as a religious social organization  
whose goal is peaceful, social reform. AM is also described as  
an international socio-political movement propagating spiritual  
philosophy and practices based on ancient Indian meditation and  
yoga techniques. The AM and its splinter groups have committed  
numerous acts of terrorism throughout the world demanding the  
release of their leader, Prabhat Rainjan Sarkar, and a social  
revolution in India.

Regarding the captioned individual, our files reveal  
Sarkar, born April 1, 1923, in Bihar, India, is the spiritual  
leader and founder of the AM. Sarkar, who is known to his  
devotees as Anamurti (Bliss Incarnate) and Baba (father), was  
imprisoned in India during 1971 after being found guilty of  
conspiring in the murders of six former followers who had  
defected from the AM.

On an appeal in 1978, Sarkar was acquitted in India  
of one homicide charge and as of March, 1979, one homicide  
charge was still pending against him and he remained on bail. There  
is attached one copy of an FBI memorandum dated January 3, 1977,  
which contains information concerning Sarkar. (105-289420)
