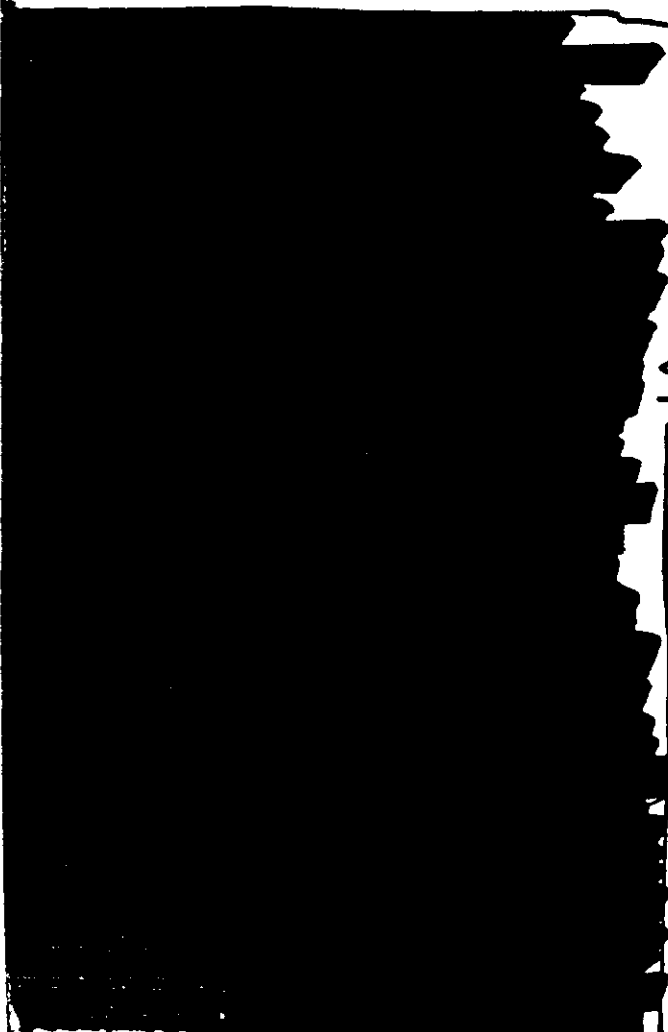

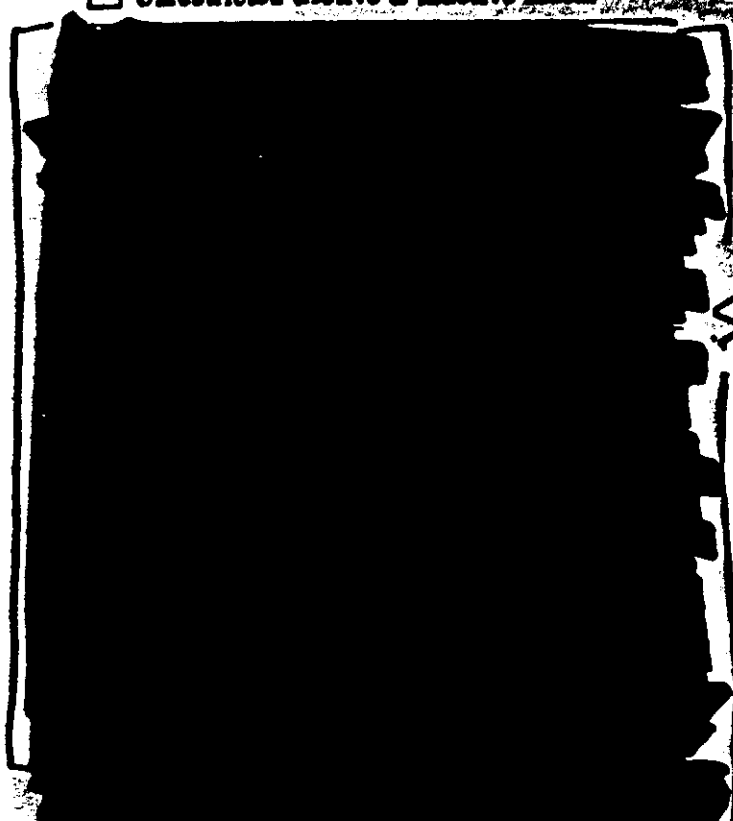

Dear Senator Denton:

I have received your March 19th inquiry concerning the Ananda Marga Yoga Society and appreciate the opportunity to give you a brief background of this organization for your personal information and for possible assistance in addressing the inquiry you received in this regard from [REDACTED]

The organization, Ananda Marga (AM), also known as Anand Marga and Ananda Marga Yoga Society, was founded in India in 1955 and is self-described as a religious, social organization whose goal is peaceful, social reform. It is also described as an international socio-political movement propogating spiritual philosophy and practices based on ancient Indian meditation and yoga techniques. The AM and its splinter groups have committed numerous acts of terrorism throughout the world demanding the release of their imprisoned leader and advocating social revolution in India. AM established itself in the United States in 1971.

The FBI has conducted inquiries relating to AM on a foreign police cooperation basis or under the Protection of Foreign Officials Statute when requested to do so or when deemed necessary. We have not, however, received any information to date that AM has engaged in terrorist activity in the United States pursuant to the direction of a foreign power. Under the Attorney General Guidelines for Foreign Intelligence Collection and Foreign Counterintelligence Investigations, such foreign direction is necessary for the FBI to conduct an investigation.
