ON MAY 28, 1976, AN OFFICIAL OF THE FEDERAL POLICE OF ARGENTINA

(FPA) PROVIDED THE FOLLOWING INFORMATION: (S) (U)

ON OR ABOUT MAY 19, 1976, THE FPA DETAINED AN INDIVIDUAL, WHO WAS IDENTIFIED AS A FEDAYEEN TERRORIST IN JOSE PAZ, BUENOS AIRES PROVINCE. UNDER INTERROGATION THIS INDIVIDUAL ADMITTED HE HAD ILLEGALLY ENTERED ARGENTINA ALONG WITH A NUMBER OF OTHER FEDAYEEN TERRORISTS IN ORDER TO COLLABORATE WITH THE MONTOMERCS, AN ARGENTINE GUERRILLA ORGANIZATION, IN PLANNING ASSASSINATIONS OF THE UNITED STATES AND OTHER FOREIGN OFFICIALS OF VARIOUS PETROLEUM COMPANIES. IT IS ANTICIPATED THAT THE UNITED STATES AND OTHER FOREIGN-OWNED PETROLEUM COMPANIES WILL INCREASE THEIR PERSONNEL IN ARGENTINA IN CONNECTION WITH PROTECTED ARGENTINE GOVERNMENT CONTRACT TO THESE FOREIGN COMPANIES FOR PETROLEUM EXPLORATION AND OTHER TECHNOLOGICAL ASSISTANCE IN THE PETROLEUM FIELD.
