FOR INFORMATION, THE ARGENTINE NAVAL INTELLIGENCE SERVICE ADVISED THAT INFORMATION TAKEN IN A RAID AGAINST THE MONTONERO GUERRILLA ORGANIZATION APPROXIMATELY SIX WEEKS AGO IN BUENOS AIRES UNCOVERED INFORMATION THAT THE MONTONEROS WERE CONDUCTING A CASING OPERATION AGAINST LT. COL. ARTHUR F. ELIASON, WHO WAS ^{U.S. MARINE CORPS} ~~IS~~ ASSIGNED TO THE U. S. MILITARY GROUP IN ARGENTINA. ACCORDING TO INFORMATION PROVIDED BY THE ARGENTINE NAVAL INTELLIGENCE SERVICE, THE MONTONEROS APPARENTLY SELECTED COL, ELIASON FOR EITHER A KIDNAPPING OR ASSASSINATION OPERATION; HOWEVER, FROM DATA COLLECTED BY THE MONTONEROS, IT APPEARED THAT THE CASING OPERATION WAS NOT BEING PROFESSIONALLY CONDUCTED AND HAD DEVELOPED LITTLE INFORMATION OF VALUE IN ORDER TO CARRY OUT AN ACTUAL OPERATION. ~~(S)~~ (U)
