ON SEPTEMBER 29, 1975 A CONFIDENTIAL SOURCE ABROAD WHO IS
AN OFFICIAL WITH THE FEDERAL POLICE OF ARGENTINA (FPA) PROVIDED
THE FOLLOWING INFORMATION:

DURING THE EARLY MORNING HOURS OF SATURDAY, SEPTEMBER 27, 1975, SEVERAL TERRORIST BOMBS WERE SET OFF IN CORDOBA, ARGENTINA. ONE OF THESE BOMBS WAS DETONATED AT THE VILLA CABRERA BRANCH OF THE FIRST NATIONAL CITY BANK OF NEW YORK. THIS BOMB CAUSED NO PERSONAL INJURIES AND MODERATE MATERIAL DAMAGE.

THE NAVAL ATTACHE ASSIGNED TO THE U. S. EMBASSY, BUENOS
AIRES REPORTED HE WAS INFORMED ON SEPTEMBER 26, 1975 BY A SOURCE
DESCRIBED AS A RETIRED MILITARY OFFICER, WHO HAS PROVIDED
RELIABLE INFORMATION IN THE PAST, THAT ARGENTINE TERRORISTS
ARE PLANNING TO INITIATE A NEW WAVE OF TERRORISM IN ARGENTINE
SOMETIME DURING THE PERIOD SEPTEMBER 26-OCTOBER 6, 1975. NAVAL
ATTACHE REPORTED THAT HIS SOURCE IS UNABLE TO IDENTIFY WHERE
THE ACTIVITY WOULD TAKE PLACE BUT SUGGESTED IT COULD VERY WELL
ORIGINATE IN THE METROPOLITAN BUENOS AIRES AREA. THE NAVAL
ATTACHE REPORTED HIS SOURCE HAD NO INFORMATION INDICATING THAT
U. S. EMBASSY PERSONNEL WOULD BE TARGETS OF TERRORIST ATTACKS
BUT FELT THAT IT WAS A DISTINCT POSSIBILITY.



ARGENTINE TERRORIST ACTIVITIES

On 9/29/75, a source connected with an Argentine Government agency under the jurisdiction of the Ministry of Defense advised that on 9/29/75 a notice was circulated from the Ministry of Defense to all Ministry of Defense entities advising that the Ministry received information originating in Paris, France which indicated that orders had been issued that the Ejercito Revolucionario del Pueblo (People's Revolutionary Army) (ERP) was to initiate a campaign of indiscriminate assassinations of Argentine military and police personnel. (5)

The source noted that the information contained in the circular was non-specific as to the exact origin of the information and the manner in which it had been received by the Argentine Government.
